

Advisory for Parents of Minor/Underage Drivers

Time and again Motor Vehicles Department has advised the parents against allowing their Minor/ Underage children to drive two wheelers/four wheelers. Recently a number of instances where Juveniles are diving two/ four wheelers with impunity particularly in Srinagar & Jammu cities have been reported. This not only puts the lives of these minor children at risk but also poses a threat to the pedestrians as well as to other commuters. This is a serious offence, which can attract punitive action against the offenders under section 199A of the Motor vehicles Act, 1988.

"The guardian or owner shall be punishable with imprisonment for a term which may extend to three years and with a fine of twenty- five thousand rupees. Further in case of any offence under MV act 1988 has been committed by the juvenile, the guardian of such juvenile or the owner of the motor vehicle shall be deemed to be guilty of the contravention and shall be liable to be proceeded against and punished accordingly. In addition, the registration of the motor vehicle used in commission of the offence shall be cancelled... The juvenile shall not be eligible to be granted a driving license under section 9 or a learner's license under section 8 until such juvenile has attained the age of twenty-five years. For the offences under the MV act the juvenile shall be punishable with such fines as provided by the Act while any custodial sentence may be modified as per the provisions of the Juvenile Justice Act, 2000 (56 of 2000)."

Hence again through the medium of this advisory the general public especially the parents/ guardians of the minors are requested to desist from the practice of allowing their minor children to drive two/ four wheelers, as the same is a serious offence and punishable under law
