JAMMU: Uppal Neuro Hospital in Amritsar has "Mission Brain Attack" during the observance of World Stroke Awareness Month. This initiative, spearheaded by Dr. Ashok Uppal, the founder of the hospital, and Dr. Salil Uppal, Treasurer of the Indian Stroke Association, aims to educate the public and local healthcare professionals about the critical aspects of stroke prevention and treat-

The mission follows a nationwide campaign that began in Varanasi, led by ISA President Dr. Nirmal Surva and his team, and marks a dedicated effort to

improve awareness in the Amritsar region.

Dr. Salil Uppal shared alarming statistics highlighting the prevalence of stroke, revealing that one in four individuals is at risk, with an average of three strokes occurring every minute worldwide.

He stressed the importance of recognizing the symptoms of stroke using the "B-FAST" acronym, which stands for Balance (loss of balance), Eyes (blurred vision), Face (facial drooping), Arms (weakness in arms), Speech (slurred speech), and Time (the urgency for immediate medical attention).

The hospital has also emphasized the importance of timely medical care, noting that patients who are treated within the critical four-and-a-halfhour "golden period" significantly reduce their risk of longterm disability.

Dr. Uppal pointed out that TPA injections represent a vital treatment option for stroke patients, while physiotherapy plays an essential role in reha-

In addition to these measures, Dr. Shikhil Uppal, a neurosurgeon at the hospital, highlighted the availability of mechanical thrombectomy for patients arriving within six to eight hours post-stroke, offering advanced treatment options to improve outcomes.

To further enhance patient care, Dr. Ashok Uppal announced the introduction of a pre-stroke care ambulance service. This specialized ambulance will be equipped with medical personnel and state-ofthe-art monitoring facilities, enabling early assessment and treatment of stroke patients even before they arrive at the

### High Court upholds detention of Heroin smuggler

JAMMU: The Jammu and Kashmir and Ladakh High Court, presided over by Justice Rajnesh Oswal, has upheld the detention of Mohd Dilawar, an alleged heroin smuggler, under the Prevention of Illicit Traffic in Narcotic Drugs and Psychotropic Substances (PIT-NDPS) Act.

The decision came after a comprehensive examination of the case details submitted by the authorities.

The court noted that the dossier presented to the respondent was carefully evaluated. leading to the conclusion that Dilawar's continued involvement in narcotic drug trafficking posed a significant threat to public order and the health and welfare of the community. Despite previous proceedings under the Narcotic Drugs and Psychotropic Substances (NDPS) Act, Dilawar reportedly resumed his illicit activities even after being granted bail, demonstrating a clear disregard for the law.

During the execution of the detention order, the relevant documents, including the grounds for detention, were provided to Dilawar in a language he understood-be it English, Urdu, Hindi, or

Dogri. He was also informed of his right to make a representation against the detention order to the Government and the

detaining authority. In his ruling, Justice Oswal addressed the concerns raised by the petitioner regarding the specificity of the allegations against him, which included selling heroin on two specific dates in January 2024. The judge concluded that the grounds of detention were neither vague nor unfounded, reaffirming the validity of the detention order.

Furthermore, the petitioner argued that his case had not been referred to the Advisory Board within the stipulated five-week period. However, the court found that the Advisory Board had indeed reviewed and opined in favor of the detention shortly after the case was referred, effectively dismissing this contention as well.

The court deemed the detention order, identified as PIT-NDPS 06 of 2024 and dated January 22, 2024, as justified and upheld it, stating that there was no merit in the petition filed by Dilawar.

The ruling reinforces the commitment of the judicial system to curtail drug trafficking and protect public health.
