- Whereas, in terms of the Advertisement Notification No. 05 of 2024/RG/GS dated 08.08.2024, online applications were invited or 16 posts of District Judges (Entry Level) in pay Level J-5 (144840-194660), under direct quota.
- Whereas, pursuant to the aforementioned notification, some Prosecutmng Officers submitted their applications and had represented for consideration of their application forms against the aforementioned post of District Judge, which representations were rejected in view of the recommendations made by the Hon'ble Committee for Higher Judicial Service in its meeting held on 10.07.2024, approved by Hon'ble The Chief Justice, in terms of order dated 31.07.2024.
- Whereas, the Prosecuting Officers whose representations were rejected in terms of the order dated 31.07.2024, referred to above, preferred various writ petitions bearing WP(C) Nos. 1596/2024, 1613/2024, 2131/2024 and other connected petitions.
- Whereas, Hon'ble Division Bench of the High Court of Jammu & Kashmir and Ladakh, while considering the aforementioned writ petitions, passed an interim order dated 30.08.2025, the relevant part of which is reproduced as under:

" Having regard to submissions made, the respondents are directed to accept provisionally the application forms of those petitioners who have completed seven years or more from the date of their enrolment as advocate for participation in J&K Higher Judicial Service Examination at their own risk, responsibility and costs and that their participation in the said examination will not create and/or accrue any right in them to seek consideration for appointment against the posts in question."
- Whereas, in the aforesaid perspective, the matter was considered by the competent authority on the recommendation made by the Hon'ble Committee for Higher Judicial Service in the light of the interim order passed by the Hon'ble Division Bench, referred to above, and it has been found that out of fourteen (14) Prosecuting Officers, who had filed their application forms and later after their representations were rejected, approached the Hon'ble High Court of Jammu & Kashmir and Ladakh, through the medium of the aforementioned writ petitions, only five (05) Prosecuting Officers have completed seven years or more as an Advocate from the date of their enrolment.
- Accordingly, in view of the above, the candidature of the following five (05) Prosecuting Officers who have completed seven years or more as an Advocate from the date of their enrolment, shall be considered against the post of District Judge (Entry Level) advertised vide advertisement notification No. 05 of 2024/RG/GS dated 08.08.2024, at their own risk and responsibility in terms of the interim order, referred to above:
