Why Digital Life Certificates for Pensioners ?

- No need to visit Treasury or Bank for submitting life certificate
- DLC generation through Mobile App Installed on your phone
- Instant confirmation & online download



How to Generate Your DLC (Step-by-Step):

- Step 1: Download Aadhaar Face RD (Early Access) App from Google Play Store / App Store.
- Step 2: Install Jeevan Pramaan App from Play Store.
- Step 3: Open Jeevan Pramaan Go to Operator Authentication Enter Aadhaar, Mobile No., Email ID.
- Step 4: Authenticate using OTP.
- Step 5: Enter Name (as per Aadhaar) Proceed for Face Scan.
- Step 6: Go to Pensioner Authentication Enter Aadhaar, Mobile No. Verify with OTP.
- Step 7: Enter Pension Details: Name, Type, PPO No., Account No., etc.
- Step 8: Provide Consent Click Face Scan.
- Step 9: Upon success, DLC Confirmation with Pramaan ID appears.
- Step 10: Download Certificate from <https://jeevanpramaan.gov.in> Pensioner Login Enter Pramaan ID.
