Bovine smuggling bid foiled; 7 bovines rescued, vehicle seized

JAMMU: Continuing its crackdown on bovine smuggling under Operation Kamdhenu, Jammu (Rural) Police foiled a smuggling attempt in the Jhajjar Kotli area.

A naka was established by Jhajjar Kotli Police. During checking at the naka, the police team intercepted a canter vehicle bearing registration number JK02CR-7445. Upon thorough inspection, 07 bovines were found being transported illegally in the said vehicle. All the animals were rescued safely, while the driver of the vehicle, Shakeel Ahmed S/O Ghulam Ahmed R/O Kalyanpur, Jammu, was arrested on the spot.

In this regard, FIR No. 135/2025 U/S 223 BNS & 11 PCA Act stands registered at Police Station Jhajjar Kotli. Further investigation is underway.

Movable property of habitual bovine smuggler attached

UDHAMPUR: Udhampur Police has attached movable property worth Rs 12 lakhs belonging to a habitual bovine smuggler. A Tata Yodha vehicle bearing registration number JK14J-3924 owned by Gulam Qadar S/o Mazam Din R/o Jig Bupp, Tehsil Chenani, District Udhampur, has been attached under Section 107(5) BNSS by the order of the Hon'ble Court of JMJC Rammagar, Udhampur.

The said vehicle was found involved in Case FIR No. 165/2025 U/S 223(a) BNS & 11 PCA Act of Police Station Rammagar. During investigation the IO conducted a detailed inquiry covering multiple aspects. Based on the criminal record and financial investigation of the accused, it was revealed that the offending vehicle had been procured through illegally acquired proceeds of crime generated from bovine smuggling. Accordingly, Udhampur Police attached the said vehicle under Section 107(5) BNSS.

Shopkeeper among 2 arrested; 37 bottles of illicit liquor recovered

DODA: Doda Police have seized a total of 37 bottles of illicit liquor in two separate actions carried out in Doda district, leading to the arrest of two individuals and registration of two FIRs.

A police patrolling team of Police Station Doda, while conducting routine checks in the Nagri Tondwah area, detected illegal liquor activity inside a local chicken shop.

The patrol noticed unidentified individuals consuming liquor inside the shop of Bittu Ram S/O Pyare Lal R/O Bhagwa, District Doda. On seeing the police party, the individuals fled from the spot.

During a search of the premises, the police recovered 13 bottles of JK Special Whisky (750 ml each) Three plastic glasses placed on a table. The shop owner failed to provide any valid explanation or permit for the possession or consumption of liquor inside the premises. Preliminary inquiry revealed that he had illegally procured the liquor and was allowing consumption inside his shop, thereby encouraging alcohol abuse among the youth of the area.

Accordingly, FIR No. 261/2025 U/S 48(f) Excise Act was registered at Police Station Doda, and further investigation is underway. During routine naka checking conducted by Police Post Pul Doda at Pul Doda, an Alto vehicle bearing registration No. JK06-5592, driven by Shakir Hussain S/O Habibullah R/O Babore Ghat, Tehsil & District Doda, was intercepted while travelling from Pul Doda towards Doda. Upon searching the vehicle, 24 bottles of 750 ml JK Whiskey were recovered from the dickey. Accordingly, FIR No. 262/2025 U/S 48(a) Excise Act was registered at Police Station Doda. The accused was arrested, and the vehicle was seized.

Snatching case cracked; accused arrested, stolen property recovered

UDHAMPUR: Police Station Rammagar received a written complaint from Kartar Chand S/o Sh. Massu R/o Prey, Tehsil Rammagar, District Udhampur, stating that, he had withdrawn ₹50,000 from his bank account. As he stepped out of

the bank premises, an unknown person snatched his handbag containing the said cash and fled from the spot.

Taking cognizance of the matter, a case FIR No. 172/2025 U/S 304 BNS was registered at PS Rammagar, and investigation was set into motion.

A special police team led by the SHO PS Rammagar was constituted to trace out the accused person. During the investigation, with the help of CCTV footage, human intelligence and technical assistance, the accused was identified as Vijay Singh @ Pickel S/o Sh. Joginder Singh R/o Sewna Rang, Tehsil Rammagar, District Udhampur

After sustained and meticulous efforts, the police team successfully arrested the accused. Out of the stolen ₹50,000, an amount of ₹47,450 has been recovered from his possession.

5 drug peddlers nabbed; heroin like substance, vehicles, weighing scale recovered

JAMMU: In a major success against drug trafficking, Jammu (Rural) Police achieved a significant breakthrough with the arrest of four drug peddlers and the recovery of heroin-like substance, one Punch car, one Bullet motorcycle, and an electronic weighing scale.

The operation was conducted under the overall supervision of SP Rural, SDPO Nagrota, and SHO Police Station Jhajjar Kotli.

During routine patrolling, a team from Police Post Manwal, led by its Incharge PSI Bhawani Singh and assisted by other officials, received credible information that four individuals were roaming in the area with the intent to sell contraband. Acting swiftly, the team established a naka near Jindrah Road, Saloon.

They intercepted a Punch car bearing registration number JK02DP-9627 and a Bullet motorcycle bearing registration number JK02CQ-7326. During the search, approximately 8 grams of heroin-like substance were recovered from the possession of the accused Rohit Jamwal, S/o Shamsheer Singh, R/o Jindrah, 2.11 grams; Abhishek Jamwal, S/o Brij Pal, R/o Jindrah, 1.55 grams; Arvind Singh @ Kaka, S/o Sat Paul, R/o Jindrah, 2.23 grams and Aditya Singh @ Veeru, S/o Omkar Singh, R/o Jindrah, 2.23 grams.

Accordingly, FIR No. 134/2025 under Sections 8/21/22/29 of the NDPS Act was registered at Police Station Jhajjar Kotli for further investigation.

A special naka was established at Qazi Morha by Police Station Poonch to strengthen checking and surveillance in the area. The police team was carrying out routine checking of vehicles and pedestrians.

During late evening hours, one person travelling from Poonch towards Chandak was found moving suspiciously and was stopped for verification. Upon his personal frisking, police recovered approximately 10 grams of heroin-like substance from his possession.

On questioning, the individual disclosed his identity as Sadaqat Ali S/O Mohd Sharif, R/O Chandak, Tehsil Haveli, District Poonch. He was immediately taken into custody by the naka team.

In this regard, FIR No. 213/2025 U/S 8/21/22 NDPS Act has been registered at Police Station Poonch. The accused has been arrested on the spot, and further investigation is in progress.
