Applicant moved the application for issuance of non-bailable warrant against the accused Pardeep Singh @ Ambedkari S/o Sansar Singh R/o Chack Sardar Singh Kathua. 2. Upon presentation of application, summons were issued against the said accused person. Issued summon received back with the report that neither the accused person nor his family members were present at home, thereafter, Tamil affixed the copy of summons on conspicuous part of the house of accused. Thereafter, NBW were issued which returned back unexecuted. 3. Incharge police station Kathua moved another application for issuance of proclamation against accused person namely, Pardeep Singh @ Ambedkari S/o Sansar Singh R/o Chack Sardar Singh Kathua which was assigned to this court by Ld. Chief Judicial Magistrate, Kathua. Office to diarize the same in the register concerned.
