CS reviews implementation of VVP-II for holistic development of border villages

JAMMU: As part of the nationwide initiative to realise the vision of Viksit Bharat, Chief Secretary, Atal Dulloo on Sunday chaired a high-level meeting to assess the progress and implementation of the Vibrant Villages Programme -Phase II (VVP-II) acros Jammu & Kashmir.

The meeting, attended by the ACS Planning, ACS APD; Secretary Tribal Affairs; concerned DCs and other senior officers of concerned departments, focused on accelerating development interventions in strategically located border vil-

The Chief Secretary underscored the urgent need to complete comprehensive surveys to identify gaps in core components such as road connectivity, telecom services, television access and electricity supply in the identified villages.

He directed the departments to undertake detailed themewise gap analysis and expedite the formulation of individual Village Action Plans aimed at saturating these areas with essential infrastructure and services. He further called for the designation of dedicated nodal officers for each component to ensure focused monitoring and timely execution.

The programme aims to transform strategically important border villages into prosperous, sustainable and secure communities

He highlighted that the scheme operates on a threepronged strategy of saturating existing central and UT schemes, strengthening basic infrastructure and building enabling capacities for sustainable livelihood generation, thereby integrating border popmainstream.

While 1,378 villages have already been connected with road infrastructure, 30 strategic villages have been proposed for connectivity under PMGSY-IV. Surveys for 169 habitations have also been completed for seeking norm relaxations to facilitate connectivity in difficult ter-

With respect to telecom connectivity it was revealed that the BSNL has expedited 4G saturation surveys, with 98 of the selected vibrant villages currently covered and plans underway to extend services to remaining shadow areas, particularly in Kupwara and Bandipora districts.

Regarding electrification. districts of Jammu, Samba and Kathua have achieved 100 per cent coverage. The Power Development Department has been directed to prioritise pending works in Tulail Valley and Kupwara

to ensure grid connectivity for the remaining 1,402 households in Kupwara and 2,574 households in Bandipora.

To bridge the information and communication gap, focused efforts are being made to provide DTH facilities to households with television sets, especially in border blocks of Baramulla and Kupwara.

For ensuring transparency and real-time monitoring, the Digital VVP Portal has been operationalised. District Nodal Officers have completed verification of Local Government Directory (LGD) codes and are in the process of finalising Village Action Plans, which utilise geo-tagging technology to align development works with village-specific needs identified during the gap analysis.

Beyond physical infrastructure, VVP-II also prioritises financial inclusion, tourism promotion and preservation of cultural heritage. The roadmap includes organisation of medical camps, awareness campaigns and tourism initiatives aimed at boosting the local economy and strengthening national integration.

It was reiterated that the Vibrant Villages Programme is a Centrally Sponsored Scheme focused on the holistic development of villages along the northern borders by improving socio-economic conditions and ensuring a better quality of life for residents of identified bor-

Cold Weather Challenges Cardiovascular Health: Dr Sushil

STATE TIMES NEWS JAMMU: In view of recent climate change and upcoming winter season Head Department of cardiology GMCH Jammu Dr Sushil Sharma held a cardiac awareness cum health checkup camp at Vishwakarma Temple Mishriwala, Jammu with main focus to reduce the impact of winter season on cardiac ailments and decrease the morbidity and mortality. Interacting with the people Dr Sushil stated that Cold weather exerts a significant influence on cardiovascular health by triggering a physiological response in which blood vessels constrict, leading to increased blood pressure and forcing the heart to work harder than usual, thereby placing additional strain on the cardiovascular system. When temperatures drop, this vasoconstriction reduces blood flow to the skin to conserve heat, but in doing so, it increases the workload on the heart and raises the risk of adverse events, especially in individuals with pre-existing heart disease. Alongside this natural response, lifestyle changes during winter such as decreased physical activity, weight gain due to heavier food intake, and increased indoor time further contribute to worsening heart health. He elaborated that the combination of narrowed arteries, elevated blood pressure, and reduced cardiovascular resilience can heighten the likelihood of angina, arrhythmias, heart attacks, and strokes. Moreover, cold weather can cause the body to release more stress hormones like adrenaline, which further elevates the heart rate and blood pressure, compounding the strain. Even sudden exposure to cold, such as stepping out into chilly air or engaging in strenuous activity, can precipitate acute cardiac events by rapidly increasing oxygen demand in the heart. Thus, understanding this interplay between cold temperatures and cardiovascular physiology is crucial for adopting protective strategies during winter months. These include wearing adequate warm clothing, avoiding sudden heavy exertion, maintaining regular exercise indoors, adhering to heart-healthy diets, monitoring blood pressure, staying hydrated, managing stress, and ensuring timely intake of prescribed medications. Recognizing symptoms such as chest discomfort, breathlessness, palpitations becomes even more

important in cold seasons. He added that in addi-

tion to the direct physical effects of cold on the

cardiovascular system, winter also influences heart health through behavioral and environmental shifts that often go unnoticed. Shorter daylight hours can disrupt circadian rhythms, leading to increased fatigue, mood changes, and decreased motivation for exercise all of which indirectly weaken cardiovascular resilience. Many individuals also consume more salty, sugary, and high-fat comfort foods during colder months, which can cause fluid retention, weight gain, and elevated cholesterol levels, further straining the heart. Even indoor heating systems can contribute by causing dehydration, which thickens the blood slightly and makes circulation more demanding for the heart. Infections trigger systemic inflammation, elevate metabolic demands. and can destabilize plaque in coronary arteries, increasing the risk of acute events like myocardial infarction. Fever, dehydration, and reduced appetite during illness also worsen heart strain. This makes timely vaccination, early treatment of infections, adequate hydration, and careful monitoring of symptoms essential during cold weather. By recognizing these interconnected winterrelated triggers, individuals and clinicians can better anticipate risks and adopt protective measures that safeguard heart health throughout the season, He said. Dr Sushil Sharma in his concluding remarks told that cold weather silently challenges the cardiovascular system by increasing blood pressure, raising heart workload, and amplifying the effects of existing risk factors, making winters a vulnerable period for heart patients. Awareness, preventive habits, and early symptom recognition are powerful tools in reducing winter-related cardiac events. By staying warm, remaining active, eating wisely, and follow ing medical advice closely, individuals can significantly protect their heart health throughout the colder months. He also urged the government to address pending issues of daily wagers, casual labourers, migrant workers, and ensure steps for the addressing the genuine issues of Kashmiri migrants & their children & for their safe and dignified return of Kashmiri

Expressing serious concern over the proposed 20% power tariff hike, Bhalla said the decision has sparked widespread resentment among citizens. He appealed to the government to roll back the hike, provide compensation to flood-affected families, and extend support to business units suffering from natural disasters.

Bhalla further sought strict measures to curb drug abuse. establishment of rehabilitation centres, revival of the industrial sector, creation of employment opportunities for youth, improvement in healthcare and education infrastructure, and promotion of tourism.
