

JAMMU: National Sikh Front (NSF) Chairman S. Varinderjeet Singh strongly condemned the recent order of the United States Department of Defence banning beards and long hair for its uniformed personnel, terming it a "direct assault on the religious identity of Sikhs" and "gross violation of fundamental rights".

In a hard-hitting statement issued here, S. Varinderjeet Singh said the directive issued by US Defence Secretary Pete Hegseth revoking religious accommodation for Sikh



soldiers was "highly regrettable, discriminatory and unacceptable". He said forcing a Sikh to choose between faith and uniform

was nothing short of religious persecution."

The Sikh articles of faith, including unshorn hair and beard, are not optional. They are mandatory and non-negotiable. This order insults the sacrifices of countless Sikh soldiers who have served the US forces with full religious symbols since World War I," the NSF Chairman said.

He warned that the decision would not only affect serving Sikh personnel but also discourage future generations from joining the armed forces.

S. Varinderjeet Singh urged the Government of
