JAMMU: The Bharatiya Janata Party (BJP) today addressed a press conference on the recent controversy surrounding the selection of 42 Muslim candidates in the medical college established and funded by the Shri Mata Vaishno Devi Ji Shrine Board

The briefing was addressed by BJP Chief Spokesperson Sr. Advocate Sunil Sethi, Sr. Advocate Abbinay Sharma Advocate Ankur Sharma, and Zorawar Singh Jamwal, who also moderated and introduced the subject of the press conference.

Sr. Advocate Sunil Sethi cautioned against politicising or communalising the matter. He criticised Chief Minister Omar Abdullah for what he described as attempts to project the issue as a Hindu-Muslim conflict.

Sethi said the sensitivities associated with Shri Mata Vaishno Devi Ji Shrine, being a revered Hindu religious institution, must be respected. At the same time, he added that "the rights of the selected candidates can be protected through several available legal and administrative avenues," urging responsible handling of the situation.

Sr. Advocate Abhinav Sharma pointed to what he called inadequate publicity of the

admission process. According to him, limited dissemination of information deprived many meritorious Hindu students of an opportunity to opt for the college during counselling.

He alleged that Omar Abdullah was "playing to the galleries of a particular political constituency," and said that the former CM's remarks were politically motivated rather than aimed at constructive resolution.

Advocate Ankur Sharma strongly criticised Omar Abdullah for "mocking the sentiments of the Hindu community" by what he described as a "deriding and trivialising" response to the concerns raised.

Sharma argued that the Shri Mata Vaishno Devi University Act, 1999 should be revisited by the legislature. He stated that the University and the upcoming medical college have their origins, funding, and institutional purpose rooted in the Hindu religious tradition, and therefore possess a distinct religious identity.

On that basis, he asserted that the Act could be amended by the competent authority to reflect and preserve this identity, including exploring legally viable provisions institution's founding purpose. He emphasised that any such consideration must be within the constitutional and statutory framework. He slammed Omar Abdullah for his statements justifying and rationalising terror and termed him a terror sympathiser. BJP spokesperson Zorawar Singh

Jamwal concluded the press conference by challenging what he called Omar Abdullah's "bluff" on the issue. Jamwal criticised the former Chief Minister's attacks on the Leader of Opposition, terming them baseless and politically motivated.

He said the BJP would continue to raise the concerns of the community while urging that the matter be approached with seriousness and sensitivity rather than politici-

Ladakh must prepare for climate challenges with strong watershed systems: LG

The Governor of Ladakh, Kavinder Gupta, on launched the State Level Watershed Mahotsav under the Watershed Development Component-Pradhan Mantri Krishi Sinchayee Yojana (WDC-PMKSY) 2.0 at the DC Conference Hall, Leh. The event underscored the importance of community participation, sustainable water management and long-term ecological balance in Ladakh's coldarid Himalayan region.

The programme aims to strengthen water conservation, improve irrigation facilities and optimise land use to enhance agricultural productivity in areas. Marking National Constitution Day, the Lt Governor also administered the Constitution Day pledge, reaffirming collective commitment to national integrity and constitutional values

Addressing the gathering, Kavinder Gupta highlighted the transformative role of watershed-based planning for Ladakh's development. Given Ladakh's fragile geographycharacterised by glaciers, snowmelt-fed water systems minimal rainfall-he stressed that watershed development offers a reliable model for water security, climateresilient agriculture and livelihood enhancement

He noted that the Mahotsav symbolises a jan-andolan, driven by active community involvement rather than merely a government programme. The Lt Governor appreciated

the enthusiastic participation of farmers, women self-help groups, youth volunteers, PRI members and cultural groups. He encouraged their continued involvement Shramdaan, plantation drives rejuvenation of traditional water sources and maintenance of watershed assets. Community-led decision-making in site selection, design feedback and future upkeep, he said, ensures long-term sustainability.

Kavinder Gupta also reiterated the vision of the Prime Minister Narendra Modi, who emphasises that water conservation must become a people's movement. He stated that initiatives such as Catch the Rain, Amrit Sarovar Mission, Jal Jeevan Mission and PMKSY reflect this national commitment, and affirmed Ladakh's dedication to advancing watersecure villages and balanced ecology.

Reaffirming Administration's resolve, he announced an integrated model combining PMKSY, MGNREGA and Rural Development programmes to strengthen water harvesting

structures, expand irrigation capacity and reduce soil erosion. He added that Ladakh will continue to work toward doubling farmers' income under WDC-PMKSY 3.0.

He further stated that youthfocused activities-awareness rallies, expert sessions, technical demonstrations, Pani ki Pathshala and plantation drives-will deepen environmental responsibility among young residents.

Earlier, RDD Secretary Shanshanka Ala, informed that WDC-PMKSY 2.0 will conclude in 2026, followed by a more locally adaptive WDC- PMKSY 3.0.Coordinator Shahnaz shared that 11 watershed projects-six in Leh and five in Kargil-are underway, along with 36 micro-watershed focusing on greenhouses, reservoir tanks, percolation tanks, irrigation khuls and springshed development.

STATE TIMES NEWS JAMMU: At a first ever interaction of pensioners and senior citizens with State Bank of India officers at an event at IIPA auditorium today, the Deputy general Manager, State Bank of India, Business & Development, J&K Module, Jayant Mani listed Bank's schemes for the convenience of pensioners and said that the SBI is serving over 44 lakh pensioners in the country through 18 Central Pension Processing Centres.

Central Pensioners Association (CGPWA) and Indian Institute of Public Administration, J&K Regional Branch (IIPA JK RB) have jointly organised an awareness lecture for the benefit of pensioners and senior citizens. The function was presided over by the President, CGPWA Kuldeep Khoda. The Patron of IIPA J&K RB Dr Ashok Bhan was the Chief Guest while the Chairman of the IIPA J&K RB, B R Sharma was the

Mani said that the SBI provides Doorstep Banking Services to Pensioners with special facilities for physically challenged ones. It also provides Non Home Branch Pension Loan for SPARSH Pensioners. All pensioners up to the age of 70 are covered by personal accident insurance of Rs 30 lakh on request. He said that the Bank has a special scheme for Senior Citizens viz. SBI Patrons ke Saath under which an FDR with higher rate of interest for citizens of above 80 years. Another scheme for pensioners. Senior Citizen Saving Scheme, under which 8.20% rate of interest for deposits up to Rs $30~{\rm lakhs}$ is available for retired civilian & retired defence personnel of the age of 55 to 60 years and 50 to 60 years respectively for five years, extendable in the block of another three years. He said that the SBI also provides Pension Loan up to Rs 5 lakhs at low interest rate of interest, with enhanced Loan

limit up to Rs 20 lakhs, adding

that dreams never retire.
