Khatana visits Nowgam blast victims & survivors, vows full assistance

SRINAGAR: Rajya Sabha MP and senior BJP leader Gulam Ali Khatana on Thursday visited the victims and survivors of the Nowgam blast and met with affected families in Natipora, Police Colony Bemina, Qamarwari, and Ghazaliabad.

Governor administration are fully committed to supporting them and will ensure all necessary relief and rehabilitation measures are provided.

While speaking to the families, Khatana said, "This tragic incident has affected many lives, but Kashmir's spirit is unbreakable. The Union Government is with you, and every possible support will be provided for medical care, housing, and livelihood. Together, we will

rebuild and ensure that the victims and their families receive justice, care, and security."

Khatana personally interacted with the families, inquiring about their well-being and the support they require for medical treatment, housing repairs, and daily necessities. He emphasized that the Union Government is closely monitoring the situation and is determined to provide swift assistance to help the victims

recover from the tragedy. He also visited the UJALA Cygnus Kashmir Super Speciality Hospital, Nowgam, where he met medical staff and patients, appreciating the hospital's role in providing timely and critical care to those affected by the blast. Khatana encouraged the community to remain resilient and assured that the government will continue to provide full support for the victims' rehabilitation and well-being.

Shiv Sena demands death penalty of traitors involved in 'white collar' terror module

JAMMU: Shiv Sena (UBT) Jammu and Kashmir unit has called for stringent action against those allegedly involved in the recent Delhi bomb blasts and the so-called "white collar" terror module. The party has demanded that the accused be declared traitors and that the Union Government take decisive steps to dismantle the network. The organisation also voiced strong political demands, including harsher laws and firm action against Pakistan, attributing these views to party leaders.

Jammu - Pathankot National Highway, holding placards urging strict punishment for the accused and calling for measures to counter Pakistan-sponsored terrorism. The protestors also burnt an effigy symbolising "white collar terrorism."

Addressing the gathering, Sahni said that the Delhi blast incident had revealed a deeply concerning and organised terror network operating under a "white collar" cover. He described the alleged module as a threat to the nation's internal security. According to him, security agencies have arrested several individuals so far, including around 10 doctors and multiple alleged conspirators, with

further arrests expected. He referred to recent developments in J&K, including the arrest of an electrician, Tufail Niaz Bhat, from Kashmir, and Mohammad Sajid, a NEET aspirant, from Jammu's Bathindi area for alleged links to Pakistan-based terror networks. Sahni emphasized that the scale and organised nature of the case warrant a nationwide investigation. He also said that early reports link the module with Pakistan-based outfit Jaish-e-Mohammed. Sahni urged the Central Government to classify those involved in the "White Collar Terror Module" as traitors and introduce strong punitive provisions. Referring to a recent state-

ment by Army Chief General Upendra Dwivedi that "Operation Sindoor was just a trailer," Sahni said such threats must be responded to with firm measures and argued that Pakistan-based terror infrastructure must be dismantled through strong national action. Those present on the occasion included Raj Singh (President Kamghar Wing), Shahshipal, Pawan Singh, Rajesh Sharma, Parveen Sani, Raj Kumar, Arjun Sharma, Rozi, Mumtaj, Neelan, Kush Sharma, Yashpal, Sham, Munish Sharma, Narinder Kumar, Jatinder Sharma, Rajinder, Bhupinder Singh, and several other party members.
