ORDER

An application has been moved by SHO P/S Kanachak through Ld. APP stating therein that accused namely Major R.P.S Ahluwalia S/O A.S Ahluwalia (IC 44355) 202 Engineer Regiment C/O 56 APO (Driver of car no UAH 6767), is absconding of P/S Kanachak in the above said FIR and this Court has already issued warrant of arrest u/s 512 Cr.PC against him on 19.01.2023 but the said accused remains untraced. Despite the best efforts of Tamili HC of this Police Station, the said accused has not been located and the execution of warrant has not been successful. The commanding officer, 202 Regiment C/O 56 APO Jammu of locality has also been contacted in this regard but no clue found against the accused. As such, prayed for initiating proceeding under section 87 Cr.PC against him.

Heard and Considered

I have heard Ld. APP for UT. Perusal of main file reveals that proceedings under section 512 Cr.PC have been initiated against the accused by this Court vide order dated 19.01.2023 and proclamation under section 87 Cr.PC has not been issued till date. For ready reference, Sec 87 Cr.PC reads as

Section 87 Cr.PC: Proclamation for person absconding

(1) If any Court has reason to believe that any person against whom a warrant has been issued by it has absconded or is concealing himself so that such warrant cannot be executed, such Court may publish a written proclamation requiring him to appear at a specified place and at a specified time not less than thirty days from the date of publishing such proclamation.

(2) The proclamation shall be published as follows:-
(a) it shall be publicly read in some conspicuous place of the town or village in which such person ordinarily resides;
(b) it shall be affixed to some conspicuous part of the house or home stead in which such person ordinarily resides or to some conspicuous place of such town or village; and
(c) a copy thereof shall be affixed to some conspicuous part of the Court-house.

(3) A statement in writing by the Court issuing the proclamation to the effect that the proclamation was duly published on a specified day shall be conclusive evidence that the requirements of this section have been complied with, and that the proclamation was published on such day.

It is clear from the above referred provision that a person against whom proclamation has been requested has been absconded or is concealing himself so that warrants under section 512 Cr.PC cannot be executed against her. As such, this Court has ample powers to proceed against absconded person under section 87/88 Cr.PC. As such, before proceeding ahead under section 88 of Cr.PC, it will be proper and appropriate to issue proclamation against the absconding person.

As such in view of the discussion made supra, proclamation in terms of Section 87 of the Code of Criminal Procedure is directed to be issued against accused namely Major R.P.S Ahluwalia S/O A.S Ahluwalia (IC 44355) 202 Engineer Regiment C/O 56 APO (Driver of car no UAH 6767), who has absconded after committing the crime. The accused shall be required to cause her appearance before this Court within one month, failing which the process of attachment of her property in terms of Section 88 Cr.PC, shall follow.

A copy of the proclamation shall be pasted at a conspicuous place in the Court premises and in the town. A copy of the proclamation be also sent to SHO concerned for pasting the same on or around the residence of accused, so that the accused has due notice of the proclamation. A copy of this order along with copy of proclamation shall be forwarded to SHO concerned for publication of proclamation in some daily newspaper having its circulation in the area with intimation to this Court. SHO concerned be also directed to furnish a list of moveable and immovable property of accused.

JAMMU: Jammu and Kashmir suffered second consecutive loss when they were beaten by Goa by 14 runs in the Women's Under-23 Twenty20 Trophy Elite at Lady Amritbai Daga College Ground, Nagpur today.
