The Lieutenant Governor further directed that individuals or groups running Facebook pages, online news portals, or social media handles under the banner of journalism must be duly registered and verified by the Department of Information and Public Relations (DIPR). He emphasized that such digital media platforms must be made accountable for the content they publish and should function strictly within the bounds of media ethics and lawful reporting.

Officials said the move comes amid growing complaints that certain individuals cosing as journalists were misusing media identification cards or social media platforms to intimidate officials and extract favours. Several legislators in the recent Assembly session had also raised this concern and sought a mechanism to curb the

"The government values the role of genuine journalists who report with integrity and responsibility," another senior officer said. "However, action against those bringng disrepute to the profession is inevitable.

While hearing the matter on October 27, the top court had directed the chief sec retaries of states and UTs, except West Bengal and Telangana, to remain present before it on November 3 to explain why compliance affidavits were not filed despite the court's August 22 order.

The apex court on August 22 asked the states and UTs about the steps being taken for compliance of the Animal Birth Control (ABC) Rules.

The bench had expressed displeasure over the non-compliance of its order and observed that by October 27, compliance affidavits were not filed by the states and UTs, except West Bengal, Telangana and the Municipal Corporation of Delhi (MCD).

It had made clear that the chief secretaries would have to appear in the court and explain as to why no compliance affidavits were filed by them.

On October 27, the top court had slammed the states and UTs, which had not filed their compliance affidavits in the matter, and said continuous incidents were happening and the country was being "shown as down" in foreign nations

The apex court had earlier expanded the scope of the stray dogs case beyond the confines of Delhi-National Capital Region, and directed that all states and UTs be made parties in the matter

It had directed the municipal authorities to file an affidavit of compliance with complete statistics of resources like dog pounds, veterinarians, dog-catching personnel, and specially-modified vehicles and cages available as on date for the purpose of compliance of the ABC Rules.

The bench had also impleaded the states and UTs in the matter while observing that application of ABC Rules was uniform all over India.

NCB arrests partner in Digital Vision Pharma, Kala Amb

CHANDIGARH:

Chandigarh Zonal Unit of the NCB arrested Anuj Kumar Singh, age about 42 and resident of Roorkee, Haridwar (Uttarakhand), following detailed questioning after he evaded earlier summonses issued since 14 August 2025.

An NCB official said the investigation-triggered with registration of a case under the Narcotic Drugs and Psychotropic Substances Act, 1985 (NDPS Act) in February 2025-has traced the role of Digital Vision Pharma, Kala Amb (Himachal Pradesh), and two other Uttarakhandbased manufacturers in the illegal manufacture and diversion of psychotropic tablets and codeine-based cough syrup bottles to nonexistent firms operating across Punjab, Rajasthan and West Bengal.

The NCB official added. "Investigations show that the firm, under Singh's partnership, acted as a major manufacturing and supply node in the interstate illicit diversion network. We have seized 21.88 lakh psychotropic tablets, 10.57 lakh CBCS (codeine-based cough syrup) bottles, and 1,002 kg of psychotropic raw material

The accused had earlier served as General Manager of Digital Vision in 2020 and 2022; he is also named in FIR 33/22 (PS Ram Nagar, UT J&K). The firm was earlier implicated in FIR 21/2020 (PS Kala Amb, HP) after 12 infant deaths in Jammu & Kashmir linked to its syrup "Cold Best-PC".
