

Delhi cops haven’t shared info about arrest of ‘Sulli Deals’ App creator: Indore police

INDORE: The Indore police on Sunday said their Delhi counterparts have not shared any information with them about the arrest of a 26-year-old man, believed to be the creator of "Sulli Deals" app, from here in Madhya Pradesh.

Earlier in the day, officials said the Delhi Police have arrested the accused, identified as Aumkareshwar Thakur (26), who did his BCA from IPS Academy in Indore and is a resident of Newyork City Township.

This is the first arrest made in the 'Sulli Deals' app case, they said.

However, Indore's Police Commissioner Harinarayanchari Mishra told PTI, We have come to

know only from the media about the arrest of Thakur from Indore by Delhi Police. The Delhi Police have not shared any official information with us in this regard so far.

Mishra also said that the Indore police will consider starting an investigation into the matter after the Delhi Police share with them the official details of the case.

Hundreds of Muslim women were allegedly listed for 'auction' on the mobile application with photographs sourced without permission and doctored.

Deputy Commissioner of Police (IFSO) KPS Malhotra said during preliminary interrogation, the accused admitted that he was a member of a

group on Twitter and the idea to defame and troll Muslim women was shared there.

"He had developed the code on GitHub. The access of GitHub was with all the members of the group. He had shared the app on his Twitter account. The photos of the Muslim women were uploaded by the group members," the official said.

According to police, Niraj Bishnoi, the alleged mastermind and creator of the 'Bulli Bai' application, had disclosed during interrogation that he was in touch with the person behind the Twitter handle @sullideals, the alleged creator of the 'Sulli Deals' app that was hosted on GitHub in July last year.

Interest calculator soon in GSTR-3B for delayed monthly tax payment

NEW DELHI: GST Network, which provides technology backbone for the indirect tax regime, will shortly release interest calculator functionality in monthly tax payment form GSTR-3B to help taxpayers in calculating interest for delayed tax payment.

This new functionality will compute the minimum interest applicable on the basis of the values declared by the taxpayers in GSTR-3B for a particular tax period, GSTN said in an advisory.

"To facilitate taxpayers in doing self-assessment, the new functionality of interest calculator is being released in GSTR-3B. This functionality will assist taxpayers in calculating the interest applicable for delayed filing of returns. Taxpayers will have to verify and discharge the correct interest liability as per law, as payment of interest is a statutory compliance," it said.

As per Goods and Services Tax law, 18 per cent interest is charged for failure to pay tax liability on time, while 24 per cent interest is levied for undue or excess claim of input tax credit (ITC) or reduction of output tax liability.

This functionality will be made available on the GST Portal shortly, the advisory said, adding it will improve ease in filing return.

AMRG & Associates Senior Partner Rajat Mohan said,"this change will enhance the user experience by affording them the necessary tools to compute precise interest liability and enable authorities in a timely collection."

No plan to impose lockdown in Delhi yet: Kejriwal

NEW DELHI: Delhi Chief Minister Arvind Kejriwal on Sunday said there is no plan to impose a lockdown as of now in the city, and that there will be no need for it if people wear masks.

He said that on Sunday, the city is likely to report 22,000 COVID-19 cases in 24 hours.

He appealed to the public to wear masks and not panic.

Rising COVID-19 cases are a matter of concern but there is no need to panic. Very few people are getting hospitalised. Wearing mask is very important. There will be no

lockdown if you continue to wear mask. There is no plan to impose lockdown as of now, Kejriwal said in a virtual press conference.

The CM said that he along with Lieutenant Governor Anil Bajjal and the Centre are keeping a close eye on the Covid situation.

Our attempt is to impose minimum restrictions so livelihoods are not affected, Kejriwal said.

Comparing the current third wave with the second Covid wave in April-May last year, the CM said that on May 7, 2021 there were

20,000 cases reported with 341 deaths but on Saturday Delhi witnessed same number of cases with only seven deaths.

He, however, said that there should not be even a single death.

On May 7 last year nearly 20,000 Covid beds were occupied while till yesterday there were only 1500 hospital beds occupied despite having reported same number of cases.

"I am telling you this data to show that very less people are requiring to go to hospital in this infection and you

do not need to panic. We just have to behave responsibly, Kejriwal said.

The CM said that a meeting of the Delhi Disaster Management Authority (DDMA) will be convened on Monday to further review the situation and discuss efforts to be taken.

We have overcome the dangerous second wave last year and we will sail through this one too, Kejriwal said.

He also appealed to the public not to go out unnecessarily and follow social distancing norms.

He also urged people to

take vaccine and get themselves protected against the virus.

The national capital has been seeing an uptick of daily cases in the last few days, mainly triggered by the Omicron variant of the infection.

According to data by health department, Delhi recorded 20,181 new COVID-19 cases and logged seven deaths on Saturday. The positivity rate rose to 19.60 per cent.

To curb the spread of the virus, the DDMA has already imposed a weekend curfew in the city.

Centre surveys 17.78 lakh acres of defence land using advanced technologies

NEW DELHI: In a first such comprehensive exercise since Independence, the government has surveyed 17.78 lakh acres of defence land using the latest technologies such as three-dimensional modelling, drone and satellite imageries.

The defence ministry said the mammoth exercise of surveying about 1.61 lakh acres of defence land inside cantonments and 16.17 lakh acres outside cantonments was started in October 2018 and is now completed.

"It is a remarkable achievement since, for the first time after Independence, entire defence land has been surveyed by using latest survey technology," it said.

The ministry said the mag-

nitude of landholding, the location of land in approximately 4,900 pockets, inaccessible terrain in many places and involvement of various stakeholders made it one of the "largest" land surveys in India.

It said modern survey technologies such as Electronic Total Station, Differential Global Positioning System as well as drone and satellite imageries were used to ensure "reliable, robust and time-bound" outcomes.

"For the first time, drone imagery-based survey technology was used for survey of lakhs of acres of defence land in Rajasthan. The entire area was surveyed with the help of Surveyor General of India in a matter of weeks, which earlier used to take years," the

ministry said in a statement.

It said satellite imagery-based survey was carried out for the first time for many defence land pockets.

"3D Modelling techniques for better visualisation of defence land in the hilly areas have also been introduced by utilising Digital Elevation Model in association with Bhabha Atomic Research Centre (BARC)," it said.

The Directorate General Defence Estates that operates under the Ministry of Defence was the nodal agency for the survey.

The ministry said out of 17.78 lakh acres, 8.90 lakh acres was surveyed during the last three months.

Probe ordered after large number of passengers test COVID positive at Amritsar Int'l Airport

AMRITSAR: A probe has been ordered against a private laboratory after a number of flyers who reached here from Italy recently tested positive for COVID-19 amid allegations by several of them that their test reports were incorrect, health officials said on Sunday.

The Airports Authority of India has also replaced the services of the Delhi-based laboratory with a local lab, officials said.

The probe had been ordered after several of the passengers who returned from Italy had alleged that their Covid positive report was not correct as they had tested negative hours before boarding the flight. They had raised questions on the testing practice adopted by the lab. Many among them had even cre-

ated ruckus at the international airport here.

Some of the passengers who had arrived here at Shri Guru Ramdas International Airport had subsequently tested negative in a re-test later, officials said.

Assistant Civil Surgeon Dr. Amarjit Singh said on Sunday, A probe has been initiated by the Airports Authority of India against the alleged errant working of the lab. The services of the existing Delhi-based lab has been suspended and new local lab has resumed its working at the airport."

He said the services of this Delhi-based lab were engaged on December 15, 2021 by the Airports Authority of India.

At least 173 passengers on a Rome-Amritsar chartered flight were found to

be Covid-positive after being tested on arrival on Friday, officials said.

This is the second consecutive incident wherein a large number of passengers coming from Italy to Amritsar airport have tested positive for the coronavirus on arrival.

On Thursday, 125 passengers who were travelling from Milan in Italy on another charter flight were found positive after being tested on arrival at the Amritsar airport.

According to the rules of the Union Health Ministry, passengers coming from "at risk" countries to India have to compulsorily get tested for COVID-19 on arrival at the airport.

All European countries, including Italy, have been deemed as "at risk" countries by the Union Health Ministry.

Nearly 400 Parliament staffers test COVID positive; attendance restricted

NEW DELHI: Nearly 400 staffers working with Lok Sabha and Rajya Sabha secretariats and allied services have tested positive for COVID-19 in the last few days, triggering a move to impose restrictions on employees' attendance.

According to sources, 65 staffers of Rajya Sabha Secretariat, 200 of Lok Sabha Secretariat and 133 of allied services have tested positive for COVID-19 between January 4-8 during regular tests. The development comes days before the Budget session of Parliament, which usually begins in the end of January.

After the surge in cases among employees, the Rajya Sabha Secretariat has reimposed restrictions on atten-

dance of officials and staffers.

According to the latest directions, 50 per cent of officials and staff below the rank of under secretary or executive officer are required to work from home till the end of this month.

They constitute about 65 per cent of the total employees.

Rajya Sabha Chairman M Venkaiah Naidu has reviewed the situation and directed that necessary measures be taken to contain the spread of virus among the secretariat officials and staffers ahead of the Budget session.

Those with disabilities and pregnant women are exempt from attending office. Starting and closing timings of the secretariat have been staggered to avoid crowding.

All official meetings will be held virtually.

Naidu has also directed that all officials and staffers should be tested for the coronavirus and recovery of the infected should be closely monitored and they should assisted in hospitalisation and treatment, if needed.

In a recent circular, the Lok Sabha Secretariat said 50 per cent of officers below the level of under secretary will attend office by rotation as decided by their respective directors.

The working hour of all employees who attend office on a particular day has been staggered between 10 am and 10:30 am with corresponding office exit timings to avoid rush in commuting as also in lifts and corridors.

Sikkim Tourism Minister B S Panth contracts COVID-19

GANGTOK: Sikkim Tourism Minister B S Panth on Sunday said he has tested positive for coronavirus and is in home isolation.

In a social media post, the 69-year-old minister said, "I have tested positive for coronavirus. I have isolated myself at home."

Meanwhile, the Himalayan state's COVID-19 tally rose to 32,719 on Sunday as 70 people, 25 more than the previous day, tested positive for the infection, a health bulletin said.

Fifty-one cases were registered in East Sikkim, followed by 13 in West Sikkim and six in South Sikkim.
