





## Illegal extraction &amp; transportation of minerals: 2 arrested, 2 vehicles seized

**GANDERBAL:** Police on Friday arrested 2 persons and seized 2 vehicles for illegal extraction and transportation of minerals.

Officers from Police Station Ganderbal arrested 2 persons and seized 2 vehicles (Tippers) bearing registration numbers JK03A-0911 and JK04-9101 involved in illegal extraction and transportation of minerals from Nallah Sindh near Waheedpora Ganderbal. The arrested persons were identified as Mehraj-ud-Din Guroo, son of Gh Mohd Guroo and Sajad Ahmad Rather, son of Nazir Ahmad Rather, both residents of Ganderbal. They were shifted to Police Station where they remained in custody. Accordingly, FIR No. 232/2021 under relevant sections of law was registered at Police Station Ganderbal and further investigation initiated.

## 13 bovines rescued; 2 arrested

**VIJAYPUR:** In its continued efforts to eradicate menace of bovine smuggling from society, District Police Kathua under overall supervision of SSP Kathua, R.C.

Kotwal on Friday succeeded in foiling bovine smuggling attempt by rescuing 13 bovines and arrested 2 smugglers.

As per details, a police team led by Insp Surinder Paul Singh, SHO Lakhmanpur while on Naka/checking duty noticed a suspicious Truck (JK14B-8681) which was being driven by one Yaqoob, son of Mohd Aslam, resident of Baggal Dhana Tehsil Haveli, District Pooreh who along with his accomplice namely Ahmed Din, son of Jalal Din, resident of Sari District Pooreh was signaled to stop for checking. On checking, Police found 13 bovines tightly tied with ropes in the vehicle which were being transported without any permission and were rescued. Both smugglers were arrested and FIR No 118/2021 under section 188 of IPC, 11 of PCA act was registered at Police Station Lakhmanpur.

## 2 drug peddlers arrested; contraband recovered

**AWANTIPORA:** Continuing its efforts to eradicate menace of drugs from the society, Police on Friday arrested two drug peddlers in Awantipora and recovered contraband substance from their possession.
