DC Bandipora reviews COVID-19 containment measures; briefs media about situation

BANDIPORA: The Deputy Commissioner (DC) Bandipora, Dr Owais Ahmad on Wednesday chaired a meeting to review the Covid-19 scenario and various mitigation measures in the district.

The meeting discussed threaddare Covid containment measures and stress was laid on the strict implementation of Covid protocol, extensive sampling and mass vaccination.

Soon after the meeting, the DC briefed the media about the situation in the district with regard to the pandemic.

The DC informed that there are 664 Covid positive patients in the district as on date out of which only four are under hospital isolation. He said all the home isolated patients are regularly monitored by the doctors and all SOPs are being followed while dealing with the positive cases.

He said the district witnesses abrupt surge in positive cases though very few required hospital isolation. He said the district is well equipped with healthcare infrastructure as compared to last year.

Giving details, DC said the District Hospital has a capacity of 2000 LPM oxygen plant-double than last year with an additional 300 LPM Oxygen plant at CHC Dawar in Gurez while one oxygen plant will soon be made functional in CHC Hajin.

Dr Owais said SOPs are followed regarding Covid positive cases including contact tracing and isolation of the patient. They said every patient is attended thrice a week from the control room and vitals are recorded.

Arrangements for Republic Day celebrations finalised at Anantnag

ANANTNAG: The Additional Deputy Commissioner (ADC) Anantnag, Gh Hassan Sheikh today chaired a meeting of the concerned officers to discuss and finalize the arrangements for smooth and successful celebration of the Republic Day-2022 in the district.

The meeting was held under strict adherence of COVID protocol and all the participants were fully masked.

It was decided in the meeting that the main function will be held at GDC (Boys) Khanabal where Chief Guest will unfurl the National Flag and take salute at the March past comprising the contingents of CRPE, JKP, NCC and Fire & Emergency.

Flag hoisting Ceremony will also be held at Sub-Divisional and Tehsil Levels.

The meeting was informed that the Republic Day celebrations will begin with playing of Shehmai Vadan at designated places by the Information Department in the wee hours.

For smooth conduct of the National event, tasks were assigned to District Officers related to stage preparation, seating arrangement, Cultural Programmes etc for the successful celebration of the National Function.

The ADC laid special emphasis on adherence to Covid

He said he had directed the officers for strengthening surveillance, enhanced testing, monitoring of hot spots, and prompt dispatch of samples for genome sequencing and other actions.

With regard to the vaccination drive for children of 15-17 years age-group, DC said so far 30 percent target has been achieved. He said 26639 children of the given age group are to be vaccinated.

He lauded the efforts of healthcare workers for working tirelessly to vaccinate every single individual. He said the workers moved to hilly terrains, Snow bound areas and other inaccessible areas amid sub-zero temperature to ensure all the youngsters of given age group are vaccinated.

He urged the people to follow

Appropriate Behavior while observing the Republic Day Celebrations so as to minimize the chances of its spread.

A detailed discussion was also held on various issues regarding seating arrangements, barricading, security, traffic regulation, drinking water and power supply, sanitation, first-aid, PAS, fire-tenders, Media gallery, among others.

The ADC directed the concerned Executive Engineers to ensure adequate arrangements of barricading, seating and drinking water supply besides uninterrupted power supply on the day of function.

He also passed directions to the concerned officers to ensure ambulance, fire tender, security and provision of adequate manpower at the venue of the event.Calling for strict compliance to COVID SOPs while performing different activities related to the National day celebrations, ADC asked for ensuring that all the COVID related protocols are strictly adhered to by all the participants during rehearsals and on the scheduled day to avoid the risk of infection.

ACD, Chief Education Officer, Executive Engineers of PHE, PWD and PDD, DYSSO, Dy CMO and all other concerned officers were present in the meeting.
