

Similarly, teams from Police Station City and Police Station Gandhi Nagar led by SHO City Inspr Vijay Kumar and SHO Gandhi Nagar Inspr Pankaj Sharma during patrolling duty in area rounded up two different suspects namely Anuj Dubey, son of Uttam Chand, resident of Lower Mastgarh Jammu and Ashwani Kumar alias Patti, son of Late Kamal Kumar, resident of Nanak Nagar Jammu. The overall arrests and recoveries were made under the supervision of SDPO R S Pura Shabir Khan, SDPO Domana Sunil Singh, SDPO North Sharad Kalu and SDPO South P K Mengi respectively; Further investigation is going on.

7 vehicles seized for illegal mining

 JAMMU: In a quest to check menace of illegal mining, a multi-pronged strategy was devised by Jammu Police in which teams from Police Stations Domana, Nagrota, Police Posts Chatta & Chatha acted stringently on specific inputs and raided different locations in their respective areas and seized 7 different vehicles involved in illegal mining. The seized vehicles include 3 tractor-trolleys without registration number seized by Domana police; a tipper without registration number seized by Nagrota police; a tractor-trolley (JK02CC 5544) and a tractor-trolley without registration number seized by Chatta police and a JCB bearing engine No KPIL SL13900103106 was seized by Chatha police.

The overall recoveries were made by SHO Domana Inspr Mahesh Sharma, SHO Nagrota Inspr Vishav Pratap Singh, Incharge Police Post Chatta PSI Arun Kumar Shan and Incharge Police Post Chatha PSI Ranjit Singh in their respective jurisdictions. DMO Jammu was also intimated about the same.

13 bovines rescued; five smugglers arrested

 JAMMU: In a massive drive against bovine smuggling, Jammu Police rescued 13 bovines from three different vehicles during Naka checking at Ban Toll Plaza Nagrota.

In this regard, FIR Nos. 6, 7 & 8/2022 under sections 188 of IPC and 11 of PCA, were registered at Police Station Nagrota and accused were arrested.

Three vehicles (JK02CN/5243, JK02CU/1566 and JK14E/6012) involved in crime have also been seized. The accused were identified as Mohd Hanief, son of Abdul Rishid, resident of Dablaher, R S Pura District Jammu (driver of vehicle JK02CN/5243); Amir Hussain, son of Liaquat Ali, resident of Kachwan, Anantnag (associate with vehicle No JK02CN 5243); Sadam Husain, son of Mohd Raiz, resident of Gunn Reasi (driver of vehicle JK02CU/1566); Mohd Sadiq, son of Nazir Ahmed Chouhan, resident of Qaziqund (associate of vehicle JK02CU/1566) and Mohd Gafoor, son of Shah Mohd, resident of Wali Nalla Udhampur (driver of vehicle JK14E/6012). The arrests and recoveries were made by SHO Nagrota Inspr Vishav Pratap Singh under supervision of SDPO Nagrota Parupkar Singh. The operation was done under guidance of SP Rural Sanjay Sharma.

CRPF Jawan commits suicide




