Narco-smuggler nabbed, 1 Kg Ganja recovered

JAMMU: Continuing drive against drug trafficking, Police achieved a major success by recovering 1 Kg Ganja at a Naka in jurisdiction of Police Station Satwari.

As per details, a team of Police Station Satwari constituted under the supervision of SDPO South Sachit Sharma and led by SHO Satwari Inspr Sameer Jeelani assisted by PSI Meetu Singh rounded up a suspect namely Amola Ram, son of Ram Dass, resident of Dayaram Bhaloin, Tehsil Kataia, District Gopalganj. During search, 1 Kg Ganja was recovered from him. He was arrested and FIR 16/2023 under sections 8/20 of NDPS Act was registered at Police Station Satwari. Further investigation of case is going on.

Two missing persons reunited with families

JAMMU: Police has reunited two missing persons with their families under jurisdictions of Police Post Sidhra and Police Post Greater Kailash.

As per details, a complaint was registered at Police Post Sidhra by legal heirs of one Mohd Akram, son of Shamim Ahmed, resident of Bajalta stating that he went missing from his house. Accordingly, missing report was registered and investigation started. Special police teams, under the supervision of SDPO Nagrota Pradeep Kumar were constituted and a team led by SHO Nagrota Inspr Vishav Partap Singh assisted by Incharge Police Post Sidhra Nitish Khajuria, after putting in strenuous efforts, traced missing person.

Similarly, another complaint was lodged at Police Post Greater Kailash by legal heirs of a girl stating that she went missing from her house and a missing report was registered at Police Post Greater Kailash. Special police teams under the supervision of SDPO South Sachit Sharma were constituted and a team led by SHO Police Station Gangyal Inspr Ajaz Haider assisted by Incharge Police Post Greater Kailash Harish Chander, after putting in hectic efforts, traced missing girl. Subsequently, families of both missing persons were informed and they were handed-over to their family members after completing all legal formalities.

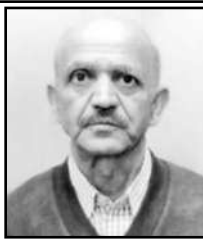
