Qasim, originally a resident of Angrala village of Mahore in Reasi district, is absconding and his name cropped up during investigation of the case, exposing the terror network in Jammu and Kashmir and PoK.

Three-year-old Veer Singh was killed and six of his family members, including a woman, injured in a grenade attack by terrorists on the house of a BJP functionary at Khandli chowk in Rajouri on August 13, 2021.

The accused were chargesheeted under relevant sections of the Indian Penal Code, Explosive Act and Unlawful Activities (Prevention) Act, the official said.

Shah and his Kashmiri associate Faisal Ahmad Dar of Puhwama were overpowered by the villagers of remote Tukson Dhok in Reasi district in July last year and later handed over to police.

Two AK assault rifles, a pistol, seven grenades and a large quantity of ammunition were recovered from them.

On December 30, Jammu and Kashmir State Investigation Agency had filed a chargesheet against Shah, Qasim and two other LeT operatives in another case related to smuggling of arms and explosives by drones and recruitment of youth in the prescribed outfit to revive the terror ecosystem in different districts of Jammu region.

## Political parties slam...

out peaceful marches in various parts of the Union territory.

Coming down heavily on the administration, PDP chief Mehbooba Mufti said laws are made to "disempower", "humiliate" and "punish" people in Jammu and Kashmir:

In a circular issued on January 9, Commissioner Secretary of the Revenue Department, Vijay Kumar Bidhuri, directed all Deputy Commissioners to ensure 100 per cent removal of encroachments from state land, including Roshni and Kaheharai, by the end of January.

"Who stops u from going after the rich powerful elite. The elites till now r getting away with mere threatenings. The humbler structures of the poor r abodes borne out of necessities. These structures house families, aspirations, dreams, ambitions, emotions, memories," Peoples Conference President Sajad Lone said in a tweet.

Mufti claimed the government was keeping people in Jammu and Kashmir busy with issues of their survival so that they cannot fight the onslaught on their identity.

"Laws are created for the welfare of public, but in J&K they are weaponised to disempower; humiliate & punish. This latest diktat was issued because despite GOI misusing all the agencies at its disposal & unleashing draconian laws, aren't getting the desired results," she said in a series of tweets.

"The collective punishment and humiliation is this government's way of keeping people of J&K on tenterhooks & fighting for mere survival so that they don't have the energy to fight the onslaught against their identity," she added.

**Activists of the Democratic Azad Party (DAP), Congress and the Peoples Democratic Party (PDP) held separate protests here on the issue.**

**Hundreds of leaders and workers of DAP led by its vice chairman G M Saroori took out a peaceful march from Panama Chowk to the office of Divisional Commissioner, Jammu against the "process of evicting people from the lands which have been under their possession for generations".**

They also submitted a memorandum to the Divisional Commissioner, seeking immediate revocation of the order.

"The land under Roshni act was allotted to people through the legislature of erstwhile Jammu and Kashmir state. It is unfortunate now those who were benefitted from the scheme are forced to vacate the land, despite the matter is sub judice before the High Court & Supreme Court. He further said that the government cannot force the eviction of the people who have legally obtained the ownership of land. where shall they go in these harsh winters," Saroori said.

Saroori said that when Ghulam Nabi Azad was the Chief Minister of Jammu and Kashmir he allotted the land to landless and homeless to empower them economically but the present dispensation seems hell bent to disempower people after snatching their resources.

Provincial President Jugal Kishore said "DAP stands with the people who are being victimized with this executive order. We will not accept it. Only the elected governments can decide the fate of people."

He said the agenda of DAP is to empower the local people and we will continue our fight to seek the restoration of statehood, secure jobs and land rights. "We are not going to watch the sufferings of our people silently. We will raise the voice for them," he added.

DAP chairman Ghulam Nabi Azad had recently termed the order as "unfortunate" and said he had provided land under the Roshni scheme as chief minister to the poor; needy and landless for building houses and cultivation, but now the prevailing regime is snatching it back, that too, in harsh weather conditions.

He had said the people of Jammu and Kashmir were the first beneficiaries of its resources.

"The LG administration is working against downtrodden and marginalized people of Jammu and Kashmir, which is intolerable. We demand roll back of this unjust land notification. It seems that BJP controlled administration is planning escape route for big sharks involved in land mafia business by uprooting poor and landless people" Shah Nawaz

said while addressing media after protest.

He further said that LG administration should frame fair and rational policy to save small and marginal farmers , poor people from getting uprooted after this irrational and illogical land notification.

Congress party will start strong agitation if BJP controlled apparatus will not withdraw this unjust and irrational land notification.

Congress leader Jatinder Chib, IYC Secretary Ajaz Choudhary, JKPC Social Media Chairperson Bilal Rashid, Happy Randhawa, Ajay Lakhotra and other senior leaders were also present.

The Jammu and Kashmir State Lands (Vesting of Ownership to Occupants) Act was enacted in 2001 with the twin objective of generating resources for financing power projects and conferment of proprietary rights to occupants of state land.

The Act, popularly known as Roshni scheme, initially envisaged conferment of proprietary rights of around 20.55 lakh Kanals (1,02,750 hectares) to the occupants of which only 15.85 per cent land was approved for vesting of ownership rights. The scheme was finally repealed by the then governor Satya Pal Malik on November 28, 2018.

The Jammu and Kashmir High Court had on October 9, 2020 declared the Act "illegal, unconstitutional and unsustainable", and ordered a CBI probe into the allotment of land under this law.

**CPI(M) leader M Y Tarigami also voiced his deep concern over the government's move of divesting people of the land registered under various titles in revenue records and demanded immediate withdrawal of the order:**

Calling the move "administration-sponsored land grab", he appealed to all shades of public opinion to unitedly raise the voice against such steps of the administration.

## Gandhi Nagar robbery

Sharma and Advocate Sahib Aggarwal (complainant), present in person, observed that as robbed money is yet to be recovered and many other accused persons involved in robbery are yet to be nabbed by the SIT, mere factum of accused being in judicial custody can't entitle him to seek bail especially when accused is involved in such a serious crime. "Indisputably, the applicant, at present, is in judicial lockup but it doesn't mean that the investigation of the case is complete.

Prima facia, it appears that in case the accused is enlarged on bail, there is every apprehension that he may temper with evidence and may also come in contact with absconding accused persons and may then hamper the investigation of the case. Moreover; while deciding the plea of the accused for bail, the antecedents of the accused can't be ignored. Police report has shown that instant case is not the only case registered against accused but, as per the record submitted by SIT, accused Raja Singh, son of Sardar Gurdev Singh. resident of Hoshiarpur; at present Patiala City, is also involved in three more FIRs registered in Dasua, Hoshiarpur (Punjab), which clearly indicate that accused Raja Singh is not a first-time offender," the Court observed. "In view of facts and circumstances, the Court is of the considered view that a strong prima facia has been made out against applicant/accused. Offences allegedly to have been committed by the accused are very serious in nature and are considered as menace and threat to the society. Personal liberty of the accused is without any doubt his constitutional guarantee but the same can be refused in accordance with the procedure established by law and is required to be balanced with the impact of the offence upon the society. Therefore, prayer of the applicant for grant of bail is rejected and application is hereby dismissed. It is made clear that any observation made hereinabove are strictly for the disposal of the instant application only and shall not be construed an expression of opinion while deciding the main case as and when filed," the Court directed.

As per the details of the case, Police report revealed that on 07.12.2022 at 7 am, ten armed persons, wearing upper jersey and caps of J&K Police, entered house of complainant and held him as well as his wife, parents, 2 domestic helps and driver as hostages on gun point and left house at 12.30 PM after settling extortion money @ Rs 12 to 15 lakh. During investigation of the case, five accused persons, including applicant, were arrested. At the time, when the police was effecting the arrest of the mastermind of the case namely Harpreet Singh, fired on police party. On disclosure of accused Harpreet Singh, 4 pistols, 6 magazines, 57 live rounds, 3 handcuffs, Rs 4,25,000 cash, 6 upper jersey with logo of J&K Police, 10 police caps with logo of J&K Police, 2 face-masks, 1 notebook, 8 tapes, one pair hand gloves, one black coloured trouser and a pair of black formal shoes were recovered. The SIT found that the main conspirator namely accused Harjeet Singh had planned six different incidents of dacoity, kidnapping and target killing and for accomplishing the plans, had contacted applicant as well as other gangsters of Punjab. For successful execution of Dacoity, the applicant had visited Jammu on two different occasions with mastermind Harpreet and also received Rs 14,000 in this regard. The applicant was also in touch with the other accused Manjeet Singh, who was directly reporting to accused Harpreet Singh. Plan for executing instant robbery was hatched at the residence of accused Harpreet in Jammu and it was decided that each of associates including applicant would receive Rs 5 lakh after robbery. Thereafter, the applicant returned back to Punjab but refused to come back to Jammu for executing robbery as he had some family issues but agreed to provide safe hideouts for absconding accused persons. Through its supplementary report, the SIT has submitted that as per CDR details, more than 100 phone calls have been exchanged between the applicant and accused Manjeet Singh @ Raaji while frequency of these calls increased manifold between 05.11.2022 to 15.11.2022, during the period when applicant visited Jammu to conduct recee and finalize robbery plan. It suggests the nature and gravity of circumstances in which the offences have been committed. Offence punishable under section 395 of IPC is punishable with imprisonment for life or rigorous imprisonment for 10 years and fine, and offence is triable by Court of Sessions, thus is very serious in nature.

Pertinently, the occurrence involved in this case is first of its kind and has never been heard in past in Jammu. It has taken place in the heart of the city that too in broad daylight. Moreover; complainant is a practicing Advocate and area where the dacoity has been executed is nearby a high-security zone and considered as one of the safest areas of Jammu. Few of the members of this gang hail from Punjab and are still evading their arrests. As recoveries in the instant case have been affected from Jammu as well as from Punjab and thus it appears to be an inter-state gang, which uses weapons and have criminal background. The involvement of this gang is possible in other high profile murder cases also. The CDR reports, tower locations of the applicant and disclosure of other accused persons especially accused Manjeet @ Raaji, detailing the involvement of the applicant in the crime in minute details, prima facia establishes a case against applicant. Therefore, the arguments of the Counsel for the applicant that the exchange of almost 100 calls, that too prior to the commission of the crime, between applicant and accused Manjeet @ Raaji against whom almost 20 criminal cases have been registered, is no evidence against applicant, are not sustainable. It was also disclosed by police that applicant is one of the main conspirators and has played his role prior to the actual occurrence as well as in conducting recee the house and had also ensured safe hideouts for accused who executed the main robbery.

## Ensure party doesn't,,

then in Telangana in 2023.

The ruling party has been putting in place a number of exercises to strengthen its organisation to ensure that it comes back to power in 2024 at the Centre for a third term. In his nearly 45-minute closed-door address, Nadra highlighted the representation to Other Backward Classes, Scheduled Castes and Scheduled Tribes in the BJP governments in states and the Centre, besides in constitutional positions like governor: He noted that in President Droupadi Murmu, India has got its first tribal person at the top constitutional post.

"The party is getting votes of the backward classes, SCs and STs and is giving them representation. This shows our resolve of Sabka Saath, Sabka Vikas, and Sabka Prayas," he said, stressing on the expanding voter base of the party in the last several years since Modi led it to victory in 2014 and then in 2019.

Nadra lauded India's progress under the Modi government.

It has become the world's fifth-largest economy, second-largest manufacturer of mobile phones, third-largest manufacturer in the auto sector while the length of highway being built every day has risen to 37 km from 12 km earlier; the party president said. The country has also worked to empower the poor with a number of welfare schemes, including distribution of free grains, he added.

Nadra praised the party's win in the recent Gujarat assembly polls as "extraordinary and historic", saying winning more than 150 seats in the 182-member assembly is a great achievement.

While the party lost in Himachal Pradesh to the Congress, the vote gap between the two parties was less than one per cent, he said.

He called upon state units and other leaders to emulate the Gujarat state unit and Modi's untiring efforts to strengthen the organisation.

He said India has made rapid strides to fulfil the 'panch pran' (five pledges), including freedom from every trace of slavery and feeling proud of the country's heritage, voiced by the prime minister in his Independence Day speech.

While the Ram temple construction is in full swing, the government has also worked to rejuvenate India's rich cultural and religious traditions. India's success in Covid vaccination campaign received applaud globally, he said.

The party has also been working to strengthen itself and reached out to 1.3 lakh booths against the target of 72,000, which it had identified to boost its presence, he said.

The party will also commemorate the 200th birth anniversary of social reformer and Arya Samaj founder Dayananda Saraswati in a big way, he said, asserting Modi has worked following his ideals to empower the most deprived people in society.

## EC holds consultation...

the meet. Representatives of all eight national parties attended the consultation.

The parties agreed with broad objectives of every effort to include non-voting electors in the election process in the stakeholder consultations on electoral issues which was held after a gap of five years. They also suggested more such discussions on a regular basis in future.

On the request of the parties, the poll panel extended the date of submission of written views by them on various issues on RVM to February 28. The earlier date was January 31.

Representatives from political parties later said the EC assured that it would move ahead with remote voting only after a consensus emerges between the stakeholders.

"No opposition party wants to see the demonstration of a remote voting machine (RVM). First the issue of the need to have such a machine should be settled," senior Congress leader Digvijaya Singh told reporters after participating in a meeting of political parties convened by the poll body to demonstrate the working of an RVM.

The former Madhya Pradesh chief minister said he felt that there would be no RVM demonstration till there is a consensus on having one. No political party is prepared to see the demonstration, he said.

"The idea of RVM is not acceptable," Singh said, adding that the commission should address concerns about electronic voting machines raised by eminent citizens of the country.

The EC should also address the issue of urban apathy towards the election process, the Congress leader said.

Aam Aadmi Party leader Sanjay Singh too questioned the need for an RVM, saying there were other ways to increase participation of voters.

"How will we campaign in different states among eligible migrant voters using RVM? When there is a bypoll on one seat, say Jalandhar; how will smaller parties campaign in various states among eligible migrant voters who may be located in different states ... RVM is not acceptable," he added.

The poll panel had invited representatives of eight national and 57 recognised state parties for an RVM demonstration here.

The commission has maintained that RVMs, developed by the public sector undertaking Electronics Corporation of India, will be a standalone device not connected to the internet in any way.

The initiative, if implemented, can lead to a "social transformation" for migrants, the EC had said last month.

Each machine can handle up to 72 constituencies, allowing migrant voters to cast their votes from a remote polling booth.

In a letter to political parties last month, EC had said that domestic migrant/ internal migrant does not form a uniquely identifiable and countable class in the existing norms and standard definition.

"There is no central database available for migration within the country for the purpose as required for the matter under discussion (remote voting). The Registrar General of India, the Ministry of Labour and Employment and National Sample Survey Organisation lay different meanings to the term 'migrant'," it said.

"In the existing multiple meanings of 'migrant', periodicity and purpose of 'absence from the place of origin lacks clarity. As per Census 2011, 45.36 Crore Indians (37 per cent) in India are migrants i.e., now settled in a place different from their previous residence, however; 75 per cent of such migrations are on account of marriages and family related reasons," the letter said.

"It is also to be noted that internal out migration is predominant among the rural population and it is mostly intra-state (approximately 85 per cent)," it said.

of Jammu and Kashmir have been denied their right to vote for so many years now," PDP chief spokesperson Suhail Bukhari, who attended the EC meeting on remote voting in Delhi, told PTI over phone.

He said the Chief Election Commissioner; while taking note of the matter; said the polls will be held as soon as the weather and security situation in Jammu and Kashmir get better.

Bukhari said earlier the "excuse" for not holding assembly elections in Jammu and Kashmir was the process of delimitation of constituencies and updating electoral rolls. "All the processes have been completed now. The only excuse left for not holding polls is that they don't want to," he claimed.

National Conference treasurer Shammy Oberoi, who represented his party in the meet, also raised the issue of uncertainty surrounding the assembly elections in the Union territory. "@oberoi\_shammi while speaking on the issue said that when the government is concerned about facilitating domestic migrants to exercise their voting rights, the 1.4 crore people of J&K continue to remain deprived of exercising their democratic rights," National Conference tweeted on its official handle.

country and also internationally that nationalist forces in India would never allow J&K to be separated from India in spite of the divisive politics of the Congress party coupled with machinations of Pakistan.

The BJP Yatra at that time, recalled Dr.Jitendra Singh, was vehemently opposed by the ruling Congress Party and its allies who were the vote bank beneficiaries of keeping the integration of J&K with India under question mark. The credit goes to PM Narendra Modi for having abrogated Article 370 and adopting a decisive approach of zero tolerance against terrorism, as a result of which today there is complete mainstreaming of J&K, he said.

At a time like this today, said Dr. Jitendra, Congress party's so-called Bharat Jodo Yatra only betrays their discomfiture with normalcy having returned to J&K because Congress and its allies have developed a vested interest in the continuation of terrorism and unrest so that the voting percentage is low and they continue to thrive by getting elected, generation after generation, to sustain their dynasty rule.

He said, in the garb of Bharat Jodo Yatra, Congress is actually trying to create an element of division or "Bharat Todho" in J&K for its vested political interest.

Dr. Singh recalled that in 1952, the Delhi Agreement by the Nehru Government had institutionalised separatism and lack of full integration of J&K with India and today Nehru's great grandson is trying to revive a similar sentiment in a bid to seek his political revival. The Congress and its allies, during their rule, tactically supported terrorism, separatism, nepotism and corruption while economic development came to a standstill, said Dr. Jitendra and gave credit to PM Modi for having brought J&K back on the track. The stakes are too high and therefore, ill-conceived or mischievous misadventures of Rahul Gandhi and his colleagues can no longer be afforded. Dr. Jitendra Singh expressed confidence that the common man walking in the streets of Srinagar wants to be a part of the India journey led by PM Modi and after having come out of a nightmare of three decades he is not ready to be thrown back into the same mayhem of violence and destruction.

Time will vindicate, said Dr.Jitendra Singh, that the Congress Party's Bharat Jodo Yatra will meet its Waterloo in J&K and end up in "Congress Todho" by further disintegrating and finishing off the last remnants of this outlived dynastic vestige.

## Jammu-Srinagar highway...

to dry weather; the officials said.

Srinagar recorded a low of minus 1.9 degrees Celsius on Sunday night -- down from minus 0.6 degrees Celsius the night before, they said.

Qazigund, the gateway to the Valley, registered a drop of almost five degrees in the minimum temperature which settled at minus 5.6 degrees Celsius.

Kokernag in south Kashmir recorded a low of minus 6.6 degrees Celsius, compared to minus 1.4 degrees Celsius on the previous night.

The minimum in Kupwara, a frontier district, settled at minus 2.9 degrees Celsius, the officials said. Pahalgam in Anantnag district, which also serves as a base camp for the annual Amarnath Yatra, registered a low of minus 10.2 degrees Celsius.

The minimum temperature at the famous ski-resort of Gulmarg in Baramulla district went down from the previous night's minus 10.4 degrees Celsius to settle at minus 12 degrees Celsius. The resort was the coldest recorded place in Jammu and Kashmir.

The meteorological office said the weather will remain mainly dry across J-K till January 18. There will be a further decrease in the night temperature till that time.

It said, a few western disturbances are likely to affect J-K from January 19 to 25.

The weather will remain cloudy from January 19-21 with chances of light rain/snow over isolated to scattered places mainly over higher reaches.
