Advisor Bhatnagar chairs 63rd BoDs meet of JKHPMC

JAMMU: Advisor to
Lieutenant Governor, Rajeev
Rai Bhatnagar on Tuesday
chaired the 63rd Board of
Directors (BoDs) meeting of
Jammu and Kashmir
Horticultural Produce
Marketing and Processing
Corporation (JKHPMC) at
Civil Secretariat here.

The meeting was attended by Additional Chief Secretary, Agriculture Production Department, Atal Dulloo; Secretary Planning Development and Monitoring; Department, Raghav Langar; Managing Director, JKHPMC, Shafat Sultan; Director General Codes, Director Horticulture Jammu/Kashmir; Director Agriculture Kashmir, representatives of SFAC, NHB, SKUAST (K/J), former Director Agriculture, Kashmir as special invitee and other concerned officers. During the meeting, the BoDs held

detailed deliberations on various development projects of the Corporation both under execution as well as the ones being implemented during the current financial year under apex. MD, JKHPMC while making a presentation on the various post-harvest infrastructure projects undertaken by the Corporation explained that three fruit & vegetable processing units are under execution one each at Dolbagh, Jallipora and Marh Akhmoor. Two CA stores projects one at Behrampora, Baramulla - 5000 MT and one at Mazbug, Sopore - 2500 MT have been finalized. He further informed that the Corporation has established on pack house for onions and potatoes at Narwal, Jammu and work on a 2000 MT Cold Store, at Narwal, Jammu is going on.

Besides JKHPMC has set up three Common Incubation Centres, one each at Doabgah,

Sopore - Apple, Acchabal,
Anantnag - Fish and Narwal,
Jammu - Dairy/Bakery with
Ministry of Food Processing
Industries, GoI's, financial
assistance.

Speaking during the BoDs meeting, Advisor Bhatnagar impressed upon the JKHPMC management that completed projects should be commissioned and outsourced as early as possible so that the stakeholders associated with them stand to benefit.

Advisor advised MD, JKH-PMC to distinctly incorporate key performance indicators and other check & balances as per the tender cum lease documents, while leasing out the facilities to private players, so as to secure the interests of the Corporation. The Board also decided that the products of Corporation could be linked on e-Nam portal so that the products are made available across the country;

Whereas, the Govt. of India through Ministry of Road Transport and Highways (MoRTH) Vide Notification No. S.O 3548 (E) Dated 29-07-2022 under section 3A of national Highways Act, 1956 declared its intention to acquire the land particulars of which are mentioned in the schedule for construction of Double Lane Road with paved shoulders on the Existing Double Lane specification Akhnoor-Poonch NH-144A in village Sangiote Tehsil Mendhar District Poonch.

Whereas, the said Notification issued under Section 3A of Nabonal Highways Act, 1956 was published by Competent Authority Land Acquisition (CALA) in news papers Hind Samachar and Slate Times dated 13-08-2022 for inviting objections from the interested persons within stipulated time frame of 21 days from the date of publication.

Whereas, none of the land owners/interested persons objected before the Competent Authority for Land Acquisition (CALA) within stipulated period of time and accordingly the Govt of India through Ministry of Road Transport and Highways (MoRTH) issued Notification under section 3D of National Highways Act 1956 vide No. S.O 5864 (E) dated 15-12-2022 for an area of 14.4621 Hectare declaring that land specified is to be acquired for aforesaid purpose.

Whereas, the aforesaid Notification u/s 3D bearing No. S.O 5864 (E) dated 15-12-2022 was also published by Competent Authority for Land Acquisition (CALA) in two local dailies viz. State Times and Udaan dated 05-01-2023.
