NOTIFICATION

New Delhi, the 15th December, 2022

S.O. 5865(E).—Whereas by the notification of the Government of India in the Ministry of Shipping, Road Transport and Highways, Department of Road Transport and Highways number S.O. 3840, dated 16.08.2022, S.O. 4849, dated 12.10.2022 published in Gazette of India, Extraordinary, Part II, Section 3, Sub-section (ii) issued under sub-section (1) of section 3A of the National Highways Act, 1956 (48 of 1956) (hereinafter referred to as the said Act), the Central Government declared its intention to acquire the land specified in the Schedule annexed to the said notification for building (widening / Two-laning, etc.), maintenance, management and operation of National Highway no. NH-144A on the stretch of land from Km 162+800 to 198+250 Km. in the district of Jammu, Reasi, Rajouri & Poonch in the State of (UT) Jammu & Kashmir.

And whereas the substance of the said notification has been published in “Dainik Jagran” dated 29 Oct. 2022 and “Panjab Kesari” dated 29 Oct. 2022 and “State Times” dated 03 Nov. 2022 and “Hind Samachar” dated 03 Nov. 2022 under sub-section (3) of section 3A of the said Act;

And whereas no objection has been received from any person by the competent authority;

Or

And whereas objections have been received and the same have been considered and disallowed by the competent authority;

And whereas, in pursuance of sub-section (1) of section 3D of the said Act, the competent authority has submitted its report to the Central Government;

Now, therefore, upon receipt of the said report of the competent authority and in exercise of the powers conferred by sub-section (1) of section 3D of the said Act, the Central Government hereby declares that the land specified in the said Schedule should be acquired for the aforesaid purpose;

And further, in pursuance of sub-section (2) of section 3D of the said Act, the Central Government hereby declares that on publication of this notification in the Official Gazette, the land specified in the said Schedule shall vest absolutely in the Central Government, free from all encumbrances.
