As per order, the committee will be headed by Dr. Ratnakar Sharma, Professor & Head, Surgery as its Chairman while Dr. Rajesh Mahajan, Professor, Anaesthesia, Dr. Farid Hussian, Lecturer, Orthopaedics and Senior Spine Surgeon and Dr. Rahil Naqvi, Lecturer, Surgery will be its Members.

"The team shall assess the patients of the recent terrorist incident admitted in GMC, Rajouri and take necessary decisions about their management including shifting them to GMC, Jammu," it added.

2,000 by June this year. "Till now, 600 flats are completed at Vessu (Kulgam) and Sheihkpura (Budgam) area. Prefabricated huts have been provided at Natnusa and Veerwan in Baramulla. By March 2023, nearly 500 flats will be completed and in June 2023, we are expecting the completion of 2,000 flats," the divisional commissioner added. Even as the administration asserts that the employees from the community have nothing to fear in the Valley, political parties maintain that a sense of security among the minority community members was as important as physical security.

"It is not about one-room or two-room apartments. The government thinks that providing accommodation will resolve the entire issue about Kashmiri Pandits, but that is not the case.

"The government has to build a sense of security and confidence among the Kashmiri Pandits," PDP spokesman Mohit Bhan said.

He said the Kashmiri Pandit employees came back to the Valley in 2010 to restore the community's essence and culture.

"Unfortunately, since 2019, we have seen incidents of target killings of minorities. When regional parties were governing Jammu and Kashmir, not a single Kashmiri Pandit was harmed during agitations like in 2010 and 2016. Now, they are losing trust in the security establishment," he added.

National Conference spokesman Inran Nabi Dar echoed similar views.

"Primarily, the government has to give the employees a sense of security which it has failed. Otherwise, why are they protesting in Jammu for the past so many days? They are not ready to come back as they do not feel secure enough," he said.

BJP spokesman Altaf Thakur had a different take to offer on the issue.

"The biggest security for the Kashmiri Pandits are the majority Muslims living in the Valley..." he said.

Thakur said security forces are capable enough to fight against terrorists and provide adequate security to the Kashmiri Pandits.

"... The KPs should come back. They should not surrender before the hollow threats of terrorists as the motive of these Pakistan-sponsored ultras is that the Kashmiri Pandits should not come back (to the Valley)," he added.

a dozen-and-a-half suspects, including some women, have been detained for questioning," an official said.

Additional Director General of Police, Jammu zone, Mukesh Singh is monitoring the investigation, which is being conducted by senior officers under the supervision of the Deputy Inspector General of Police, Rajouri-Poonch range, Haseeb Mughal.

"Some vital leads have been found that suggest the presence of terrorists in some villages near Rajouri town," the official said.

Senior Superintendent of Police, Rajouri, Mohammad Aslam confirmed the detention of at least 18 suspects.

"We have received some vital leads and are working on those to crack the case. An operation is on to neutralise the terrorists involved in the attack," the officer said, refusing to divulge any further details.

Meanwhile, an organisation representing the displaced people from Pakistan-occupied Kashmir (PoK) has demanded adequate compensation for the victims' families.

SOS International chairman Rajiv Chuni, who led a delegation to Dhangri on Saturday, paid homage to the victims of the terror attack and slammed the government for failing to protect the families that settled in the village after their exodus from the PoK in 1947.

Reiterating that the government must provide adequate security to the Hindus living in Jammu and Kashmir as well as a cash relief of Rs 1 crore and a job to a member of each victim family, Chuni exhorted the displaced families to remain united for getting justice.

He also appealed to the community to maintain communal harmony at any cost and foil the nefarious designs of the enemies of brotherhood.

were killed and an equal number injured in that incident.

Dalip Singh, a resident of Dhangri, said the latest incident had opened the old wounds and caused a scare among the local populace about the revival of terrorism in the border district. "A number of my close relatives had gone to attend the marriage ceremony and we came to know about the incident only when the victims were being evacuated to hospital while passing in front of our homes as there were no mobile phones in J&K at that time," he said.

He said although all his relatives had escaped unhurt in the attack, people from the minority community suffered a big blow as it was the first such attack on minorities in their close vicinity. Besides the Bal Jarallan, the other major terror attacks targeted against minorities in Rajouri district in the past include killing of seven persons in Swari village in 1997, killing of five persons in Kotedhara in 1998, killing of three persons in Nirojal in 2002, killing of five persons in Patrara in 2003 and killing of five persons in Panglar in 2005. "Now this Dhangri attack has not only given a fresh wound but also created a wave of terror among the minority community," he said.

Sanjay Kumar said the Dhangri incident is a cause for major concern as it signals the revival of terror activities in the district after it was declared terrorism free many years ago.

"The government should take all necessary measures to rebuild the confidence of the people in the security system and track down the attackers to ensure justice to the victims," Kumar said. Senior Superintendent of Police Rajouri, Mohammad Aslam had assured that the terrorists involved in the Dhangri incident would be neutralised soon. He also said various measures have already been taken to tackle the terror threat effectively.

"A massive exercise is underway to strengthen Village Defence Committees in the district for which special camps are going on in different villages. We are examining and servicing the weapons at these camps, while hundreds of VDC members have also been provided with ammunition," the officer said. He said the process of deploying the additional troops in sensitive areas and notorious infiltration routes is also in progress to instill a sense of security among the people.

ARTO issues show cause notice to minibus owner for violating traffic safety rules

SAMBHA: Taking cognizance of gross violation of traffic safety norms by a minibus by resorting to overloading and rash driving, the Motor Vehicle Department Samba has issued a show cause notice to owner of vehicle. As per ARTO Samba, the action was initiated after a video clip was circulated in social media, showing an overloaded vehicle bearing registration number JK21B5245, with passengers hanging and sitting on rooftop in gross violation of MV Act 1988 and CMV Rules 1989. The notice has been issued by ARTO Samba to owner of minibus with stipulation that the reply shall reach the office within a period of three days, failing which Route Permit of minibus will be suspended/ cancelled. Meanwhile, the minibus has also been black-listed in VAHAN portal till explanation/reply is received from owner.

Forest Department team seizes truck loaded with illegal willow cleft bats

FCS&CA seals 82 Mutton shops; imposes 30K fine on 18 erring traders

SRINAGAR: In view of complaints pouring in from various corners regarding over-charging by mutton sellers, Enforcement Squad of Food Civil Supplies and Consumer Affairs (FCS&CA) department sealed 82 mutton shops and imposed a fine of Rs 30000 on 18 erring traders during the preceding week. The erring traders

were taken to task during the special drive launched in various areas of Srinagar City from December 30, 2022 to January 7, 2023.

It is worth mentioning here that during January-2023 in entire valley, an amount of Rs 80,700 has been collected as fine from 269 erring traders for violating EC Act and 59 establishments were sealed. Moreover, the erring lot has been reprimanded to remain careful in future. The drive will continue in the same passion in future as well and whosoever is found violating norms will be booked as per law.
