JAMMU: Sunil Sharma, former minister on Saturday called on Lieutenant Governor Manoj Sinha here at Raj Bhawan. The former Minister apprised the Lt Governor about the welfare issues of Rehbar-e-Khel and Rehbar-e-Janglat appointees, VDC SPOS, National Youth Corps and other issues of public importance. While briefing, Sunil Sharma stressed that VDGs SPOS can serve as the security arch to defend the remote and hilly villages of J&K against terror attacks and strengthening them will increase security of minorities in far flung areas. Sunil Sharma urged that

Meritorious Sports persons of J&K should be appointed under new sports policy S.O 12 at the earliest as it was pending since 2014 and urged LG to address the issues of Rehbar-e-khel, Rehbar-e-Janglat and NYCs. He also demanded Degree College for the Dacca area. The Lt Governor while interacting assured about the early redressal of issues of strengthening of VDGs SPOS, Meritorious Sports persons of J&K and promised to look into other issues of Rehbar-e-khel and Rehbar-e-Janglat for early disposal.

Later, a delegation of J&K Ex-Services League led by its President Lt Gen RK Sharma (Retd.) submitted a memorandum of demands to the Lt Governor pertaining to the welfare of ex-Servicemen. The Lt Governor assured the members of the delegation that all their concerning issues and suggestions would be taken into consideration.

Offline applications are invited from the eligible candidates desirous of seeking admission in PG Diploma in Rehabilitation Psychology (PGDRP)-2022 in Composite Regional Centre, (CRC), Bemina Srinagar, which should reach the J&K BOPEE office Srinagar/Jammu up to 28-01-2023. The selection of the candidates shall be governed by the J&K Board of Professional Entrance Examinations Act, 2002 and the Rules and Regulations there under read with the; JK Reservation Act, 2004 as amended from time to time and the Rules there under as amended vide S.O. 127 of 2020 dated 20-04-2020 followed by S.O. 249 of 2021, dated 23-07-2021.

#### Submission of Application Forms (Offline):

The eligible and interested candidates are required to submit the duly filled in Application Form (in the prescribed format available on the BOPEE website) at the BOPEE offices Srinagar/Jammu from 09-01-2023 to 28.01.2023 (till 4:00 PM) during working days only along-with payment of fee of Rs. 2000/- (Two thousand only) to be made through POS machines installed in the BOPEE offices Srinagar/Jammu. The candidates have to submit the following self-attested certificates along with the Application Form:-

- Domicile Certificate of UT of J&K / Ladakh;
- Qualifying marks certificate; and
- Date of Birth Certificate; and
- Reserved category certificate, if any.

The candidates must bring along original certificates for verification by BOPEE office at the time of submission of the application form.

#### Eligibility :

The Applicant must be a domicile of UT of J&K / Ladakh and must have obtained:-

- Bachelor's Degree (Regular Mode) with General Psychology Courses in all the three years; OR
- Master's Degree in any Branch of Psychology either in Regular Mode or Distance Mode; or Master's Degree in Counselling Psychology either in Regular or Distance Mode with a minimum of 55% marks in aggregate for OM candidates. For SC/ST/OBC (Reserved Categories), minimum of 50% Marks in aggregate is essential. Entry qualification shall be from a UGC recognized university.

#### Selection Process:

The selection for the said course is purely on merit basis and the criteria adopted for preparation of Merit List is as under:

- 90% weightage on pro-rata basis to the marks obtained in qualifying examination viz Bachelor's Degree/Master's Degree in Psychology as the case may be;
- 10 additional points to the candidates possessing Master's Degree in any branch of Psychology in addition to Bachelor's Degree in General Psychology.
- In case of tie, Date of Birth of candidate(s) shall be considered i.e. the candidate older in age shall be preferred first. For further tie, the first alphabet of candidate(s) name shall be considered.

#### Note:

- No under process certificates will be accepted.
- The information in the application forms of the candidate shall in no case be construed as an acceptance of that information/ category certificate by the BOPEE. Therefore, if at any stage, it is found that a candidate has provided false or incorrect information in respect of any eligibility condition, his/her candidature will be cancelled without any further notice to him/her.
- Candidates having "Outstanding Proficiency in Sports" must submit their certificates to Secretary, J&K Sports Council for awarding sports points which will be then officially submitted to the Board by the Sports Council. Board shall not be responsible where a candidate fails to submit sports certificates to the Council or Council fails to forward sports points of a candidate to Board. It shall be sole responsibility of the candidate to ensure that his/her sports points are forwarded by Council to Board. (Candidates belonging to sports category shall be considered on the basis of merit and sports points given by J&K Sports Council) in time.
- The candidates having more than one reserved category certificate can get benefit of only one category indicated in the Application Form which in no case shall be changed afterwards. The candidate, whose category certificate has not been found valid, will be considered in open merit, if found otherwise eligible, without any further notice.
- In case there is no eligible candidate in any category, the seat of that category shall be allotted to Open Merit Candidates strictly in the order of merit
