

Annual Identification of Defence Pensioners on SPARSH portal extends upto Jan 31

JAMMU: In response to the evolving circumstances and to facilitate a smoother process for our esteemed defence pensioners, the Ministry of Defence has decided to extend the deadline for the annual identification of defence pensioners on newly SPARSH portal. The same is applicable for all Defence Pensioners of Jammu, Kashmir and Ladakh also. The original deadline, set for November 30, 2023, has now been

extended to January 31, 2024. This extension aims to ensure that all eligible pensioners have ample time to complete the necessary documentation and provide updated information for the annual identification process. This decision is part of the Ministry's ongoing commitment to streamlining administrative processes and providing the best support to our defence community. We understand the importance of timely and accu-

rate record-keeping, and this extension aims to accommodate any unforeseen challenges pensioners may face in meeting the initial deadline. Pensioners are urged to take advantage of this extended period to complete their annual identification promptly. The Ministry remains dedicated to maintaining transparency and efficiency in pension-related matters, and this extension is a testament to our commitment to the welfare of our defence personnel.

For further details and assistance, pensioners are encouraged to reach out to the designated helpline or visit the official Ministry of Defence website. In J&K, those pensioners whose annual identification has yet not been done, they may visit their nearest SPARSH Seva Kendra or DPDO under PCDA Northern Command for their annual identification. For identification, they must carry their Aadhaar Card, PPO Number, Bank Passbook and Mobile with them.

Voluntarily retired employees of RTC hold protest

JAMMU: Voluntarily retired employees of J&K Road Transport Corporation on Wednesday held protest against the RTC Management and J&K Transport Department authorities for not releasing the pending dues of the VRS given employees. The retired (VRS) employees of the RTC

under the leadership of Dev Raj Bali assembled near Maharaja Hari Singh Park and held protest. They were shouting slogans against the RTC management and also against the J&K Transport authorities. They alleged that they have not been paid their COLA and 6th Pay Commission arrears by the RTC authorities despite the fact that Central

Government has paid an amount of Rs 76.95 crore to them including payment of the arrears of more than 700 employees. Their total DA amount comes out to around Rs 66.24 crores. Bali said that most of them are senior citizens and struggling for their hard earned money for the last more than 8-9 years. But the authorities concerned have failed to pay

their arrears. The officers in J&K administration are only harassing them and adopting delaying tactics. They appealed the Prime Minister Modi to intervene into the matter and provide justice to over 700 VRS given RTC workers of J&K, struggling for the last over eight years for getting their own hard earned money. Over 52 have expired during these years of struggle.
