DODA: The Motor Vehicle Department (MVD) in Doda orchestrated a one-day medical health check-up camp for drivers at the Dak Banglow in Thathri. Whereas, above 28 posts, belonging to Divisional Cadre, Jammu (12 Posts) and Divisional Cadre, Kashmir (16 Posts) were advertised by the Board vide Notification No. 01 of 2021 dated 03.02.2021, under Item Nos. 25 and 63 respectively, for seeking applications from the eligible candidates and the cut-off date i.e. last date for applying for these posts and for purpose of determining the eligibility/academic qualification, validity of category certificates and other such documents of the candidates was **29.03.2021**; and

Whereas, as per the Indent, the qualification prescribed for the said posts of Senior Horticulture Technician in Horticulture Department is **"B.Sc. Horticulture OR B.Sc. Agriculture with Horticulture as major subject."**

Whereas, in terms of the notified Selection criteria, the selection for these posts was to be made on the basis of the Written Examination only and, accordingly, the JKSSB conducted Computer Based Test (CBT) on 07.02.2023 as per Notice No. JKSSB-COE0EXAM(UT)/10/2022-04(CC-7055504) dated 06.01.2023. On the basis of performance of the candidates in the CBT, the Board, vide Notification No. JKSSB-COE0EXAM(UT)/06/2023-04(7110979) dated 28.06.2023, published the Result/Score sheet of the candidates. After the publication of Result/Score Sheet, the preferences were sought from the candidates vide Notification No. JKSSB-COE0EXAM(UT)/48/2023-03(7207093) dated 20.07.2023 and simultaneously, the candidates falling under the consideration zone, were called for Document Verification (DV) vide Notification No. JKSSB-COE0EXAM(UT)/48/2023-03(7207093) dated 20.07.2023 & Supplementary Document Verification vide Notification No. JKSSB-COE0EXAM(UT)/48/2023-03(7207093) dated 09.08.2023; and

Whereas, after the conduct of the Document verification (DV) by the respective DV Committees, both at Srinagar and Jammu, the Board constituted a Selection Committee vide Office Order No. 164-SSB of 2023 dated 28.08.2023 to finalize the selection for these 28 posts of Senior Horticulture Technician, Divisional Cadre, Jammu/Kashmir, advertised vide Notification No. 01 of 2021 dated 03.02.2021, under Item Nos. 25 and 63; and

Whereas, the Selection Committee, constituted for these posts, observed and placed various issues regarding the selection for deliberations in the Board in its 242nd Board meeting, and after decision on the issues so flagged, prepared the Provisional Selection List as per the extant rules governing the subject and placed the same in the Board for approval; and

Whereas, after approval in the Board, in its 247th meeting held on 28.11.2023, the Provisional Selection List for the aforesaid posts of Senior Horticulture Technician, Level 6E; (Item No. 25/Divisional Cadre, Jammu and Item No. 63/Divisional Cadre, Kashmir), as received from the Horticulture Department, was notified vide No. JKSSB-PLAN/27/2023-03 (E-7283041) dated 08.12.2023, wherein one post under ALC/IB category was kept unfilled as no candidate was eligible/fulfilling the benchmark for selection for the said vacancy; and

Whereas, the above Provisional Selection list *inter-alia* provided that any candidate feeling aggrieved with it, shall represent with objections, if any. After due examination and scrutiny of the representations received in response to the notification of the Provisional Selection List, the Selection Committee framed the Final Selection List for these posts of Senior Horticulture Technician, which was subsequently approved in 253rd Board Meeting held on 05.01.2024.

Eligibility

- Anganwadi Helpers**
- The selection of Helper shall be restricted to the electoral ward where Anganwadi Centre is located.
- Women candidates in the age group of 18-37 years shall be eligible.
- The candidate must be domicile of the UT of J&K.
- Minimum qualification for Anganwadi Helper shall be matriculation.
- In case no matriculate candidate available in the ward, candidates with qualification not less than 8th standard shall be considered.
- The committee shall select the most destitute/needly married woman of the ward as helper from amongst those who fulfil the qualification criteria. In case no married candidate is available , unmarried candidate may be considered.
- First and foremost criteria of eligibility amongst married women in case of Sahayikas (Anganwadi Helpers) is the marks obtained in the class 10th. However in rarest of rare cases where selection committee finds a widow headed household with no source of income or a completely destitute lady with zero source of income, in such cases preference may be given if other things are equal, with unmarried candidates selected only if no married candidate is available.

B. In case eligible candidate is available within the family of retiring AWWs, the said candidate shall qualify for additional two percent points.

- Domicile Certificate .
 - 10th Mark Sheet of school education in case of Sahayikas(AWHs).
 - Date of Birth/Matriculation Certificate .
 - Residence/Ward certificate where the vacancy has been verified from concerned BDO.
 - Voter list of concerned ward where post have been available.
 - Un-Married certificate issued by concerned Tehsildar in case of name of the candidate appeared in voter list with her parents.
 - Certificate from concerned Sarpanch in case of candidate belongs to the family of retired AWW.
 - Death Certificate in case of widow/divorcee copy in case of candidate applying for Sahayikas(AWH) for considering most destitute/needly.
 - Affidavit duly attested by Judicial Magistrate/ Executive Magistrate Ist Class as shown in Annexure "B" .

- Document Verification**
- Candidate who is shortlisted for Document verification will be required to appear for Document Verification along-with the original documents as well as self-attested Photostat copy of each document as per the Advertisement Notification. The candidate must be in possession of the prescribed academic qualification and other document like Domicile Certificate, on or before the last date of submission of application form.
