Whereas, the formal land indent has been placed by the Executive Engineer, CPWD, Jammu Division, Jammu vide his office No.20(263)/ जामा/2023/3156 dated 01-11-2023.

Whereas, it appears to the Government of UT of Jammu and Kashmir that the land measuring 27 Kanals 03 Marlas is required for construction of Central Secretariat Building by CPWD, MOHUA Govt. of India situated at village Bansultan Tehsil R.S Pura District Jammu, by the CPWD, Jammu Division, Jammu. In exercise of power vested in me Under Section 11 Sub Section (1) of the Right to Fair Compensation and Transparency in Land Acquisition Rehabilitation and Resettlement Act 2013, I Seema Parihar JKAS, Collector Land Acquisition RS Pura do hereby notify that the land whose particulars are given herein below is required for Construction of Central Secretariat Building by CPWD, MOHUA (Govt. of India) situated at village Bansultan Tehsil R.S Pura District Jammu.

Whereas, the Health and Medical Education Department, vide indent No. HD/Drug/24/2020 dated 25-09-2020 and No. HD/Drug/24/2020 dated 07.01.2021, vide indent No. ME/NG/83/2020 dated 08.03.2021, vide indent No. HD/Coord/64/2020 dated 25.09.2020, vide indent No. HD/Coord/63/2020 dated 25.09.2020, vide indent No. HD/ISM/62/2020 dated 25.09.2020 and No. HD/Coord/64/2020 dated 05-03-2021 and vide indent No. ME/NG/83/2020 dated 28.09.2020, among other posts, forwarded the requisition for making direct recruitment to the 08 posts Social Worker/Medical Social Worker, under item No. 204 as per the following break up:

Whereas, the Jammu and Kashmir Services Selection Board (JKSSB) advertised the aforesaid 08 posts among other posts of Health and Medical Education Department vide Advertisement Notification No. 02 of 2021 dated 26.03.2021; and

Whereas, as per the Notification, the selection to these posts was to be made on the basis of Written Examination only and, accordingly, the JKSSB conducted the Computer Based Test (CBT) for these posts in multiple sessions/slots w.e.f. 17.08.2021 to 25.08.2021 and, thereafter, on the basis of merit obtained by the candidates, the Document Verification was conducted vide Notice No. SSB/CoE/Health/2021/7598-7606 dated 09.11.2021, from 20.11.2021 to 04.12.2021, after JKSSB notified domain wise list of candidates falling in the consideration zone vide No. SSB/CoE/H&ME/2021/7477-84 dated 02.11.2021, both at Jammu and Srinagar by the DV Committees constituted vide Order No. 380-SSB of 2021 dated 17.11.2021 followed by Order No. 386-SSB of 2021 dated 18.11.2021 and Order No. 389-SSB of 2021 dated 18.11.2021. Separate DV committees for the left-out candidates was also constituted vide Order No. 348-SSB of 2021 dated 30.11.2021; and

Whereas, the Selection Committee for preparing the selection to the aforementioned posts was constituted vide Order No.344-SSB of 2021 dated 29.11.2021, which was superseded by a fresh Selection Committee, constituted vide Order No.277-SSB of 2022 dated 8.10.2022; and

Whereas, in response to the communication made by this office vide letter No. JKSSB/71/2022-05 dated 04.01.2023, the indenting department vide their communication No. ME-NG/315/2021-02 dated 25.04.2023 forwarded the letter dated 04.03.2023 received from the Principal, GMC, Srinagar, wherein it was requested to:

**"...withdraw two posts of promotional quota i.e. 01 post under roster point 08-OM (Social Worker) from Item No. 204 and 01 post under roster point 09-EWS (Medical Social Worker) from Item no. 203 respectively from the 09 posts of Psychiatric Social Worker/Social Worker/Medical Social Worker bearing Pay Level-6 (35400-112400) which were referred to Indenting department for filling up through the Board..."**

Whereas, vide a subsequent communication No. ME-NG/315/2023 (CC-89992) dated: 22.11.2023, the indenting department forwarded the copy of letter dated 05.11.2023 received from Principal GMC, Srinagar wherein it was clarified:

**"...that few officials of this institution approached to the Hon'ble Court for promotion to the post of Social Worker under promotional quota and Hon'ble Court Central Administrative Tribunal, Jammu Bench vide order dated: 13.07.2021 passed the following directions' to consider the case of the applicants for promotion against the post of Social Worker in terms of promotional quota and reserve two posts for the applicants for promotion." And accordingly, in terms of this office communication No. AH/Est-II/Mc/2021/4835 dated 08.10.2021, followed by another communication bearing No. AH-9/Est-II/MC/2023/1196 dated**

4.3.2023, administrative department was requested to withdraw one post under Roster point 08-OM (Social Worker) from Item No. 204 and one post under Roster point 01-OM (Psychiatric Social Worker) from item No. 203 from the recruiting agency as both the posts were belonging to promotional quota. However, the directions from the Hon'ble Central Administrative Tribunal, Srinagar Bench order dated 28.02.2023, in OA No 136/2023 (Srinagar) titled *Md. Ishfaq Tantray Vs UT of J&K and Ors* was passed and the matter was re-examined and it was found that out of 14 sanctioned posts, 11 posts were to be filled through direct recruitment (which constitute 75%) and 03 posts were to be filled through promotional quota (which constitute 25%) by virtue of Government Order dated: 19.01.2006.

Now, therefore, in view of the above stated facts, it is requested that all the 09 posts referred vide this office communication No. AH-Est/2020/3098 dated 09.07.2020 are for direct recruitment purpose and to be referred to the recruiting agency. Hence no post is to be withdrawn."

Whereas, the matter pertaining to all the selections of Health and Medical Education Department advertised vide Notification No.02 of 2021, was in the Hon'ble Central Administrative Tribunal against the said selection process in the case of Hiral Ahmad Bhat and others vs UT of J&K and others case, wherein, the Hon'ble CAT Srinagar dubbed TA No. 5646/2021 and TA No. 221/2021, that were disposed of by way of a common order on 15.11.2022 with the following directions:

**"In view of the above discussion, it is clear that the applicants are governed by the rules of 2009 which clearly state that the engagement of applicants was on academic arrangement basis for a period of one-year extendable upto a maximum of six years or till selection is made in accordance with the recruitment rules. The applicants had also executed an agreement/contract with the respondents that they will not claim for regularization of their services. The respondents were well within their jurisdiction and competence to issue the advertisement notification 02 of 2021 dated 26.03.2021.**

With these observations, TA 5646/2021 and TA 221/2021 along with all the MAs are dismissed. All the interim orders stand vacated. The respondents are at liberty to proceed further to complete the process of selection and appointment of candidates as per advertisement notification No.02 of 2021 dated 26.03.2021. No order as to costs"

Whereas, the petitioners, aggrieved of the final order of Hon'ble CAT Srinagar, mentioned above, approached the Hon'ble High Court of J&K and Ladakh, wherein the Hon'ble High Court of Jammu & Kashmir and Ladakh at Srinagar in WP(C) No. 2682/2022, while pronouncing its Judgement on 31.01.2023, upheld the decision of the Hon'ble Central Administrative Tribunal, Srinagar Bench and maintained that:

**"In view of the above and having regard to clear position of law enunciated by the Supreme Court in Uma Devi (3), we fully concur with the view taken by the CAT, Srinagar Bench. We find no merit in these petitions and the same are, accordingly, dismissed. The interim directions, if any, shall stand vacated. The respondents are free to conclude the selection process initiated vide advertisement Notice No. 02 of 2021"**

Whereas, after receiving the aforementioned directions from the Hon'ble High Court of Jammu & Kashmir and Ladakh on 31.01.2023 and the clarification from the indenting department dated 22.11.2023, the selection committee started preparing the provisional selection list; and

Whereas, keeping in view the afore-stated facts, directions and clarification, the Provisional Selection list so prepared, was placed before the Board in its 253<sup>rd</sup> Meeting held on 05 Jan, 2024, which, after due deliberations, approved the same for its notification.

**Now, therefore:**

- The Provisional Selection List for the 8 posts of Social Worker/Medical Social Worker, Divisional Cadre, Kashmir, under Item No. 204, of Health and Medical Education Department, advertised vide Advertisement Notification No.02 of 2021 dated 26.03.2021, is hereby notified as Annexure-A to this Notification.
- The Provisional Selection List shall be subject to the outcome of writ petition(s)/OAs, if any, pending in any Court of Law of the competent jurisdiction.
- The List shall also be subject to the outcome of pending inquiry, if any, involving candidate(s), figuring in this Selection List.
- The List is provisional only, and mere figuring in the aforementioned list shall not confer any right on the candidates for final selection.
- Formal recommendations to the concerned Indenting Department shall be made separately after the Notification of the Final Selection List.
