Whereas, you are working as Extension Educator in the Department of Family Welfare, MCH & Immunization, J&K Division cadre Kashmir and presently posted at Emergency Hospital Qazigund District Kulgam; and

Whereas, as reported by Dy. Chief Medical Officer Kulgam, vide letter No. Est/Dy.CMO/K/251-55 dated 11.12.2023, you have remained un-authorized absent from duties w.e.f. 21.09.2023 without any intimation/reason; and

Whereas, you have applied for 18(eighteen) days Earned leave w.e.f. 03.10.2023 to 20.10.2023 through e-mail, in connection with illness of father and the same was remained un-sanctioned by, Dy. Chief Medical Officer Kulgam (competent authority) for want of Medical certificate; and

Whereas, after expiry of leave you were supposed to resume your legitimate duties at Emergency Hospital Qazigund District Kulgam on 21.10.2023, but remained un-authorized from duties w.e.f. 21.10.2023; and

Whereas, a show cause notice was served to you by the Dy. Chief Medical Officer Kulgam vide letter No. DYCMOK/227-29 dated 10.11.2023 to resume your duties forthwith without any further delay and explain your position for remaining absent from duties from 21.10.2023, failing which action under rules shall be initiated against your under J&K Civil Services Rules; and

Whereas, in response to Show cause notice served to you by, Dy. Chief Medical Officer Kulgam you have joined Emergency Hospital Qazigund Kulgam on 28.11.2023 and left the station on very next day without proper permission of the authority, as reported by Medical Superintendent Emergency Hospital Qazigund vide letter No. Est/MS/EHQ/982-83 dated 09.12.2023 and you have applied for another spell of 45 days earned leave w.e.f. 29.11.2023 to 11.01.2023 through e-mail, which has not been sanctioned by the competent authority with the pretext to resume your duties; and

whereas, it has been observed that you are habitual for remaining un-authorized absent from duty which is violation of Service Conduct Rules and invites disciplinary action in terms of Article 128 of J&K CSR,1956; and

Whereas continued absence from duties by a Government servant attracts action and tantamount to loss of service as warranted in terms of Article 128 of J&K Civil Services Rules, 1956, which reveals as under :-

**Article 128**  
"Absence without leave or after end of leave involves loss of appointment".

Now in view of above, you are hereby given last and final opportunity/chance to resume your duties within a weeks time from the date of issuance of this notice failing which, it will be presumed that you are not interesting to serve the department and deserve for disciplinary action in terms of Article 128 of J&K Civil Services Rules, 1956 for remaining on un-authorized absent from duties willfully.
