PUBLIC NOTICE

It has come to the notice during the course of checking in District Samba that persons serving as Conductors in Stage Carriages i.e. buses and mini buses are not having Conductor Licenses, which is mandatory for serving as Conductor of stage carriages.

Further, as per Section 29 of C.M.V. Act, 1988, no person shall act as a conductor of stage carriage unless he holds an effective conductor's licence issued to him authorising him to act as such conductor; and no person shall employ or permit any person who is not so licensed to act as a conductor of a stage carriage.

As such through the medium of this notice all the owners of stage carriages (buses and mini buses) are directed not to employ any person as conductor till he has a valid conductor licence issued by concerned Licensing Authority. Besides, action as per the provisions of M.V. Act/Rules shall be taken if any person is found serving as conductor of stage carriage without conductor licence.

Public Notice

It has been observed that various business/ commercial activities have come up within the limits of Jammu Municipal Corporation without seeking any prior permission from the Corporation as envisaged in the section (323), (324) & (328) of Municipal Corporation Act, 2000.

In terms of section 323 of J&K Municipal Corporation Act, 2000, it is provided as under:
"(1) No person shall, without the previous permission in writing of the Commissioner establish in any premises, or materially alter, enlarge or extend, any factory, workshop or trade premises in which it is intended to employ steam, electricity, water or other mechanical power.
(2) The Commissioner may refuse to give such permission, if he is of opinion that the establishment, alteration, enlargement or extension of such factory, workshop or trade premises, in the proposed position would be objectionable by reason of the density of the population in the neighbourhood thereof, or a nuisance to the inhabitants of the neighbourhood."

In terms of section 324 of J&K Municipal Corporation Act, 2000, it is provided as under:
"(1) No person shall use or permit to be used any premises for any of the following purposes without or otherwise than in conformity with the terms of a licence issued by the Commissioner in this behalf, namely:-
(a) any of the purpose specified in Part-I of the Schedule-I;
(b) any purpose which is, in the opinion of the Commissioner dangerous to life, health or property or likely to create a nuisance;
(c) Keeping horses, cattle or other quadruped animals or birds for transportation, sale or hire or for the sale of produce thereof; or
(d) Storing any of the articles specified in Part-II of the Schedule-I except for domestic use of those articles;"

In terms of section 328 of J&K Municipal Corporation Act, 2000, it is provided as under:
"(1) No person shall, without or otherwise than in conformity with the terms of a licence granted by the Commissioner in this behalf, keep any eating house, lodging house, hotel, boarding house, tea shop, coffee house, cafe, restaurant, refreshment room or any place where the public are admitted for repose or for the consumption of any food or drink or any place where food is sold or prepared for sale.
(2) The Commissioner may at any time cancel or suspend any licence granted under sub-section(1) if he is of opinion that the premises covered thereby are not kept in conformity with the conditions of such licence or with the provisions of any bye-laws made in this behalf."

In exercise of the powers vested under section 43 & 44 of the Municipal Corporation Act 2000, it is hereby directed as under:

- That restrictions are in place for starting/running any commercial activities without permission from JMC.
- These commercial/business establishments / shops who have not taken permission/NOC by any reason, are directed to seek permission from the Jammu Municipal Corporation within a period of two months from the issuance of this notice by applying through <https://jansugam.jk.gov.in/>.
- Those establishments who have taken licence / NOC which stands expired now, are directed to get it renewed within 30 days by applying through <https://jansugam.jk.gov.in/>.

Further all Govt. Departments entering into any agreement for supply of services or issuance of licence to shops/establishments are advised to ensure that prior NOC is obtained by the said shop/establishment from Jammu Municipal Corporation as provided above.

Failure to comply the instructions shall invite action under provisions of J&K Municipal Corporation Act, 2000 against the premises owner.
