ABVP CUJ unit submits memorandum to VC, demands to reduce fee in campus

JAMMU: Akhil Bharatiya Vidyarthi Parishad (ABVP) Central University of Jammu unit submits a memorandum to the Vice Chancellor of the University, Prof. Sanjeev Jain regarding the increase in fees in the University.

ABVP CU Jammu unit President, Prabhakar Bhardwaj said that the course fee is being increased every year by the university administration, since most of the students in the university belong to poor and lower middle class families, and also a large number of them from different states are coming to study here.

Due to continuous fee hike, there is more burden on the students, due to which they are forced to leave the education.

Unit Secretary Shagun Sharma said that the university is also increasing the hostel fees from three consecutive years. In the year 2021-22, the hostel fee was Rs 5,000 per semester; in the year 2022-23 the hostel fee

was increased to Rs 9,000 per semester and in the last year 2023-24 the hostel fee was increased to Rs 12,000 per semester.

ABVP demanded that there should be no increase in course and hostel fees this year and the previous fee increase should also be reduced so that all students can get quality education at easy, accessible and reasonable fees.

Prabhakar said, ABVP hopes that university administration will take appropriate action as soon as possible keeping in mind the interests of the students, otherwise the ABVP will start an agitation in the university in the coming days for the genuine demands of the students.

The Vice Chancellor of the University has assured that the decisions taken regarding fee increase will be considered keeping in view the interest of the students.

IGNOU extends last date for re-registration for January 2024 session

JAMMU: Indira Gandhi National Open University (IGNOU) has extended the last date for re-registration for the January 2024 session till 15th of February, 2024. The last date was 29th January, 2024 earlier.

To enroll in the next year or semester, learners need to fill and submit the IGNOU re-registration January 2024 form by the extended submission deadline which is now 15.02.2024.

The learners who did not attempt the term-end examinations or did not submit their assignment can still apply for

re-registration for January 2024 provided the minimum programme duration is achieved and programme validity has not expired.

The learners can apply for IGNOU re-registration January 2024 by visiting the official website of the IGNOU www.ignou.ac.in. The direct link for online re-registration is https://onlinereg.ignou.ac.in/ which can be accessed under the drop-down menu option "Register Online">>Re-registration" on IGNOU website front page. In case any learner has forgotten his/her User ID or password or has changed the registered mobile number at

later stages and is not able to log in to re-register, he/she must approach the Regional Centre or drop a mail on rcjammu@ignou.ac.in with the request to reset the password. In case online payment made by any learner does not get updated, do not make the second payment immediately. Learners must wait for a day, check the payment status and then decide further course of action. Learners are advised not to wait for the last date for submission of re-registration form since the servers get heavily overloaded towards the last date of online submission due to huge rush.

In a press statement, Regional Director Dr. Jai Prakash Verma informed that learners must exercise due caution in making online transactions and as far as possible must use their own card/net banking to make payment and

in case the learners are using third-party services (cybercafe or some other outlet) for submission of re-registration form, they must ensure that the courses have been correctly chosen and payment of programme fee has been made successfully.

Dr. Jai Prakash Verma also informed that IGNOU and the Institute of Cost Accountants of India (ICMAI) have jointly developed Diploma in Agricultural Cost Management (DACM) programme which would be on offer from the ongoing January 2024 admission cycle. "The programme would pave the way for hands-on experience for the learners in Basics of Agriculture, Institutional Support for Agricultural Development, Cost Concepts and Techniques, Farm Cost Management, etc", Regional Director informed.

Secretary, while addressing the meeting, exhorted upon all the officers to put in best efforts ensuring that the purpose of facilitating the public with affordable and accessible means of transportation is met. He emphasized the need of creating huge awareness regarding availability of this service so that maximum people could get benefitted. During the meeting, the issue of explore possibilities for making these subsidized air services operational throughout the year was also discussed.

Stressing on making this air service more convenient and accessible for the public, the Secretary directed for making the booking online platform in addition to the offline option. He also sought suggestions from the concerned officers and

service provider companies regarding further streamlining of this crucial service for the public. Responding to issue of payments of Aryan Aviation Limited Kashmir and Global Vectra Jammu, the Secretary issued directions to the concerned for releasing the

reimbursement at the earliest so that the subsidized air services are not affected on this account. Earlier, Additional Secretary, CAD, Veedushi Kapoor, briefed the meeting about the present status of subsidized helicopter services being provided in various areas like Doda, Kishtwar, Poonch, Rajouri, Bandipora and Kupwara. She informed that about 5444 passengers have availed this vital facility from December 2022 to April 2023.

Meanwhile, Nodal Officers for Subsidized Helicopter Service Doda, Rajouri, Poonch, Jammu, Srinagar, Bandipora and Kupwara apprised the Secretary of various issues concerning their respective jurisdictions.
