Whereas, it was stipulated in the said notice that failing to submit the E-Mail ID and contact number within 07 days, it shall be presumed that the candidate is not willing to take up his / her appointment as "Library Assistant" in the Higher Education Department, and he/she shall forfeit the right of appointment without any further notice;
