No claim on any post till completion of recruitment process: DB

STATE TIMES NEWS JAMMU: A Division Bench of Jammu & Kashmir and Ladakh High Court Comprising Chief Justice N Kotiswar Singh and Justice Rajesh Sekhri holds that under our service jurisprudence, there is no concept of year wise vacancy unlike in the case of posts to be filled up by promotion. In case of direct recruitment, no one has a vested right to claim to be considered against any particular advertised post till the recruitment process is undertaken and completed. If the recruitment process for the advertised posts is not initiated or completed for any reason and if new posts are further advertised, all the persons who would have become eligible by then, will be also entitled to apply for the posts advertised earlier also. In other words, no direct recruitment posts could be kept reserved for a particular group of candidates. It must be made open to all those persons who become eligible when the posts are advertised. Thus, all the can-

didates who had applied under the advertisement issued in 2008 and were eligible for the posts of Naib Tehsildar would be entitled to be considered for all the posts advertised earlier in 2002 and 2005 as these posts could not have been reserved only for those who had applied in 2002 or 2005 as the case may

DB further observed that the position is different when it related to appointment by promotion when the concept of year wise vacancy comes into play. Under the promotional scheme, only those who become eligible when the vacancy under the promotion quota arises can be considered and if for any reason the selection for the promotion could not be held, it can be held in a subsequent year, but it will be confined to those candidates who were eligible during that period when the vacancy arose and not those who become eligible after the vacancy had arisen. Thus, the right of eligible candidates for consideration against vacan-

cies occurring in a particular year or period is confined to the posts to be filled up by promotion and not against direct recruitment quota unless, the rules specifically provide or the advertisements make it very clear and the recruitment process conducted accordingly.

DB observed that in the present case, there is no mention in the relevant service rules that vacancies occurring in a particular vear against direct recruitment quota has to be filled up from amongst the eligible candidates of that period or advertisement. Further, it was not mentioned in the advertisements that the appointments will be made advertisement wise. It has been also noted that there was only one written test and one interview process

There were no separate written tests and separate interviews for these different categories of candidates as per advertisements issued in 2002, 2005 and 2008. The interview was conducted as if all the posts were advertised

together and as per records, all the posts were clubbed together.

DB said that the inference is inescapable. If the open competition consisting of written test and interview is the same for all these posts advertised in 2002, 2005 and 2008, which is the position in the present case, for the purpose of determining seniority in the post of Naib Tehsildars, the merit position obtained by the candidates in the said common competitive examination must be the basis for determining inter-se seniority amongst them.

There cannot be any subsequent compartmentalization or segregation of the select lists/merit lists for the three advertisements within the meaning Rule 24 of the Jammu and Civil Services Kashmir (Classification, Control and Appeal) Rules, 1956.

Any subsequent segregation based on advertisement though may be permissible for the purpose of ascertaining the number of persons to be appointed

against the vacancies occurring in 2002, 2005 and 2008, it cannot have any effect for the purpose of determining seniority as Rule 24 of CCA rules does not contemplate any other method for determining seniority except the merit position assigned to the candidates in the common competition. Court observed.

Accordingly, DB hold that the seniority list prepared on the basis of advertisement wise vacancy in terms of the advertisements issued in 2002, 2005 and 2008 is not only impermissible under law but also violative of the provisions of Rule 24 of the Jammu and Kashmir Civil Services (Classification, Control and Appeal) Rules, 1956 for the purpose of determining seniority and to that extent the impugned seniority list dated 08.10.2013 prepared is not valid and accordingly, the same is quashed and set aside as far as the present appellants and private respondents are concerned, and not for others, as they have not questioned the said final seniority list before us and we do not wish to disturb the position at this stage except for the appellants and the private respondents, ordered.

DB further observed that in our opinion, the principle for fixing seniority list of direct recruit Naib Tehsildars who were appointed as such on the basis of the common open competition held in 2009 and select list notified on 08.09.2009 is to be based on the positions attained by them and assigned to them in order of merit in the said compe-

tition by the selection body. DB further observed that it has been submitted at the Bar that many of the Naib Tehsildars in the meantime have been promoted to the higher posts of Tehsildars. In the present case there are only four appellants. Accordingly, if any of these four appellants are found to be senior to any of the Tehsildars who are found to be junior to the appellants in the grade of Naib Tehsildars in the light of the principle and observation made

above, a review Departmental Promotion Committee/Selection process shall be held for promotion to the post of Tehsildars and if the appellants are found to be suitable for promotion to the post of Tehsildar, the appellants shall be given promotion to the posts of Tehsildars. DB made it clear that those private respondents, who may have been promoted earlier to any of the present appellants as Tehsildars, they shall not be demoted but shall be allowed to remain as Tehsildars by assigning appropriate seniority in the grade of Tehsildar below the appellants as per the recommendation of the Review Departmental Promotion Committee by adjusting against the promotion quota. DB further ordered that the

aforesaid exercise shall be conducted at the earliest, preferably within a period of one month from today, so that any subsequent promotion to the post of Tehsildar and higher posts is not unduly delayed to avoid any further complications.
