### NOTIFICATION

#### Under Section 11(1) of Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Re-settlement Act 2013

Whereas the Chief Medical Officer, Jammu vide his letter No. CMO-J/P&S/822-25 dated 09.07.2010 has placed an indent for acquisition of land for construction of Sub District Hospital, Akhnoor measuring 20 Kanal under Khasra No. 310min and 312min. However, Khasra No. 311 is not included in this acquisition. The owner of land bearing Khasra No.311 has approached the Hon'ble High Court of Jammu and Kashmir and Ladakh bearing case No. CPOWP No. 328/2018 in OWP No. 1644/2013 for compensation. In this respect, Hon'ble High Court vide Order dated 13.11.2024 has directed the respondent No. 2 Deputy Commissioner, Jammu and Respondent No. 5 Secretary Health and Medical Education, Civil Secretariat, Jammu to process the acquisition and pay the compensation to the land owner.

Whereas Director Health Services, Jammu vide No. DHSJ/Akh-Ind/2024-25/1389-91 dated 28.12.2024 has placed indent in terms of Rule 3(1) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Re-settlement Act, 2013 for acquisition of land measuring 15 Marlas bearing Khasra No. 311 situated at village MawaKarora, Tehsil Akhnoor, District Jammu which came under the premises of already constructed building of Sub District Hospital, Akhnoor.

The Social Impact Assessment Study has been exempted by Assistant Commissioner (Rev.) Jammu vide letter No. DCJ/LA/SDH/Akhnoor/2024-25/465 dated 27.12.2024 under Rule 8 (Chapter III) of The Jammu and Kashmir Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement (Social Impact Assessment and Consent) Rules, 2023 notified videJ&K Government, Revenue Department S.O. 440 dated 24.12.2023.

This notification is made under the provision of Section 11 (1) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Re-settlement Act 2013, to all whom it may concern.

In exercise of powers vested to me under section 11 (1) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Re-settlement Act 2013, I, ShubhankarPratyush Pathak IAS, Collector Land Acquisition Akhnoor do hereby Notify that the land particular of which are given herein below came under the premises of already constructed building of Sub District Hospital, Akhnoor, District Jammu.

Further under section 11(4) of the Act, no person shall make any transaction or cause any transaction of land (specified herein below) i.e. sale/ purchase etc. or create any encumbrance on such land from the date of publication of this notification without prior approval of the Collector.

Objections to the acquisition, if any, may be filed in writing by the person's interested in land specified herein, within sixty days from the date of publication of the notification as provided under section 15 of the Act before the Collector Land Acquisition, Akhnoor.

Any objection/statement which is received after the due date or which does not clearly explain the nature of the senders interested in the land is liable to be summarily rejected.

Objections received within the due date, if any, will be enquired into where the objectors will be at liberty to appear in person or by advocate and to adduce any oral or documentary evidence in support of their objections.
