

Two new CISF Battalions sanctioned by MHA

NEW DELHI: The Ministry of Home Affairs (MHA) has sanctioned significant expansion of the Central Industrial Security Force (CISF), by giving the go-ahead for creation of two new battalions. This decision, coupled with the recently approved Mahila Battalion, will augment the Force's capacity, strengthen national security and create new employment opportunities for over 2000 persons. CISF strength will now touch 2 lakh.

The MHA's approval authorizes the addition of two battalions, each comprising 1,025 personnel of various ranks. This will take the CISF's total number of Battalions from 13 to 15, adding 2,050 new posts to the Force. Each new battalion will be led by a Senior Commandant level Officer. These new battalions will also be vital in catering to the increasing demands on the CISF

by creating a pool of trained personnel to fulfill immediate induction requirements relating to internal security. The reserve battalions consist of personnel specifically trained and equipped who are experienced in handling security of high security Jails and other undertakings.

Furthermore, the additional Battalions will significantly improve the CISF's rapid response capabilities during emergencies.

The availability of dedicated reserve units, well equipped with transport fleet as well as sufficient weapons means faster deployment and more effective management of critical situations, further enhancing public safety and security.

The new strength will reduce stress on existing personnel and translate into improved leave and weekly relief opportunities for personnel.

KEY DATES

File your declaration under the scheme on or before **31.01.2025** to pay lesser amount for settlement of appeal.

On filing declaration on or after **01.02.2025**, the settlement amount becomes higher.

DISPUTES COVERED

All disputes (subject to some exclusion), in relation to the following :

- Tax • Penalty • Interest • Fee • TDS or TCS

ELIGIBILITY

- Appeal/writ filed on or before 22.07.2024 and such appeal/writ is pending as on 22.07.2024
- Taxpayer who has filed objections before Dispute Resolution Panel (DRP) and DRP has not issued any directions on or before 22.07.2024
- Taxpayer in whose case DRP has issued direction but Assessing Officer has not completed assessment on or before 22.07.2024
- Taxpayer who has filed an application for revision u/s 264 of the Act and such application is pending as on 22.07.2024
