"Over the past few months, it has been observed that some individuals with maliious intentions have been engaging in sectarian slander on social media, attemptng to create division. Legal action, following due process, will be taken against all offenders, and anyone sharing or forwarding such derogatory content against any sect will face strict action under the full force of the law," it added.

Referring to the Navy's adoption of indigenous symbols inspired by the 17th century Maratha warrior king Chhatrapati Shivaji Maharaj, Modi said, "This reflects our resolve to free ourselves from colonial legacies while embracing our heritage." In the evening, the PM travelled to Kharghar in adjoining Navi Mumbai to inaugurate an ISKCON (International Society for Krishna Consciousness) temple.

various stakeholders would be that the value of land increases for the landowners and better infrastructure gets created as compared to the irregular land plots pooled by the landowners developing that land parcel.

This would help in creation of infrastructure as a sustainable alternative to conventional land acquisition methods. The scheme is aimed tobe a win-win situation for both the government and various stakeholders, including individual landowners and real estate developers.

The meeting also delved into the Transferable Development Rights (TDR) Policy, focusing on its broad contours, objectives and mechanisms. The potential use of TDR for heritage properties, ensuring their preservation while enabling urban growth was also discussed. Under TDR scheme, for the land surrendered by a land owner or a developer free-of-cost for public purposes such as road widening, public passage, for conservation, heritage and other infrastructure development, shall be granted a non-financial compensation in the form of a TDR certificate specifying the Built-Up Area (BUA) or Floor Area Ratio (FAR) given to a land owner or developer which he can utilize in remaining part of his property or build elsewhere and even monetize by selling TDR to any other developer or user in receiving areas. This

would allow developers to build over and above the permissible Floor Area Ratio (FAR) for the land surrendered in congested areas

The concept of Transit-Oriented Development (TOD) was also discussed, with emphasis on its objectives to promote sustainable urban mobility and to ensure planned development around public transport stations. The stipulations of TOD would facilitate compact, walkable urban spaces around transit hubs.

Separate discussions were held on proposed services under Integrated Solid Waste Management (ISWM) for municipalities and urban local bodies across Jammu and Kashmir. Presentations by Housing & Urban Development department outlined strategies for collection, transportation and processing of solid waste.

Chief Minister exhorted the Housing & Urban Development Department to initiate implementation by taking up projects under Land pooling, TDR & TOD to create few success stories which would infuse confidence among stakeholders to adopt these urban planning strategies for overall development of our cities.

Besides, the meeting discussed management of waste disposal facilities, cleaning of roads, drains and waterbodies on Public-Private Partnership (PPP) model.

A presentation on the challenges of solid waste management in Udhampur district depicted dumping of daily waste at landfills resulting in choking of drains and water channels

Proposed solutions discussed included waste segregation, recycling mechanisms, and pollution control machinery to tackle these pressing issues effectively.

Representatives of the National Bank for Financing Infrastructure and Development (NaBFID) also delivered a separate presentation. The discussion focused on infrastructure development projects across Jammu and Kashmir.

The meetings were attended by Advisor to the Chief Minister Nasir Aslam Wani, Chief Secretary Atal Dulloo, Additional Chief Secretary to the CM Dheeraj Gupta, Principal Secretary Finance Santosh D Vaidya, Commissioner Secretary Housing & Urban Development Department Mandeep Kaur, and other senior officials. Officers based in Srinagar participated through video conferencing.

Dulloo further advised them to make simultaneous plans for treatment of legacy waste in order to clear the sites of this untreated garbage. He asked them to identify the feasible locations for establishment of Material Recovery Facilities (MRF) for solid waste, Compost Unit/Bio-CNG plants for liquid waste and dumping sites for inert waste.

He observed that management of waste is of utmost priority for both health and environmental concerns associated with it. He said that this task requires all seriousness and dedication on part of the Department to fully rid our cities and towns of the untreated waste and garbage.

He enjoined upon the J&K PCC to be proactive in enforcement of environmental protection laws in J&K. He sensitised them about their mandate and asked them to use their writ to act against the violators as per laws in force.

The Chief Secretary also reviewed the works being carried out by JMC, SMC and Directors of ULBs in both the divisions of Jammu and Kashmir.

Commissioner Secretary, H&UDD, Mandeep Kaur, presented an overview of different projects proposed and approved by GoI under SBM 2.0 for districts of the UT. She revealed that the facilities for both solid and liquid waste treatment are being created all over J&K in addition to inviting tenders for treatment of legacy

Commissioner JMC, Devansh Yadav, threw light on the detailed works undertaken by the JMC, SMC and other local bodies in different parts of J&K. He elaborated that the waste is segregated for its treatment and the solid waste is being taken to MRF facility where as the liquid one to compost units for making good soil or Bio-CNG plants for fuel making.

It was further explained that different components of the waste are treated differently with some producing Refuse Derived Fuel (RDF) being used by cement factories. It was added that only the inert waste without any use is sent to landfill sites

Regarding the facilities created in various districts, it was divulged that MRF of the capacity of 40 TPD by JMC and 100 TPD by SMC is presently in operation for treating its waste. In addition, the ULBs of Jammu had installed the capacity of 79 TPD 17 locations and ULBs of Kashmir 18 TPD at 9 locations across Kashmir.

Moreover, for treating the liquid waste STPs of the capacity of 25.29 MLD had been established by SMC, 36.7 MLD by LCMA, 71 MLD by JMC, 13.6 MLD by the ULBs of Jammu and 6 MLD collectively by the ULBs of Kashmir division.

Regarding the upcoming facilities of waste management, it was informed that an MRF facility of the capacity of 150 TPD would come into operation at Kotbalwal in September this year and one of 55 TPD at Bandurakh for JM. For SMC, an MRF of the capacity of 459 TPD is soon going to be approved by MoHUAunder the

As far as upcoming STPs are concerned, it was added that STPs of the capacity of 66.9 MLD are under construction in Srinagar, Sonamarg, Baramulla and Charar-i-Sharif in Kashmir Valley. In Jammu, the STPs of the overall capacity of 109.2 MLD are going to be established at Jammu, Akhnoor, Samba, Kathua and

Regarding the remediation of legacy waste, it was revealed that a total of 6.16 lakh Similarly, ULBs of Jammu has tendered 1.87 lakh MT and 2.98 lakh MT of legacy waste by ULBs of Kashmir for its treatment through NAFED.

The meeting was further apprised that legacy waste of the magnitude of about 1.56 lakh MT by JMC, 1.72 lakh MT by 36 ULBs of Jammu and 0.78 lakh MT by 40 ULBs of Kashmir stands remediated till date. Besides, the PDMC consisting of engineers and design analysts for taking up works of waste management in smaller ULBs of J&K is going to be finalised soon.

The meeting was also apprised that on an average 450gm/person/day of waste is generated in big cities and 300 gm is generated in smaller towns. The municipal bodies have been tasked to segregate the dry and wet waste and process it on scientific lines to reduce the environmental pollution as per the NGT guidelines.

from April 1, 2019. What happens to the earlier period?" the bench asked. One of the lawyers said even for vehicles registered prior to April 1, 2019, the third registration mark has to be affixed.

Let us be very clear. This requirement comes for the first time on April 1, 2019.... How do we direct that owners of vehicles, which are registered prior to April 1, 2019, should get this hologram affixed?" the bench asked.

The amicus flagged the issue of non-compliance of the PUC certificate norms. The bench asked the amicus to also deal with the PUC aspect in her note, so that

the norms could be implemented more effectively. "This also is very crucial. If that rule is not complied with, then there are so many

polluting vehicles on the roads," it said. The court added that public sector undertakings and government agencies can be asked to purchase electric vehicles as far as possible

The bench, which deliberated over the schedule for hearing various aspects related to pollution, including stubble burning, said the matter relating to hologrambased colour-coded stickers for vehicles would be considered on January 27. Earlier this month, the apex court had stressed the need for hologram-based

colour-coded stickers for vehicles to tackle air pollution, saying it was considering making the stickers mandatory in states and Union territories beyond the NCR. In 2018, the court had accepted a proposal of the Ministry of Road Transport and

Highways (MoRTH), which envisaged that hologram-based light blue stickers would be used in vehicles using petrol and CNG in the NCR, whereas diesel-run vehicles would have orange stickers.

These stickers, which facilitate in identifying vehicles based on the fuel used, were also supposed to include the dates of registration of the vehicles.

# BJP slams NC-led Govt for its response to 'mysterious' deaths in Rajouri

JAMMU: The Jammu and Kashmir unit of the BJP launched a scathing attack on the National Conference-led government in the Union Territory on Wednesday for its "inaction" over the "mysterious" deaths of 13 people, including 11 children

in a remote village in Rajouri district. It urged the Centre to rush experts to properly investigate the cause of the fatalities in Badhaal village of Kotranka Sub-Division over the last month and a half

"The mysterious deaths in the village in Rajouri is a cause of concern for every one and shows the (Chief Minister) Omar Abdullah-led government's apathy and failure to address the crisis-like situation," Jammu and Kashmir BJP spokesper son Tahir Choudhary told reporters at the party headquarters here.

He accused the government of not taking any concrete steps or on-ground meas ures to tackle the situation. Calling for immediate intervention, the Bharatiya Janata Party (BJP) leader

appealed to the Centre to deploy a team of experts to collect samples from villages water sources and local markets in Rajouri. He also urged police to initiate a probe to rule out any potential foul play con

tributing to the deaths. "The Omar Abdullah-led administration has failed to prioritise the health and safety of the people of Jammu and Kashmir. Such negligence is unacceptable and the government must take immediate responsibility to ensure that this crisis is

brought under control," Choudhary said. Thirteen people, including 11 children, have died in Badhaal (eight in December and five this month). The victims hailed from three families that live in close vicinity and are related to each other.

Jammu and Kashmir Health Minister Sakeena Masood said on Wednesday that the deaths were not caused by any mysterious disease as tests conducted both within and outside the Union Territory have returned negative results.

"The health department could not find any disease, virus or infection that caused the deaths," the minister, who visited the village last month to take stock of the situation, said. She said the real cause of the deaths is a matter of investigation. The victims were not suffering from any illness or infection the minister added.
