Two missing women traced, re-united with families

A missing report of a lady namely resident of Kalaban, Tehsil Mendhar, District Poonch was entered in PS Mendhar on Jan 11, 2025 and now she has been traced and re-united with her family.

Reports said that one lady gone missing and her missing report was entered at PS

Soon after getting the information regarding her missing, Police swung into action and on the directions of SSP Poonch a team was constituted under SHO PS Mendhar for search of missing lady.

The Police team by using all possible means as well as technical help and after getting some clues about her presence in Dhargaloon area succeeded in tracing her within weeks time. Accordingly, after completing all codal formalities, the lady has been handed over to her family and missing report has been closed.

Samba Police also reunited a missing girl with her familyafter a report was lodged t Police PostSupwal under PS Samba.

The father of the missing girl, a resident of Ranipura Tehsil RajnagarChatarpur (MP), currently residing at Nanak Chak, Samba, lodged a written complaintat Police Post Supwalstating that his daughter had gone missing from home. Despite their best efforts, the family was unable to locate her.

Following the complaint, a missing report vide DD No. 12 dated 02.01.2025 was registered at Police Post Supwal and search started to trace out the said missing

Through persistent efforts, the police team at PP Supwal successfully traced out the missing girl and after completing all necessary legal formalities, reunited her to her parents. Accordingly, the missing report has been closed.

Two theft cases solved; six arrested; stolen property worth Rs 5 lakh recovered STATE TIMES NEWS

KISHTWAR: In a significant achievement, District Police Kishtwar has solved two

theft cases involving hardware and Kiryana items, arrested six accused, and recovered stolen property worth Rs 5 lakh from multiple locations. On January 7, 2025, Police Station

Kishtwar received a written complaint from Mohd Farooq, proprietor of M/s Shalimar Glass House, regarding the theft of geysers and other hardware items from his store. Acting on the complaint, FIR No. 09/2025 under sections 305/331(4) BNS was registered, the nvestigation initiated

Subsequently, on January 11, 2025, another complaint was lodged by Raman Gupta, son of Bodh Raj Gupta, resident of Shakti Nagar, Kishtwar,

reporting the theft of kiryana items from his shop. Accordingly, FIR No. 14/2025 under sections 331(4)/305 BNS was registered investigation initiated.

Acting promptly, SSP Kishtwar constituted a special investigation team led by SHO Police Station Kishtwar Leveraging a combination of technical inputs and meticulous investigation, the team identified and apprehended the main accused, Rahul Singh, S/o Mangal Singh, a resident of Kuleed Chowk, Kishtwar.

Following his disclosure, five other accomplices were arrested and thoroughly interrogated. The accused individuals have been identified as Rahul Singh, son of Mangal Singh, resident of Near TRC, Kishtwar; Abdul Hamid, son of Ghulam Nabi, resident of Melan, Kishtwar; Mohd Rafi, son of Ghulam Kadir, resident of Dhar, at present Drabshalla, Kishtwar; Abhishek Mahajan, son of Kewal Kishore, resident of Udhampur City, at present Thathri City, Doda; Irshad Ahmed, son of Late Mohd Hussain, resident of Thathri Market, Doda and Rajesh Kumar Gupta, son of Bodh Raj Gupta, resident of Kandani, Kishtwar. During sustained interrogation, the accused confessed to their involvement in the thefts and disclosed the locations where the stolen property was concealed. Acting on this information, the police team successfully recovered the stolen items worth ?5 lakh.

35 missing mobile phones recovered, handed over to rightful owners

Two bovine smuggling bids foiled; 17 bovines rescued, 2 vehicles seized Samba: Continuing its drive against bovine smugglers and their propagators, Samba Police in successive day has foiled two bovine smuggling attempts in the jurisdiction of Police Station Vijaypur and Police Station Ghagwal, rescued seventeen bovines from the clutches of bovine smugglers and seized two vehicles used for illegal transportation of bovines.

5 drug peddlers arrested; contraband substances, cash recovered

SRINAGAR: Police have arrested five drug peddlers in Kupwara, Baramulla, Srinagar & Budgam and recovered contraband substances & cash from their posses

A police team of Police Post Bazaar at a checkpoint established at Geerhatchi, Kupwara, intercepted a suspicious person identified as Ishfaq Ahmad Parry son of Ghulam Hassan Parry resident of Doniwari Lolab. During search, 11 grams of Heroin-like substance and \$5,170 was recovered from his possession. Subsequently, he was arrested. Meanwhile in Baramulla, a Police party of Police Station Uri at a checkpoint established at Gingal Uri, arrested a drug peddler identified as Saleem Khan son of Akhter Khan resident of Dawaran Uri. During search, 1.208 Kgs of Cannabis Powder like substances was recovered from his possession.

In Srinagar, a Police team at a checkpoint established at Dalgate, arrested two drug peddlers identified as Aquib Ahmad Sofi son of Late Gh Mohi Udin Sofi resident of Buchwara Dalgate and Ashiq Hussain Dar @Ashiq Kala son of Mohd Yousuf Dar resident of Dubji Bund Maisuma Srinagar. During search, substantial quantity of narcotic substance and cash amount of ?5,000/- have been recovered from their possession. In Budgam, during naka checking at Madbal Chadoora, a Police party of Police Station Chadoora intercepted a vehicle (Alto) bearing registration No. JK01K-3500 driven by Sajad Ahmad Wani son of Ghulam Mohi-ud-din Wani resident of Nowhar Chadoora. During search, 1.70 Kgs of Charas Powder and 02 sticks of Charas wrapped in corn husk were recovered from his possession. He has been arrested and the vehicle used in the commission of crime has also been seized. Accordingly, cases under relevant sections of law have been registered at respective police stations and investigations have been initiated.

Fraudulent gold smith arrested; counterfeit ornaments seized

BIJBEHARA: Police in Srinagar have apprehended an individual involved in the sale of counterfeit gold ornaments.

On January 9, 2025, a written complaint was lodged at Police Station Nowhatta by an individual namely Nisar Ahmad Bhat, a resident of Bindoo Kokernag, at pres-

ent living in Srinagar & working as a storekeeper at Lalmandi Srinagar, stating therein that he had purchased gold ornaments from one Mehraj Din Qazi, the proprietor of M/S Soliya Ornaments in Bijbihara. Upon close observation once purchased, they turned out to be fake. In this connection, a case vide FIR No. 02/2025 under relevant sections of law was registered in Police Station Nowhatta.

Acting swiftly, the investigating team arrested the

accused shopkeeper identified as Mehraj Din Qazi son of Gh Mohammad Qazi resident of Bijbihara, and seized the fake jewellery. During questioning, the accused admitted to deceiving customers by embossing fake hallmarks on gold-like ornaments. The investigating team also learnt that the accused had been making home deliveries of these counterfeit items to various locations of Srinagar City, including Nowhatta. The laboratory tests of the seized gold jewellery have confirmed that the ornaments in question are indeed counterfeit. The investigation of the case is going on to uncover any further links in this fraudulent network.

Gambler arrested, stake money seized

SOPORE: Police have arrested a gambler in Sopore and recovered stake money from his possession. Acting on a specific information regarding gambling activities at Behrampora, a Police team from Police Post Watergam, raided a specific location. Upon noticing the Police, the gamblers fled from the scene, but one gambler identified as Manzoor Ahmad Bhat, a resident of Khaipora Handwara, was arrested.

Police have seized stake money of ?8,500 and playing cards from his possession. A case under the relevant sections of law has been registered at PS Dangiwacha and investigation has been initiated.
