A newly formed special investigation team of police has rounded up over 60 people for questioning as part of its investigation after autopsy reports by CSIR-IITR revealed the presence of neurotoxins.

On Friday, Jammu and Kashmir Chief Minister Omar Abdullah chaired a highevel meeting here to discuss the situation in Badhaal village of Kotranka sub-division and directed health and police departments to expedite investigations.

Located about 55km from Rajouri district headquarters, the villagers are in gripped by fear and want the mystery to be resolved already.

People complained of fever, pain, nausea and loss of consciousness before dying within days of their admission to the hospitals. A girl alone was able to buck the trend and withstand the condition for days. Her condition though continues to be

According to a doctor, the MRI scan of the patients revealed oedema in the brain, a condition where fluid builds up in the brain tissue.

"It is a big challenge for all of us \dots I appeal to the people that if anyone has any clue, please come forward and help in the ongoing investigations," National Conference leader and local Member of Legislative Assembly (MLA) Javid Iqbal

A new graveyard has come up in the village on an agriculture land belonging to Mohammad Aslam, who lost five children and his maternal uncle and aunt, who adopted him, between January 12 and 17.

Aslam's brother-in-law Fazal Hussain and his four children were the first to die under suspicious circumstances in the village on December 7. They were initially believed to have perished to food poisoning for the family had attended a wedding

The pregnant wife of Mohd Rafiq, a cousin of Aslam, and her three children died on December 12.

"The government responded to the situation in a very sensitive manner, leaving nothing to chance. Health teams from within and outside J&K were mobilised and all the villagers were screened within the shortest possible time," Choudhary said.

He said the chief minister has been monitoring the situation since day one. "The meeting chaired by the chief minister was informed that a total of 68 people have been rounded up for questioning by the SIT," he said, expressing hope that verything will become clear once the probe is complete.

A grieving Aslam did not rule out a "conspiracy" against his family.

"Hundreds of people had a feast but only Hussain and his children died first. A few days later my cousin's wife and children passed away and then death reached my doorstep. How is it that only our family perished like this?" he said, adding that his family had meals at Hussain's house where a special prayer meeting was held to mark the 40th day since the deaths.

He said fear has gripped the villagers to such an extent that many avoided meetng him when he was grief-stricken.

Zaheer Ahmad Gorsi, a local social activist, said the villagers are yet to come to erms with the unexplained deaths. "A new graveyard has to be prepared \dots It is a esting time for the whole village.

Zahid Shah, a relative of Aslam, said he has full faith in the administration and

"This type of fear was not there even when militancy was at its peak or during the COVID-19 pandemic. People are not coming forward even to dig the grave for the dead," Nazim Din, another relative, said.

Earlier, a government spokesperson said investigations and samples empirically ndicate that the incidents were not due to a communicable disease of bacterial or viral origin and that there is no public health angle.

"All samples taken from the victims and the villagers have tested negative for any viral or bacteriological aetiology. The tests were conducted on different samples in

some of the most reputed labs in the country. The toxicological analysis conducted by CSIR-IITR has detected toxins in multiole biological specimens

The chief minister said the administration is treating the situation with the high-

"The health and safety of our people remain our top priority. The government is fully committed to resolving this crisis and ensuring justice for the affected families," Abdullah earlier said.

Union Labour & Employment Minister Mansukh Mandaviya introduced the two new services on Saturday.

The minister said around 27 per cent of grievances filed by members are related to member profile/KYC issues and that would see a significant drop after the roll-

He also stated that large employers having a huge workload of such requests will also benefit.

The minister stated that the EPFO has simplified the process of joint declaration on the EPFO portal by allowing employees to self-correct most common errors in personal details like name, date of birth, gender, nationality, father/mother's name, marital status, spouse name, date of joining and date of leaving, without any verification by employer or approval by EPFO.

This facility will be available for members, whose UAN (universal account numper) was issued after October 1, 2017 (when Aadhaar matching was made manda-

No supporting document is required in such cases, the minister informed.

If the UAN was issued prior to October 1, 2017, the employer can correct details vithout the EPFO's approval.

Requirement of supporting document has also been simplified for such cases. Only where UAN is not linked with Aadhaar, any correction would have to be submitted physically to employer and after verification forwarded to EPFO for

approval, he explained. UAN registration is done by employer for the employee at the time of joining. For many employees, mistakes were committed by employers in recording father/spouse name, marital status, nationality and service details during the registration process

In order to correct these errors, the employee had to make a request online with supporting documents.

The request would have to be verified by the employer and then forwarded to EPFO for approval before any change could be effected. This process was called Joint Declaration.

Out of the 8 lakh requests that were forwarded to EPFO by employers in FY 24-25, it was seen that only 40 per cent were sent within 5 days, 47 per cent were sent after 10 days and the average time taken by employer was 28 days.

The simplification would provide relief to employees in 45 per cent of cases through immediate correction through Aadhaar OTP verification and in the balance 50 per cent of cases through the employer itself.

If any member who can self-approve has already filed his request which is pending with the employer, the member can delete the already filed request and self-approve as per simplified process

This will benefit nearly 3.9 lakh cases pending with employer as on date.

Modi said the scheme will help people get loans and benefits of other government

"Around 2.24 crore beneficiaries in villages will now have SVAMITVA property cards after 65 lakh cards are distributed today," the prime minister said.

"Property rights are a major challenge across the world. Years ago, the United Nations had held a study, which revealed people did not have legal documents for property rights in several countries. The UN has said property rights are important for poverty alleviation," he said.

Modi said an eminent economist had opined that property in villages is a "dead capital" because people cannot do anything with it, and it can't help increase their

"India was also impacted by this challenge. People in villages have property worth lakhs of crores (of rupees), but they did not have papers for it. There were disputes, properties were snatched, and even banks did not provide loans over it," he said.

The prime minister emphasized that no sensitive government could leave its villagers in such distress. "Previous governments should have taken steps to do something about it but noth-

ing much was done," he said. Modi said Dalits, backward classes and tribals were the worst affected by this.

Elaborating on the SVAMITVA Yojana, he said it involved mapping houses and lands in villages using drones and providing legal documents for residential properties to villagers. He added that the benefits of this scheme are now visible "India has over six lakh villages, with drone surveys completed in nearly half of

them," Modi said. He highlighted that after receiving legal documents, lakhs of people had taken

loans from banks based on their properties and started small businesses in their vil-

"After getting legal property rights, lakhs of people have taken loan. They have used this money to start their businesses. Many of these are farmers, for whom this property cards is a guarantee to financial security," he said.

Modi said that once property cards are issued in all villages, the scheme will unlock economic activities worth over Rs 100 lakh crore. He emphasized the substantial capital that will be added to the country's economy.

Noting that earlier, land disputes were common for farmers and obtaining land documents is challenging, often requiring multiple visits to offices and leading to corruption, the prime minister said that land records are being digitized to deal with these issues.

Highlighting that SVAMITVA and Bhu-Aadhaar are foundational systems for village development, he said that Bhu-Aadhaar provides a unique identity to land, with around 23 crore Bhu-Aadhaar numbers issued, making it easy to identify land plots.

"Over the past seven-eight years, approximately 98 per cent of land records have been digitized, and most land maps are now digitally available," Modi added. Later, in a post on X, the prime minister said rural land digitisation is "furthering

rural empowerment by leveraging the power of technology and good governance". Union Minister of Panchayati Raj Rajiv Ranjan Singh 'Lalan', Union Minister of State for Panchayati Raj S P Singh Baghel and Ministry of Panchayati Raj

Secretary Vivek Bharadwaj were also present at the event. It was attended virtually by several chief ministers, Union ministers and state min-

Events are also being organised in over 230 districts for physical distribution of property cards. It is expected that around 13 Union ministers will physically join from designated locations from across the country to oversee regional distribution ceremonies of property cards.

The SVAMITVA (Survey of Villages and Mapping with Improvised Technology in Village Areas) scheme was launched in 2020 to enhance the economic progress of rural India by providing 'Record of Rights' to households owning houses in inhabited areas in villages through the latest drone technology for surveying.

The scheme also helps facilitate monetization of properties and enabling institutional credit through bank loans; reducing property-related disputes; facilitating better assessment of properties and property tax in rural areas and enabling comprehensive village-level planning.

JAMMU: As part of its national campaign, the Jammu and Kashmir unit of Congress staged the 'Samvidhan Bachao Rashtriya Padayatra' on Saturday. Amid chants of 'mulk ko bachaana hai, Congress ko laana hai' (To save the country, Congress must be brought in), hundreds of Congress leaders and workers assembled at Gandhi Chowk in Satwari and later marched in a procession

toward the nearby Ambedkar Chowk in Gandhi Nagar. "This protest rally is part of the national campaign launched by the Congress to save democracy and the Constitution, which faces a direct threat from the BJP. We want to mobilise public support in a peaceful manner against the central government's policies, which are dividing the country along religious lines," said Senior Congress leader and AICC in-charge for J&K, Bharat Singh

Solanki, who led the rally along with AICC General Secretary and MLA GA Mir, Pradesh Congress Committee President Tariq Hamid Karra, and working presidents Raman Bhalla and Tara Chand, said his party has taken the responsibility to save the country from the BJP, which he claims is attempting to dismantle democracy and the Constitution.

Mir alleged that the ruling party at the centre has no respect for freedom fighters or those who contributed to the creation of India's strong Constitution. "They are eroding the ideology of our national heroes, and it is the inherited duty of Congress to stand up against this onslaught," he said, adding that the

Two drug peddlers arrested; heroin, sharp edge weapon recovered

JAMMU: In a significant crackdown against Drug Peddler by Jammu Police, a police party from Akhnoor Police Station apprehended two drug peddler involved in drug peddling during a routine patrolling and checking operation at Pannu Chowk Naka around 6:30 PM on Saturday.

The Police intercepted a Tata Safari bearing registration number DL 4CAI 4843, which was traveling from Sohal towards Jammu.

Despite being signaled to stop, the vehicle initially attempted to flee but was eventually stopped and its occupants detained. The two individuals were identified as Amit Sharma, son of Shakti Sharma, resident of Rajpura Magotrian Tehsil Jammu, District Jammu and Vipul Mehra, son of Ashwani Kumar, resident of Ward No. 33, Rajpura Magotrian, Tehsil Jammu, District Jammu.

Upon searching the vehicle, the police recovered approximately 20-25 grams of neroin-like substance and a sharp-edged weapon (Toka). The suspects were mable to provide any valid justification for possessing the contraband items.

A case under FIR No. 08/2025 has been registered at Akhnoor Police Station under Sections 8/21/22/25/29 of the Narcotic Drugs and Psychotropic Substances NDPS) Act and Section 4/25 of the Arms Act. Further investigation is under
