Farooq Abdullah's remarks on Article 370 desperate attempt to stay politically relevant: Dr. Tahir

JAMMU: Bharatiya Janata Party's senior leader and spokesperson Dr. Tahir Choudhary has strongly criticized National Conference leader Dr. Farooq Abdullah for his recent remarks on Article 370, accusing him of misleading the people of Jammu and Kashmir for political gains.

Dr. Choudhary stated that such statements are part of a desperate attempt by Dr. Abdullah to regain relevance in the region's political landscape. Dr. Choudhary drew a clear distinction between Maharaja Hari Singh's state subject law introduced in 1927 and Article 370.

"Maharaja Hari Singh's state subject law was designed to protect the rights of all citizens of Jammu and Kashmir, ensuring that the local population retained control over their land, jobs, and resources. However, Article 370, was discrimina-



interests," Dr. Choudhary explained and suggested Dr Farooq Abdullah to properly read history before comparing the State Subject law of Maharaja Hari Singh with Article 370.

The BJP spokesperson said that State Subject law introduced by Maharaja Singh had the provision of granting citizenship to rights to non-state subjects also.

Highlighting the discriminatory aspects of Article 370, he said, "It was anti-women, anti-weaker sections, and a major obstacle to the full integration of Jammu and Kashmir into the Indian

Union. Women from the region who married outside the state were denied inheritance rights, and marginalized sections of society were left to suffer without the safeguards and opportunities available elsewhere in the country."

Dr. Choudhary asserted

that the abrogation of Article 370 on August 5, 2019, under the visionary leadership of Prime Minister Narendra Modi, marked the beginning of a transformative era for Jammu and Kashmir. "The removal of this article was a bold and historic step that finally ended decades of inequality and stagnation. It was a decision that paved the way for the holistic development of the region and brought it on par with the rest of India," he said.
