#### Notification

#### Under Section 11(1) of RFCTLAR&R Act 2013

Whereas, the formal land indent has been placed by the Director, Agriculture Production & F.W. Jammu vide his office No. Agri/DAJ/Estt-23/2024-25/3094-95 dated:- 17/10/2024.

Whereas, it appears to the Government of UT of Jammu and Kashmir that the land measuring 14 Marla under Khasra No.1061 is required by the Agriculture Department (already under possession of Agriculture Department) situated in village Dablehar, Tehsil Suchetgarh, District Jammu. It is as such hereby notified that land in the area specified is required for the above purpose.

The notification is made under the provisions of Section 11(1) of The Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 to all whom it may concern.

The Social Impact Assessment study was exempted by the Assistant Commissioner (Revenue), Jammu vide his letter No. DCJ/LA/AP&FW-Dablehar/2024-25/489 dated:-15/01/2025.

In exercise of powers vested in me Under Section 11 Sub Section (1) of The Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013. I, SeemaParihar JKAS, Collector Land Acquisition RS Pura do hereby notify that the land whose particulars are given herein below is required by the Agriculture Department.

Further under Section 1(4) of the Act, no person shall make any transaction or cause any transaction of land i.e., sale/purchase etc. or create any encumbrance on such land from the date of publication of this notification without prior approval of the Collector.

Objections to the acquisition if any, may be filed by the person(s) interested within 60 days from the date of publication of the notification as provided under Section 15 of the Act, before the Collector Land Acquisition RS Pura.

Any objection statement which is received after the due date or which does not clearly explain the nature of the senders interested in the land is liable to be summarily rejected.

Objections received within the due date if any, will be enquired into where the objectors will be at liberty to appear in person or by advocate and to adduce any oral or documentary evidence in support of their objections.


