## Criteria for selection of Shahyikas(Anganwadi Helpers):

- Married Women candidates in the age group of 18-37 years as on 01-01-2025 shall be considered for the post of Sahiyakas(AWHs). In case no married candidate is available, unmarried candidate may be considered.
- The candidate should be domicile of the UT of J&K. 3)
- The selection of Sahayikas (Anganwadi Helpers) shall be restricted to the electoral ward where Anganwadi Centre is located.
- Minimum gualification for Sahayikas (Anganwadi Helpers) shall be matriculation. 4) Weightage shall be given on the basis of marks obtained in 10th class and selection shall be
- done purely on merit basis. However, in rarest of rare cases where selection committee finds a widow headed household with no income source or a completely destitute lady with

zero source of income in such cases preference may be given if other things are equal.

In case no matriculate candidate available in the ward, candidates with qualification not less than 8<sup>th</sup> standard shall be considered.
