JAMMU: The All J&K +2Forum Lecturers expressed deep concern over the delayed disbursement of crucial financial benefits to pensioners and employees, urging the Lieutenant Governor, Manoj Sinha, and Chief Minister, Omar Abdullah, to intervene

The forum, led by President Pardeep Singh Rakwal, Singh. Chairman Ghar General Secretary Gh Nabi Malik, and other senior leaders, has called for immediate release of funds to district treasuries to clear the longpending dues, including GPF (General Provident Fund), Gratuities, Commutation, and Leave Encashments.

JAMMU: In a Public Interest Litigation (PIL) regarding difficulties of deaf and dumb population of Paralkote village in Poonch, A Division Bench of Jammu & Kashmir and Ladakh High Court Comprising Chief Justice Tashi Rabstan and Justice Rajesh Sekhri while disposing of the PIL, directed additional steps are required to be taken, which are deemed necessary in the present case Establish Primary Health Centres (PHCs) in the village with facilities for early screening of hearing disorders.

Implement screening programs for newborns to detect congenital hearing loss. Provide cochlear implants and hearing aids for affected children and adults. Conduct regular health camps and establish permanent centers for rehabilitation and speech therapv. Collaborate with Central Government schemes to provide cochlear implants for children from low-income families. Raise awareness on integrating ear and hearing care into PHCs and train healthcare workers accordingly. DB further expressed the respondents to implement these

measures in a time bound manner, not only for the residents of Paralkot Village but also for identifying and addressing similar issues in other areas of the Union Territories of Jammu & Kashmir and Ladakh. While disposing of the PIL,

DB observed that the State

Government (now U.T.), through the Commissioner Secretary to Government, Health Medical Education Department, School Education Department: Deputy Commissioner Poonch; Block Development Officer Mandi, Poonch; and District Legal Services Authority (DLSA) Poonch, was made party respondents in the PIL. They were directed to physically inspect Village Paralkot and submit a detailed report regarding the accuracy of the claims made in the report along with the measures undertaken to alleviate the difficulties of the affected residents. Subsequent to this Court's directions, a report was submitted by the Chief Education Officer (CEO), Poonch, and Zonal Education Officer (ZEO), Mandi, following their visit to Paralkot

Village on December 8, 2018. The report revealed that out of 16 differently-abled individuals in the village, only 3 were of school-going age.

These children, though hard of hearing, were provided hearing aids. A trained teacher specializing in Braille and sign language was posted in the school to assist these children. However, the report failed to specify the names of the school(s) and the teacher(s).

The Chairman, DLSA Poonch, submitted a report dated December 3, 2018 to the Member Secretary, J&K Legal Services Authority. The report detailed that the Chief Medical Officer (CMO). Poonch, conducted immunization and other medical programs in the area. Efforts were made towards identifying the root cause of the hearing and speech impairments, providing hearing aids, and organizing medical camps. Disability certificates and pensions of Rs 1,000 per month were also sanctioned for the affected individuals. The report acknowledged the absence of road connectivity to the hamlet and clarified that Paralkot is not a standalone village but a hamlet of Village Sawjian, comprising 139 resi-

Director Health

Services, Jammu, in a report dated December 27, 2018, stated that significant action had been undertaken on the directions of this Court.

The Advisor to the Governor of J&K directed the involvement of a team of ENT specialists, an audiologist, and a genetic expert Government Medical College, Jammu to examine the cases. Blood samples of 22 individuals were collected and analyzed at the Human Genetic Research and Counseling Centre, University of Jammu, in collaboration with the School of Biotechnology, SMVDU, Katra.

potential genetic factors contributing to the impairments. Hearing aids were distributed, and water samples were collected for toxicology studies.

Following the Court's directions, the Advisor to the Governor, accompanied by officials, visited SDH Mandi on December 9, 2018. Directions were issued to the Health Department and Medical College to conduct detailed research on the causes of the impairments and to implement preventive and rehabilitation measures. including speech therapy and skill development training. IGNOU makes mandatory for students

report dated December 11 2020, proposed vocational skill development courses for rehabilitation. A revised proposal dated July 16, 2021, with an estimated cost of Rs 19.50 lakh, was submitted to the Finance Department for approval. The department, in coordination with the local Panchayat, identified two trained girls to provide training in the affected areas

By March 30, 2022, 22 individuals had been covered under the Integrated Social Security Scheme, receiving Rs 1,000 per month in financial assistance. Vocational training programs such as carpentry, tailoring, and mushroom culvation were initiated, with Rs 9.75 lakh sanctioned for implementation.

In a report dated May 23. 2023, it was revealed that further genetic studies indicated the potential role of two specific genes in the impairments due to geographical isolation and inbreeding. A proposal for Rs 7.50 lakh was submitted to the Ministry of Health and Family Welfare, GOI to extend the research.

Based on the reports so far submitted, this Court observed that several measures have been undertaken to mitigate the challenges faced by the residents of Paralkot Village.

seeking fresh admission to create DEB ID

JAMMU: The Indira Gandhi National Open University (IGNOU) has released the guidelines for creating a DEB (Distance Education Bureau) ID. DEB ID is a mandatory step for students who wish to enrol in an ODL/Online programme at the university. The university notified that DEB ID shall be created by all learners as per the UGC guidelines. The DEB ID is a unique number which will be provided by the University to each student seeking admission in the University for ODL as well as Online programmes. The admission portal of IGNOU is already open till January 31, 2025 and can accessed on https://ignouadmission.samar th.edu.in/.

The UGC mandates every student enrolling into online and distance education cours-

es to register for DEB ID. Students who are planning to apply for any of the IGNOU programmes are now required to create a DEB ID at the time of admission. DEB ID is helpful when students plan to change their university and transfer their accumulated credits to the new university. Students who have dropped out of their course can continue from where they left off within 7 years of their dropout year, if they have a valid DEB ID. Students first need to register for the Academic Bank of Credit (ABC ID), then use it to create their DEB ID. This is an initiative of the Ministry of Education, Govt. of India, with a sole purpose of creating a digital medium for students for their academic credits. This system is beneficial for those students who need to change their college after one or two years, or even those who drop-out of college and decide to take re-admission

after some time. The Academic Bank of Credit system is a digital credit storage system where with every semester, candidates can store their earned credit and use this later on, if required. It is worth noting that the ABC system is not only useful for storing credit, but it also works as a mode of student verification, maintaining an authentic and confidential way to manage

student credits.
