The trouble began late on December 31, 2024, when a dispute erupted over a notel bill. Witnesses say the criminal minded Aggarwal brothers refused to pay and began verbally abusing the staff. The hotel's employees, including the manager, tried to defuse the situation, but tensions escalated when the brothers left, only to return with a group of accomplices to attack hotel manager and staff.

In the ensuing chaos, the manager suffered severe head injuries, and another staff member sustained facial fractures, necessitating urgent medical intervention. The attack was described as brutal and premeditated, leaving the local com-

Initially thought to be aiding the Aggarwal brothers, the accomplices have now turned against them also as they have also to face legal action for attacking innocent hotel staffers. Sources close to the investigation reveal that the accomplices were misled for participating in the attack. "We were called to help resolve a minor ssue. Instead, we were used to commit a crime," one accomplice reportedly told investigators, adding, "On reaching hotel, Mohit and his brother forced us to attack and beat hotel staff.

The police has registered FIR (1/25) against the Aggarwal brothers, their known accomplice Arun Choudhary, and others under multiple sections of the IPC, including assault and grievous injury. A senior officer leading the investigation assured that everyone involved will face law.

"The Aggarwal brothers and their accomplices initially believed their influence would shield them. But the law is clear-no one is above it," the senior police officer said. He also confirmed that more arrests are imminent, with all accomplices set to be booked for their roles in the attack.

Civil society groups and hospitality unions have rallied in support of the injured hotel staff. "These employees were simply doing their jobs. What happened to them is an affront to every hardworking individual in our community," said a

Several organizations have called for a social boycott of the Aggarwal family. "We need to send a clear message that no amount of money or influence can protect those who break the law," said a spokesperson for a prominent citizen of the area.

The fallout from the hotel attack has left the Aggarwal brothers isolated and facing the combined weight of public fury and legal action. As the police deepen their investigation, the brothers' attempt to use their influence has backfired spectacularly, turning even their allies against them. The case now stands as a critical test of the justice system's ability to uphold the law, regardless financial status.

certificate from the JDA and without securing approval for the layout plan of the colony from the competent authority such as the Jammu Municipal Corporation (JMC) or the JDA under the provisions of the Control of Building Operation Act, 1988.

Sharma added that the JDA has repeatedly issued public notices to inform the general public not to purchase plots, houses or flats in illegal colonies where colonizers or developers have not secured the necessary CLU permissions or layout approvals from the competent authority.

"Through this notice, the public is strongly advised to verify that colonizers or developers have obtained the CLU certificate as well as approval for the layout plan of the colony from the competent authority before purchasing any plots," the JDA vice-chairman said.

He also urged prospective buyers to inquire with the JMC or JDA to confirm whether the colonizers have received the requisite permissions.

In a related development, the Jammu and Kashmir High Court has directed the Building Operation Controlling Authority (BOCA) to file a comprehensive supplementary affidavit detailing the commercial activities in the Gandhi Nagar housng colony in Jammu. This area is designated primarily as a residential zone

The directive, issued by Justice Wasim Sadiq Nargal of the Jammu & Kashmir and Ladakh High Court, calls for BOCA to provide a detailed list of all shops or commercial establishments operating in the colony and to clarify whether these activities comply with the Master Plan and Bye-laws or violate residential zoning

The court's directive highlights the large-scale conversion of residential areas in Gandhi Nagar into commercial establishments and illegal constructions in violation of building permissions and lease deed agreements.

The PM told the rally he had come to Rohini to make a special request to the people of Delhi to give the BJP an opportunity for their own and the city's bright future. Only BJP can develop Delhi, he said.

CB charge-sheets 17 accused including three bank officers

JAMMU: Crime Branch (CB) has submitted challans against 17 accused including three Bank officers for criminal breach of trust, misappropriation of huge money, frauds and forgery.

According to an official statement, the CB completed investigation and proved offence of criminal breach of trust and misappropriation of big amount against main accused the then Branch Manager Citizens' Co-operative Bank Vijaypur Rajiv Bali of Jammu and two more Managers of the same Bank and resubmitted challan against them as per court directions.

Among other accused against whom investigations were completed in different cases and challans filed included two property dealers of Jammu namely Mohd Ramzan and Mohd Sadiq , former ASI of IRP , former government school Teacher, Punjab Armed Police official Sukhwinder Singh of Raja Sansi Amritsar.

Seven separate challans against 17 accused have been produced in courts of law in Jammu, Poonch and Kathua. The accused belong to Punjab, Haryana, U.P., Jammu, Rajouri, Poonch and

PIL regarding dilapidated condition of JMC's cattle pound at Nagrota DB directs JMC, Petitioner-NGO to file response to Affidavit of Outsourced Agency

JAMMU: A Division Bench of the High Court of Jammu & Kashmir and Ladakh (Jammu Bench) comprising the Chief Justice Tashi Rabstan and Justice M.A Chowdhary in the much publicised PIL No.25/2017 filed by an NGO-SAVE (Save Animals Value Environment), working for the cause of animals through its Chairperson Devinder Kaur Madaan alias Rumpy Madaan seeking better management of Animals at Cattle Pound, Seri Khurd (Nagrota) has directed the Commissioner, Jammu Municipal Corporation (JMC) and the petitioner (NGO-SAVE) to file their response to the affidavit filed by outsourced agency i.e. Go Raksha Samiti through Raj Kumar.

When this PIL highlighting dilapidated condition of Cattle Pound/Goshala came up for hearing, Advocate Sheikh Shakeel Ahmed with Advocates Rahul Raina Supriya Chouhan and Mohd. Zulkarnain Chowdhary reminded the Division Bench about the recent visit of Commissioner, JMC alongwith Jt. Commissioner (H&S) Animal Welfare Officer and Incharge Cattle Pound on December 4th, 2024 and after inspection, the Commissioner, JMC in para 7 of his status report dated December 21st, 2024 highlighted major deficiencies in the running of Cattle Pounc by the outsourced agency i.e. Go Raksha Samiti of Raj Kumar. The Division Bench after going through the said lapses/deficiencies had in the open court expressed its deep anguish/displeasure and warned that in case corrective measures are not initiated before next date then the Division Bench would be constrained to cancel the contract of the outsourced agency.

At this stage, Advocate Muneesh Sharma caused appearance for outsourced agency and submitted that on January 1st, 2025 he has filed an affidavit to apprise the court that appropriate steps have been taken on the lapses pointed out in para 7 of the status report filed by the Commissioner, JMC, after his spot inspection. The Division Bench remarked that the said affidavit is not before the court, however, Advocate S.S. Ahmed conceded that he has received a copy of the same.

The Division Bench headed by the Chief Justice Tashi Rabstan directed the Registry to scan the affidavit filed by Advocate Muneesh Sharma appearing for the outsourced agency. The DB further directed that a copy of this affidavit be supplied to Advocate Harshvardhan Gupta appearing for JMC and he was further directed to file the latest status report before the next date of hearing.

Advocate S.S. Ahmed at this stage also requested the Division Bench that he would also like to file his response on behalf of NGO-SAVE and the court allowed his prayer. Advocate Dheeraj Sharma appeared vice Advocate Naved Gul for the Chief Executive Officer, Food Safety & Standards Authority of India, New Delhi.

Five of family dies of suffocation; CM expresses grief over loss of lives ■ STATE TIMES NEWS

SRINAGAR: In a deeply tragic incident in the Pandrethan area of Srinagar, a fam ily of five, including a father, mother, and their three children, died due to suffoca tion caused by heating equipment.

The heart-breaking incident occurred in the early hours, and the family was found unconscious inside their rented accommodation.

According to initial reports, neighbours grew concerned after noticing that the family's house remained quiet and motionless throughout the morning. Suspicious of the situation, the neighbours alerted the authorities. Emergency

response teams and police quickly rushed to the spot. Upon their arrival, the five family members-two adults and three children-were found unresponsive. They were immediately transported to a nearby hospital, but despite all efforts, they were declared dead.

The authorities suspect that the deaths were caused by suffocation due to mal functioning or improper use of heating equipment, which is common during the harsh winter months in Kashmir.

The tragic loss of life has sent shockwaves through the community, leaving the neighbors and local residents in deep sorrow Meanwhile, Chief Minister Omar Abdullah expressed profound grief and sorrov

over the tragic death of five family members. The Chief Minister conveyed his deepest condolences to the bereaved relatives

praying for strength and patience to help them cope with this irreparable loss.

While praying for the departed souls, the Chief Minister urged people to exercise utmost caution while using heating gadgets during the harsh winter months.

He emphasized the importance of adhering to government-issued advisories on the afe use of heating equipment to prevent such tragic incidents
