These proceedings are under provisions of Section 23 of the Right to Fair Compensation
and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 for
determination of compensation in respect of net area of land proposed to be acquired
measuring 02 kanal 04 Marlas for construction of link Road Seri to Balana Village Tagood Tehsil
Mughal Maidan District Kishtwar.
The land acquisition proceedings were initiated with the publication of Preliminary
Notification under section 11 of the Right to Fair Compensation and Transparency in Land
Acquisition, Rehabilitation and Resettlement Act, 2013.
The Executive Engineer PWD R&B, Division chatroo Vide No 991-94 Dated 2-12-2009
and Chief Engineer PWD R&B Jammu vide NO CEJ/DB/6833-36 Dated:
27-8-2018 submitted proper letter of indent for acquisition of land for construction of link Road
Seri to Balana Village Tagood Village Tagood Tehsil Mughal Maidan District Kishtwar.
Accordingly, the Tehsildar Mughal Maidan vide number /TM/GEN/2023-24/724 Dated
10/01/2024 had submitted the land acquisition papers to this office duly completed in all respect
for further necessary action.
1. PUBLICATION OF NOTIFICATIONS AND ISSUE OF NOTICES:
The local SIA team was notified as Social Impact Assessment Team (SIA) U/S 4 of the Right
to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement
Act, 2013 for conducting Social Impact Assessment Team (SIA) Vide No.SDM/C/LA/2024-
25/23-26 Dated: 24-04-2024. Accordingly, the concerned committee members had submitted the
Social Impact Assessment Study report within a time and the same was submitted to the District
Collector Kishtwar for appraisal under U/S 7 of the RFCTLARR Act, 2013 Vide No
SDM/C/LA/2024-25/166-68 Dated: 5-08-2024.
The District Collector Kishtwar, constituted a committee of expert group for appraisal of
Social Impact Assessment Study report. Accordingly, the Multi-Disciplinary Expert Group for
appraisal constituted Vide Notification No. DCK/LA/24 F.No.294/276 Dated: 03-09-2024
submitted its recommendation.
The SIA report and the recommendation of Multi-Disciplinary Expert Group was then
approved and a Preliminary Notification No SDM/C/LA/2024-25/94-101 Dated: 14-10-2024
was issued U/S 11 of the Act stating that the land described in the schedule thereto (hereafter
referred to as the said land) was needed or likely to be needed for the public purpose. The
notification issued for inviting objections within 60 days.
No objections were received against the Preliminary Notification. The proposal was then

2. OWNERSHIP:
Name of the persons of whose land under acquisition is standing in the record of rights was
ascertained from the revenue records and the same are shown in Award statement.
3. SITUATION, DESCRIPTION AND LOCATION OF THE LAND:
The total acquired land measuring 02 kanal 04 Marlas under acquisition is irrigated
agricultural land and situated in village Tagood of Tehsil Mughalmaldan District Kishtwar.
