**Subject:** Termination of contract for Construction of road from Ritti near Shiv Temple towards Barta Govt. High School (L=2.00 km) under NABARD RIDF-XXVI.

- Whereas the above noted work was advertised by the Executive Engineer PWD (R&B) Division, Udhampur vide his e-nit no: 66 of 2021-22 Dated 17-08-2021 issued under endorsement no: 10842-47 dated:17-08-2021 for an amount of Rs.226.16 lacs (Construction part 205.60 lacs & Maintenance part 20.56 lacs) under NABARD RIDF-XXVI with a completion period of 18 months.
- Whereas the work was allotted vide this office allotment no: 6993-95 dated: 27-09-2021 for an amount of Rs 1,57,69,835/- (Construction Part = Rs.1,37,13,835/- + Maintenance Part = Rs. 20,56,000/-) in favour of Sh. Kapoor Singh Contractor S/O Sh. M.R.Thakur R/O Village Mir Tehsil Panchari and District. Udhampur bearing Registration No: UEED/RCR/69/AA/7/2000-2001 dated: 17-02-2001 and the work was scheduled to be completed within 18 months as per e-NIT/SBD clause with date of start 04-10-2021 and scheduled date of completion 03-04-2023.
- Whereas the Executive Engineer PWD (R&B) Division, Udhampur vide his letter No.14868-70 Dated 26-12-2025 & No. 15426-28 Dt.06-01-2026 has reported that the said contractor started the work on 05-10-2021 and executed earth work, walling, cross-drainage work etc & after completing the part work the contractor has stopped the work for the reason best known to him and thereafter in the month of March 2025 the contractor resumed the work but stopped again and did not resumed till date despite repeated verbal directions and issuance of several notices, the Bituminous work remains pending and work is still incomplete.
- Whereas the contractor was several times directed by the concerned Executive Engineer, Assistant Executive Engineer as well as by Circle office through a series of notices issued to him to resume the work and complete the same but he did not turn up and failed to comply. - Whereas the concerned Executive Engineer has served the final notice vide No. 14360-65 dated: 11-12-2025 to concerned contractor in print media published in Dainik Jagran on 14-12-2025 vide DIP NO. DIP/J-8970/25 dated: 13.12.2025 and also circle office again issued a notice to the contractor vide this office No. SEU/2025-26/8971-76 dated: 12-12-2025 also published in print media in Daily Excelsior news paper on 16-12-2025 vide DIP no: DIP/J-9021/25 dated: 15-12-2025.
- Whereas despite repeated verbal instructions and issuance of series of notices to the contractor but he has failed to respond till date and did not resume the work.
- Whereas the case was forwarded to the Chief Engineer PW (R&B) Department, Chenab Zone, Batote vide this office letter no: SEU/2025-26/9564-68 dated: 27-12-2025 & No. 9959-61 Dt. 06-01-2026 with the recommendation for termination of allotment of contract and forfeiting of security deposit and performance security and authorization for floating the balance work to fresh tender at the risk and cost of defaulted contractor.
- Whereas the Chief Engineer PW (R&B) Department, Chenab Zone, Batote vide his letter no: CECV/20282-83 dated: 19-01-2026 has directed to proceed with the termination of the contract of the concerned contractor for subjected work strictly in accordance with the relevant provisions of the terms and conditions of the e-NIT / SBD, the Manual for Procurement of works and the General Financial Rules (GFR) 2017.

In view of the above recommendations of the Executive Engineer, PWD (R&B) Division, Udhampur and as per the directions of the Worthy Chief Engineer, PW (R&B) Chenab Zone, Batote, the contract allotted vide this office No. 6993-95 dated 27-09-2021 is hereby terminated.

The Bank Guarantee No.00281PBG2109005 Dt. 24-09-2021 valid up to 23-03-2028 for an amount of Rs.4.12 lacs issued by J&K Bank, Main Branch Udhampur, along with the security deposit forfeited and the contractor is hereby debarred from participating in tendering process in R&B Department for a period of one year from the date of issuance of this termination order, in term of clause 21 of the SBD "Fundamental breach of contract-sub-clause vi.
