It is hereby notified for information of all the Heads of Institutions of Govt./Pvt. affiliated High/Higher Secondary Schools falling under the jurisdiction of summer Zone areas of Jammu Division that they shall submit the Internal Assessment Awards to their respective Divisional/Sub/Branch Offices of appearing in the JKBOSE, Jammu Division by or before 16-02-2026 in respect of the candidates who are appearing in the forthcoming examinations pertaining to SSE (10th Class) HSP-I (11th Class) HSP-II (12th Class) Session Annual Regular 2026 (Feb-March) as per prescribed formats.

- The marks are to be awarded on duly prescribed formats (Separately for 10th- 11th and 12th) which can be downloaded from Official Website of JKBOSE i.e. www.jkbose.jk.gov.in.
- The awards must be legible and error free without cutting and overwriting and use of whitener in any case shall not be accepted.
- The Roll No's of ABSENT candidates must be reflected in the assessment as "Absent".
- No Roll number shall be left blank in any case.
- The Internal Assessment awards must be submitted in duplicate under proper signature of Subject's Examiner/s duly attested by the Head of the concerned institution.
- The entire internal assessment practical awards must be routed to the Divisional Officer, Jammu through the concerned Sub/Branch Offices: no internal assessment will be accepted through the medium of email or by post.
- The assessment awards shall mention the complete examination Roll No. of the candidates.
- All the Heads of the Institutions (Govt/Private) of Jammu Division shall ensure that they have submitted internal awards of all candidates and also maintain Internal Assessment record (Candidate wise, subject wise) of their respective Institutions duly signed by the concerned. Examination Incharge and Principal/HOI for future consultations. If any, by BOSE authorities.

In case the above instructions are not properly observed or not submitted within the stipulated period, the responsibility shall squarely lie upon the concerned Head of the Institution and no request shall be entertained whatsoever. The late/incomplete submission of awards shall entail penalty as admissible under BOSE norms/regulations.

- The above appointment shall be subject to the following terms and conditions:-
- The appointee shall report to Project Officer, Wage Employment (Assistant Commissioner Development (ACD)), Doda within a period of 21 days from date of issuance of this order failing which his appointment shall be deemed to have been cancelled without any notice in terms of Circular No: 08-JK (GAD) of 2019 Dated: 04.12.2019 issued by General Administration Department, J&K.
 - The appointee at the time of joining shall produce the following testimonials in original and subsequent verification by the concerned DDO from respective issuing authorities, and the salary shall be released only after receipt of satisfactory verification reports in this regard:
 - Domicile Certificate.
 - Date of Birth Certificate.
 - Qualification Certificate(s).
 - Category Certificate (if any).
 - Physical fitness certificate.
 - Project Officer Wage Employment (Assistant Commissioner Development (ACD)), Doda, after verifying his testimonials and other requisite document(s), shall post him in the block as per the requirement/suitability.
 - That if the appointee has taken a loan for self-employment from DIC/Employment Department, Counselling Centre of the District Industries Centre (DIC) and District Employment & Counselling Centre of the District, he shall relinquish the proprietorship of the unit/enterprise and also stakes, if any, in such self-employment unit/enterprise before joining the Government service. He shall be required to repay the entire loan liability through suitable EMIs, to be determined by the DDO concerned, using his salary. DDO concerned shall obtain an affidavit from the concerned appointee regarding both relinquishment of proprietorship and stakes, if any, in such a self-employment unit/enterprise and recovery to be made and also personally monitor its recovery.
 - The appointment shall be deemed to be cancelled if at any stage it emerges that the certificates/testimonials produced by the candidate are fake or forged, and legal action may also be initiated against such a candidate.
 - The seniority of the members of the cadre shall be regulated under J&K Civil Services (Classification, Control and Appeal) Rules, 1956. It shall be fixed in accordance with the merit obtained by him in the final selection list issued by JKSSB.
 - The appointment shall be subject to the outcome of the writ petition(s)/O.A., if any, pending consideration before any competent court of Law.
 - The appointment of the candidate shall also be subject to the outcome of the present O.A. No. 1206/2024 (Jammu), O.A. 1425/2024, O.A. No. 592/2024 (Srinagar) and O.A. 974/2025 pending before the Hon'ble Central Administrative Tribunal (CAT).
 - The appointee shall have no claim, right, or equity to continue in the present district of posting if, in consequence of the judgment/directions of the Hon'ble Court, Tribunal, or administrative exigencies, the district allotment is modified, altered, or cancelled in the future. The appointee shall be bound by and shall comply with any such re-allotment/transfer and shall not be entitled to claim any right, compensation, damages, or preferential treatment on that account.
