

Drug peddler arrested; narcotics & weapon recovered

JAMMU: In continuation of its sustained drive against drug trafficking and criminal activities in South Zone under the supervision of SP South and SDPO South, Police Station Satwari, during routine patrolling, apprehended one person at Dashmesh Nagar Park near MBS College and recovered narcotic substance along with a sharp-edged weapon.



During checking, the apprehended person was identified as Sanjay Mishra S/o Raju Mishra R/o H.No. 404, Jawahar Nagar, Narwal Pain, Satwari, District Jammu. On search, the following items were recovered from his possession Alprazolam Tablets I.P. 0.5 mg - 975 tablets; Dicyclomine, Tramadol HCL & Acetaminophen Capsules - 264 capsules, One sharp-edged toka and Cash amounting to Rs. 2,630.

Accordingly, a case FIR No. 06/2026 U/S 8/21/22 NDPS Act and 4/25 Arms Act has been registered at Police Station Satwari, and investigation has been entrusted to PSI Ajaz Ahmed Shah of the said police station.

Missing lady traced, reunited with family

JAMMU: Police on Sunday traced a missing woman and

reunited her with family.

An information was received at Police Station Domana regarding a missing lady (name withheld), resident of Jammu. Accordingly, a missing report was entered at Police Station Domana on 24/10/2025.

Acting swiftly on the report, a police team of Police Station Domana, led by SHO PS Domana, made strenuous efforts and, with the help of technical assistance and human intelligence, successfully traced the missing lady.

After completing all legal formalities, the lady was safely handed over to her legal heirs, and the missing report was accordingly closed.

The general public has appreciated the prompt and sincere action of Jammu Police in tracing the missing lady and reuniting her with her family.

Bovine smuggling bids foiled; 11 bovines rescued

JAMMU: Continuing its sustained crackdown against bovine smuggling under Operation Kamdhenu, Jammu (Rural) Police foiled a bovine smuggling attempt in the Sidhra area.

A police party from Police Post Sidhra, during naka checking at Sidhra Bridge, intercepted a Mahindra vehicle bearing registration No. JK19A-5734. During checking, four bovines were found being transported illegally in a cruel manner.

The animals were rescued safely, while the driver identified as Abdul Razaq Kisana, S/o Mahmood Ahmad Kisana, R/o Anantnag was taken into custody. The vehicle involved in the offence was seized.

Accordingly, FIR No. 01/2026 under Sections 223 BNS and 11 of the PCA Act has been registered at Police Station Nagrota. Further investigation is underway.

Continuing its drive against bovine smugglers and their propagators, Samba Police has successfully foiled a bovine smuggling attempt in the jurisdiction of Police Station

Samba, rescued seven (07) bovines from the clutches of bovines smugglers and seized vehicle.

A Police team of Police Post Mansar of PS Samba during special naka on Surinsar road, intercepted an auto load carrier bearing registration number JK14K-2031 for its checking. During checking, seven bovines were found inside the vehicle which were tied in a cruel manner and were being transported illegally without any valid permission. All the bovines have been rescued and shifted to a safer place. The vehicle used in illegal transportation of bovines has also been seized.

A case FIR No. 10/2026 u/s 223 BNS, 11 PCA Act has been registered at Police Station Samba and investigation started.

Lady found dead in Bemina, probe taken-up

SRINAGAR: A lady was found dead under mysterious circumstances in her rented room in the Bemina area of central Kashmir's Srinagar district on Sunday, officials said.

As per details, a lady, who was living as a tenant in a house at Sir Syedabad, Bemina, was found dead this morning.

He said the lady was found lying unconscious inside her room and was later declared dead by doctors.

Meanwhile, police have taken cognizance of the incident and launched an investigation to ascertain the cause of death. The deceased has been identified as Saima Rajab, daughter of Mohd Rajab, a resident of Naidkhai Sonawari.

Four Kerala tourists injured in Awantipora road accident, hospitalized

Jal Shakti (PHE) Employees, Workers raises long-pending demands

UDHAMPUR: Jal Shakti (PHE) Employees and Workers Association today held a protest at the PHE Complex, Udhampur, under the chairmanship of Mr. Som Nath, District President and Senior Trade Union Leader, Jammu Province, to highlight the long-pending genuine demands of PHE daily wage workers.

Addressing the gathering, Som Nath emphasized that the issues of PHE daily wagers require early resolution. He stated that a five-member committee headed by the Chief Secretary was constituted to examine these matters and submit its report within six months, but the report is still awaited. He stressed that concerns such as pending wages, implementation of the Minimum Wages Act, and shortage of staff need urgent attention.

The Association highlighted the following major demands during the protest which include CP/ITI/Land Case Workers who have completed 7 years of service should be regularized as per SRO-64, after fulfilling all required formalities. All pending service records should be completed so that workers receive wages without delay. A clear and time-bound regularization policy should be framed.

Daily wage workers have pending wages for 65-70 months (2014-2020). The Association demanded immediate clearance of all pending wages, including dues of retired workers, and timely release of wages in the future.

Minimum wages should be paid strictly as per the Minimum Wages Act and applicable government orders. The Association demanded enhancement of daily wage rates and uni-

form implementation so that workers receive fair wages in line with other Union Territories.

There is a severe shortage of workers across divisions, affecting smooth functioning of water supply schemes. Thousands of workers are required to operate newly commissioned schemes, including those under JJM. Retirements without replacements are leading to non-functional schemes, and existing workers are facing excessive workload. Immediate engagement of workers as per norms is demanded.

The DPC process in the PHE department has been pending for a long time.

The Association demanded that DPCs be conducted at the earliest in favor of eligible employees.

Som Nath appealed for early consideration of these genuine demands so that daily wage workers and employees may continue their services with dignity and financial security.

Senior leaders who addressed the gathering included Suraj Parkash, Vijay Sharma, Dinesh Kesar, Shanker Singh, Mahinder Singh, Karan Singh, Prem Singh, Sandokh Ram, and Tilak Raj Katoch, among others.

Whereas, tentative seniority list of PG Masters/Teachers in the discipline of Persian was issued vide Notice dated 20.03.2024; and
Whereas, after issuance of the tentative seniority, the Department received various representations through the concerned Directorates for inclusion/update of service particulars in the seniority list; and
Whereas, the objections received by the Department from the members of the Cadre with regard to additions/deletions/corrections have been examined thoroughly in the Department and the genuine objections have been entertained; and
Whereas, the incumbents who have obtained their PG degrees through distance/private mode during service without obtaining proper permission/leave from the competent authority and whose cases have not yet been recommended by the designated committee constituted vide Government Order No. 188-JK(Edu) of 2024, dated 15.03.2024 have also been incorporated in the seniority list, with the condition that their inclusion in seniority / promotion is subject to the condition that proper permission has been/is granted by the Competent Authority for acquiring the PG degree during service. Their names shall be deemed to have been deleted from the seniority lists, ab-initio in case the recommendation is not received in the time frame decided in the Ibid Government order; and
Whereas, the designated committees have recommended 45 incumbents (Annexure-D & Annexure-E) in light of Government Order No. 188-JK(Edu) of 2024, dated 15.03.2024 who had obtained their PG degrees through distance/private mode during service without obtaining proper permission from the Administrative Department and the recommendations made in their favour have been accepted by the Competent Authority.
Now, therefore, in terms of Rule 24 of J&K Civil Services (Classification, Control and Appeal) Rules, 1956, the final seniority list in respect of PG Masters/Teachers in the discipline of Persian forming Annexure-A to this order, is hereby issued, subject to the conditions that the date of birth of the incumbents recorded in the seniority list is subject to further verification from service records, also with reference to the original Matriculation certificates of all the concerned.
Moreover, twenty-four (24) incumbents have been included in the final seniority list at appropriate places as detailed in Annexure-B and twenty-eight (28) incumbents have been deleted from the final seniority list as detailed in Annexure-C for the reasons as shown against each; and
Furthermore, five (05) incumbents who have been recommended by the committee constituted vide Government Order No. 188-JK(Edu) of 2024, dated 15.03.2024, conveyed by Director School Education Jammu as detailed in Annexure-D shall be included in the seniority at appropriate place, as and when full authenticated service particulars of the incumbents are received from the concerned Directorate.
The seniority list so issued will be subject to outcome of writ petition(s) pending, if any, before any Competent court of law.
Besides, it is ordered that any member of the service who is either not included or is aggrieved with the position assigned to him/her in this final seniority list can file a review petition within 07 days from the date of issuance of this updated final seniority list along with supporting documents, through concerned Directorates which shall be decided on case to case basis. No petition shall be entertained after the expiry of stipulated time period.
