C. Document Verification

- The candidate who is shortlisted for Document verification will be required to appear for Document Verification along-with the original documents as well as self-attested Photostat copy of each document as per the Advertisement Notification. The Interested bidders are required to deposit a CDR/FDR for an amount of Rs 5000/- through their respective registered firm pledged to the Account Section, Deputy Commissioner's, office Jammu, of any scheduled bank latest by 06.01.2026 by 4.00 PM and obtain registration slip to make them eligible for participation in the said auction. The stock can be physically inspected by the Interested bidders on any working day from 10.30 AM to 3.30 PM in the Deputy Commissioner, office premises.

TERMS AND CONDITIONS

1. Only those parties would be eligible for participation in open auction who have deposited CDR/FDR of Rs. 5000/- as the security money with in prescribed time.
2. Each Bidder is entitled to furnish only one CDR/FDR through their respective registered firm.
3. Each bidder will be allowed at the most only one helper to accompany him on the auction day.
4. The successful bidder has to deposit 100% of the total value of the Articles secured by him/her in the office of the undersigned through account payee cheque/Bank Draft (No cash shall be accepted in any case) within 3 days of the announcement and acceptance of the bid prior to issuing of release orders before the final lifting of articles.
5. The auction committee reserves the right to accept or reject any bid in case of unhealthy competition and change the conditions/or suspend the auction process without assigning any reason thereof.
6. The decision about acceptance/rejection of the highest bid will be announced on the day of auction itself.
7. The successful bidders shall have to lift entire articles at the earliest possible within one week "as is where is" basis condition at his own cost and in case of delay in lifting warehousing charges Rs.0.50 per article per day will be charged under normal conditions.
8. No Transportation for lifting the auction, Items shall be provided by the Department
9. The CDR / FDR of the successful bidder will be released after complete lifting of the Auctioned stocks for which he/she has secured the bid.
10. Damage if any, caused to government property by the successful bidder or his representative during lifting of stocks shall have to be compensated by the successful bidder.
11. All taxes and other charges what so ever applicable under rules shall be charged from the successful bidder.
12. In the event of any dispute or difference arising between Auction Committee & Buyer, the matter shall be referred to the District Magistrate Jammu for arbitration and whose decision shall be final and binding on both the parties.
13. The buyer will not enter into indirect deals/transfers or assigns the contract or part thereof to any other party without written approval of the Auction Committee.
14. The disputes, if any, shall be subject to the jurisdiction of the Hon'ble Courts located within the Municipal Limits of Jammu City.
15. The minimum reserve bid for auction is Rs 100000/-GST applicable.
16. The Auction Committee may forfeit the EMD/SD/ entire deposited amount of the bidder under following circumstances:
 - I. If the security deposit is not deposited by the bidders as per clause No 1 of the terms and condition within stipulated time.
 - II. If the entire 100% of amount of the total value of the articles is not paid by the bidder as explained in clause No 04.
 - III. If the articles are not lifted by the bidder within the period stipulated in clause No 07.
17. If any bidder is found indulged in anti-department activity or any notice of the appropriate authority of State/Center has been received showing violation by the bidder in respect of statutory obligation
