Although, the Additional Chief Secretary, H&ME has said that such conduct of Government officials in the Health Sector shall not be tolerated and strict action shall be taken against those employees who are found to be indulging in private practise during working hours illegally but the previous record in such matters speaks otherwise as people get back all their emoluments with interest once their suspension is revoked. If the dereliction of duty is proved in such cases, the government should terminate the erring officials with immediate effect as these employees don't deserve any clemency.



Our trail begins with cautionary advice: "This is a bear trail. Do not approach or run from them. Keep your food in the pack". In spite of this warning about how unpredictable and uncertain wildlife spotting is, we casually walk past the signboard, giving it only a quick glance.

After walking just a few steps in the wet, moss-covered rainforest, our passionate guide and naturalist Jim Pfister is quick to sense some sort of movement in the foliage behind us. "It's the bears," Jim announces. We walk back in silence and decide to wait, hoping bears make a grand entry on the muddy path. Voila! We see a family of three black bears plodding sluggishly, searching for salmon — their favourite delicacy. Yes, bears catch spawning salmon and pull them out on the stream banks to devour the nutrient-rich parts of the fish. While Tongass is reputed for having one of the highest density of black bears in the world, we certainly didn't expect to spot bears within a few minutes of starting the trail. "There are certain days when we don't see bears at all. I guess we just got really lucky," says Jim.

Political excursion to Jantar Mantar

A few days back PDP President and former Chief Minister of Jammu & Kashmir, posed to protest against alleged repression of people of the Union Territory and demanded that killing of innocents be stopped immediately. Former Jammu and Kashmir Chief Minister staged a Dharna at Jantar Mantar in this regard, to protest about the alleged repression of people of the union territory and demanded that killing of innocents be stopped immediately. The Jammu and Kashmir Peoples Democratic Party (PDP) president said she decided to stage a Dharna in the national capital as she was never allowed to register her protest in Kashmir. She says that she was either detained at her house or whisked away by police every time she planned a protest. She claimed that scores of PDP workers joined her in the protest at Jantar Mantar. But what was ironically witnessed that such a protest by her was looking like a dramatic joke, as hardly ten youths were with her in this protest which was observed by the people on television and everybody mocked the leader to call it a protest at the national capital. It can be called as the political excursion of this leader of PDP to Jantar Mantar, New Delhi, along with some 10 number youths as her supporters to supplement her slogans of sorts. None from her erstwhile veteran members of PDP could be spotted in this protest as most her lieutenants have already deserted her, which is on record. This political leader of PDP is trying to project herself as one of tall leaders of Kashmir, by saying that she was not allowed to register her protest in Kashmir; as she was always detained or put on house arrest on all such occasions. Does she know the genesis of a tall leader representing masses? When a mass base political leader struggling for the interests of people of a region or state or country is arrested, it is the masses or the people who come out on roads and express their protests for such arrests or detentions of such political leaders. Such protests continue unabated and continuously in the support of such popular leaders if they have any popularity or credentials among the masses. Citing examples in this regard of Kashmir itself, we have observed that when the great leaders of Kashmir like Sheikh Mohamed Abdullah, Mirza Mohamed Afzal Beg and the like, were put in long detentions during plebiscite agitation, after 1953, the agitations in Kashmir in this regard were a constant affair and a movement, when the people would come on the roads risking their lives and would hardly get

deterred by the acts of the security forces. Great political leaders have vast and mass based followings of the masses. Such agitations are not being quoted here with an intention to approve of such protests and agitations. It is to bring home to the leader of the PDP that do not remain in any false dilemma that the people of Kashmir are with this leader for such agitations or protests and do not portray as a mass leader of the people of Kashmir. Nobody from the political party of this leader, as also not a single soul even from the constituency of this leader did bother to come on the roads to protest for the detention or the house arrest of this political leader. Who does not know that most of her close stalwart confidants and colleagues of her party, who shaped this political party have since deserted her and left PDP. This political leader should introspect about the cause of such desertions of her trusted colleagues. It has become a fashion with all such dynasty based political leaders of Kashmir to project themselves on mock shows, when their real intentions behind all such dramas are now fully known to the general people of Kashmir.

Why President of PDP has no following in Kashmir has a base in the fact that she betrayed the trust of the people by aligning with BJP to form the government in Jammu and Kashmir in 2015. People in Kashmir have no short memories. They know it that it was in coalition with BJP in running the government of Jammu and Kashmir, prior to the abrogation of article 370 and 35 A. She showered enough of praises on PM Modi then in unequivocal grammar to ensure that she remains in power as the chief minister of Jammu and Kashmir. Why did this leader opt to go for alliance with BJP with divergent political manifestoes of these two political parties, can be anybody's guess? The answer is simple. This political leader wanted power, which this leader got at the cost of the political manifesto of PDP. Even this leader meant to make her brother and one other close relative of her as the minister of Jammu and Kashmir during her chief ministership. She is not a mute witness to the abrogation of Articles 370 & 35A, but a positive contributor to this process of abrogation of Articles 370 & 35A, being a part of the government with BJP, when she headed the coalition

Government between PDP and BJP. People of Kashmir have not forgotten it. That is why she has a narrowed following amongst the masses of Kashmir. This political leader obviously has no right now to speak against the abrogation of the articles 370 & 35A, by arousing the regional and the communal bias, in the minds of the people of Jammu and Kashmir. By siding with the Taliban or showing sympathy to Pakistan by asking the government of India to talk to Pakistan on issues of terrorism or unrest in Kashmir due to terrorism are hypocrisy and an absurd political ad-hoc gimmick which reflects about the political immaturity of the persons concerned. The former Chief Minister denied the charge that she raised questions on every police action. "Whenever there is an encounter and a terrorist gets killed, nobody questions but when a civilian gets killed, only then people come out and start asking questions," she said. Carrying a placard at the protest site at Jantar Mantar, it read 'Kashmir is in pain'. Can she be asked as to how many such protests and 'Dharnas', she held for pain of the Kashmiri Pandits of valley, due to their mass killings and the forced exodus of from the valley, which is still occurring with the leftover residual population of this minuscule community in the valley under the very nose of such hypocritical leaders. Has she any reply or she kept mum on such occasions being radically tilted towards a suspected radical thought, the meaning of which can be understood by any wise and a person of intelligent acumen. In an interview to a TV channel recently this political leader has empirically said that Jammu and Kashmir has acceded to the India of Gandhi, not Godse. It is not this political leader of PDP only who says so, the other tall leader of national conference is also portraying this 'Mantra' among masses for their cheaper publicity. Do these leaders want to compare the present government with that of Godse? It is an insult and assault to the honor and the dignity of crores of Indian masses who have chosen the present government twice with absolute majority. The present rulers of this country are not dynasty based rulers who bring in their brothers, sisters and maternal uncles (Mamas) as ministers. It is a clean Government with a pious slogan of 'Sab-Ka-Sath, Sab-Ka-Vikas, Sab-Ka-Vishwas' and now 'Sab-Ka-Prayas', when it is actually happening on ground. In particular they should know that Jammu and Kashmir does not mean Kashmir only. Jammu is a standing entity which constitutes Jammu and Kashmir. Jammu province has sent two MPs from BJP, so do not insult people of Jammu and call it Godse regime. Kashmiri Pandit is another important entity of Kashmir. Such a statement means an insult

to them as well, as they are true Indians believing in full accession of Jammu and Kashmir with India. Let these leaders forget at this point of time, when much water has flown down river Jhelum, Tawi and Chenab, that they are not the contractors (Thekedar) of idea of the State's accession to India. There are other cogent segments as well. Should the tall political leader of PDP be reminded of her Hurriyat like approach, as to what this leader said on the floor of the Jammu and Kashmir assembly about Kashmiri Pandits return to valley? Yes this leader should be reminded. To quote it in July 2016, this political leader said that they (Kashmiri Pandits) cannot return to their original homes in the current atmosphere. This political leader likened their home coming to 'throwing pigeons among cats'. Of course this leader drew a lot of flak from various quarters including the Kashmiri Pandits, for this murderous 'pigeon-eat' analogy. This speaks enough about the communal passion and kinetic grit of Isamic mind of such a leader about the members of other community, particularly the Kashmiri Pandits. Should theology of this leader be equated with that of Godse. She has to decide before giving sermons on her Godse comments. It deserves to be condemned by all the principles of logistic debates. The tilt in the thinking's and sympathies of all such leaders towards separatists and Pakistan can be any body's guess due to their repeated utterances in this behalf. Let people of Jammu and Kashmir decide it. Let them stop calling the present government at the centre a Godse Government. It pinches heart and soul of crores of Indians. PDP was founded in 1999 by the former Union Home Minister Mufti Mohammed Sayeed. It captured power in Jammu and Kashmir in October 2002 Assembly elections. Who does not know that its main aim was to combat the influence of national conference in Jammu and Kashmir and had suspected hidden blessings of Jamati-Islami? The PDP leader says that PDP will contest the elections as and when these are held in Jammu and Kashmir minus its leader. The leader says that she will not contest the elections as long as the Articles 370 and 35A is not resumed back in Jammu and Kashmir. What a paradox? Why should then PDP contest the elections if the abrogation of Articles 370 and 35A is the obstacle. The answer is simple. The leader of PDP knows that the possible defeat in elections of this leader can be obvious, as this leader lost the recent parliamentary elections miserably to a stalwart candidate of National Conference, Justice Masoodi.

General Rawat made China & Pakistan to tremble

The entire nation is bound to mourn the sudden death of the Chief of Defense Staff (CDS), General Bipin Rawat, in a very sorrowful helicopter accident. Apart from General Rawat, 12 others including his wife Madhulika Rawat, have lost their lives. On December 6, the day marking the 50th anniversary of our victory against Pakistan in 1971 war, the country was to celebrate and remember the martyrs. The absence of General Rawat will have a profound impact on all those programmes. General Rawat was appointed as the country's first CDS and was also the Chief of Indian Army before that. He also had a deep understanding of the workings of the Army and the Navy and managed to do a brilliant job of synergizing the three armies.

General Rawat was a keen expert on Chinese affairs and constantly advised the government on the ongoing border conflict with China and Pakistan. He believed that the country would not be suppressed under any circumstances. For their every attack, our country would have a better counterattack. On the ongoing border dispute with China, General Rawat had said, "There is also a military option to deal with the encroachment of Chinese army in Ladakh." Rawat's statement reassured the citizens that India is prepared for any situation. There was nothing wrong with what he said. It was a well-balanced true statement. General Rawat never kept the nation in the dark. He had described China as the biggest security threat to India. Some time ago, General Rawat had said, "China has become a big security threat to India and thousands of soldiers and weapons the country had sent last year to secure the Himalayan

border, will not be able to return to the base for a long time." This statement of General Rawat seemed to strike a nerve with China.

China, stunned by Rawat's statement, said, "Indian Officials not without reason speculate on the so-called 'Chinese military threat', which is a serious violation of the strategic guidance of the leaders of the two countries that China and India do not pose a threat to each other." China may keep saying anything in its favor, but it is abundantly clear that the real challenge before India is China. Ever since General Rawat took over charge of CDS, he was preparing the three wings of the Army so that even if India had to face China-Pakistan together on the battlefield, India would not lag. Due to his strategic thinking, the Indian Army was continuously preparing itself. China-Pakistan watched all these military preparations and became aware of the aggressive mindset of General Rawat. The opinion that General Rawat was expressing about China had been expressed by former Defense Minister Late George Fernandes many years ago. He described China as our biggest enemy. After the Pokhran-2 nuclear test, the then NDA Government's Defense Minister George Fernandes had claimed that India's number one enemy is China.

Political experts believed that George Fernandes must have given this statement based on information received during his tenure as the Defense Minister. Apart from George, former Defense Minister Mulayam Singh Yadav also believed that China is a bigger enemy of India than Pakistan. After the Doklam controversy in 2017, Mulayam Singh Yadav said in the Lok Sabha that the biggest issue for India is not Pakistan but

China. Cautioning the central government, he had warned that China is the biggest threat to our security and the government should take it seriously. However, some experts of Defense also believe that if India ever went to war with China, Pakistan would also openly fight alongside China. Similarly, if Pakistan ever waged a war against India, China would fight alongside Pakistan. Captain Amarinder Singh, a defense expert and the Former Chief Minister of Punjab, has publicly said that Pakistan will not sit still if an India-China war breaks out. They will fight in favor of China. Of course, given the attitude of China and Pakistan, Indian security forces have to remain vigilant throughout the year on all fronts, land and sea borders. The Indian Forces were performing this responsibility well under the patronage of General Rawat. It is safe to assume that even after the sudden demise of General Rawat, the tension on our borders with China and Pakistan will not end. China isn't going to give up on its mischievous and underhanded tricks and attacks. Meaning India will continue to face its two enemy countries together on the border every day until they are crushed once and for all. Friendly relations cannot be expected from them. So India has to remain alert always to counter the nefarious antics of these neighboring countries. It will be the responsibility of the new CDS of the country to replace General Rawat, to continue the work of strengthening the army like during the time of his predecessor, General Rawat. That will be the nation's tribute to that great warrior. He was the pride of Devbhoomi Uttarakhand and a warrior of the nation. India shall always remember him with profound gratefulness and respect.
