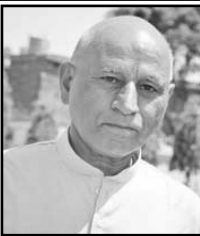

8 drug peddlers arrested across J&K

BANIHAI/JAMMU: Eight alleged drug peddlers were arrested and narcotic substances were seized from their possession during checking at different places in Ramban, Udhampur and Kathua districts on Saturday, police said.

Three residents of Doda were arrested and heroin weighing 10 gm was seized from their possession during vehicle checking at Nasheri in Ramban district, a police spokesperson said. He added that two residents of Punjab were also nabbed and 15 Kg poppy straw was seized from them, when they were on their way to Jammu from Kashmir in a private car.

Another drug peddler was arrested and heroin weighing 5 gm was seized from his possession during frisking at Omara Morh in Udhampur district.

Two men carrying 200 gm Charas were arrested from Chann Arorrian area of Hiranagar in Kathua district, the police spokesperson said. All the accused were booked under the Narcotic Drugs and Psychotropic Substances (NDPS) Act, he added.

Rs 31,600 fine recovered from COVID SoPs violators in Ramban

RAMBAN: Continuing enforcement drive to implement COVID protocol across the district Ramban, the Enforcement teams on Saturday fined scores of violators for roaming without wearing face masks and not maintaining physical distance. The enforcement teams, during the inspection in their respective jurisdictions, recovered a fine of Rs 31,600 taking total amount fined since April 1, 2021 to Rs. 71,95,100.

The Enforcement officers urged people to wear face-masks and maintain physical distance besides taking COVID vaccination doses at their nearest CVC. District Immunization Officer, Ramban, Dr Suresh informed that as many as 1,116 persons were administered first and second COVID vaccine doses across Ramban district on Saturday.

As per daily bulletin issued by the Chief Medical Officer, Ramban, Dr Mohammad Fareed Bhat, the Health Department has collected 2,460 samples including 641 RT-PCR and 1,819 RAT samples besides administering COVID vaccine to 1,116 persons at dedicated Vaccination Centres in the district.

MVD recovers Rs 1.05 lakh fine from traffic, SoP violators

REASI: Acting tough on complaints of overcharging of fare & overloading in Taxi/Maxi cabs, Assistant Regional Transport Officer Reasi, Rajesh Gupta along with his team conducted extensive checking of vehicles from Katra to Domail on Saturday.

During the inspection drive, Rajesh Gupta enquired from passengers about the fare being charged and also held a meeting with drivers, public and their elected representatives to sort out issues regarding transport facilities in their respective areas. He assured people that strict action as warranted under norms of Motor Vehicles Act will be initiated against offenders.

During the checking, the team challaned 18 vehicles for violation of MVA, 96 vehicles for other violations and recovered an amount of Rs 1,05,000. ARTO also sensitised drivers about MVA norms, COVID-19 SoPs and urged them to follow guidelines to ensure their safety against deadly virus.

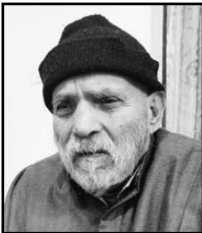
