

BJP will form next government in J&K: Rana

► 'Governance not entitlement of anyone, it's will of people'

► 'Jammu province will be equitably empowered'

JAMMU: Exuding confidence that the BJP will form the next government in Jammu and Kashmir, senior leader and former legislator Devender Singh Rana on Saturday said all regions, irrespective of religion or caste shall get a fair deal in development and jobs with no region having hegemony over the other.

"With a sense of confidence, I am telling you that the BJP will form the government in J&K on its own", Rana told reporters at the sidelines of the inaugural function of the trade fair in Gole Market Gandhi Nagar here.

When asked about the apprehensions being expressed by the Congress on fairness of elections and chances of rigging, Rana quipped, 'they are used to crying foul when any party other than the Congress wins. Such so-called apprehensions also speak about their shaking legs due to the irrelevance of the Congress'.

The BJP leader declined to react over the recent utterances of the National Conference, saying he will not comment on Dr Farooq Abdullah for the reason that he has worked with him for over two decades. However, he said that the people should not get peeved when any voice comes from Jammu. He said every segment of the society and all the regions have a right to get politically empowered. Governance in Jammu and Kashmir is not entitlement of anyone. In democracy, it is the people who exercise their right to choose those who they want to be governed by. He expressed surprise over irritation among some when Jammu raises its legitimate voice. Without naming any party, he said they keep raising the issues of their region on a daily basis as a matter of right but get perturbed when anyone speaks for Jammu. By referring to Jammu, he said, he means the entire province, the abode of Hindus, Muslims and Sikhs, who

all have equal right to govern and shape their political destination and if a voice emerges from pluralistic Jammu region for an inclusive J&K why should it rattle people.

Rana said that the Jammu region will not be discriminated against anymore. He said every region and sub-region will get equal share in development and progress. Nobody should nurture the sense of deprivation and denial, he added.

To a question about inappropriate emojis in social media over the tragic demise of CDS General Bipin Rawat, the BJP leader said that all this is unacceptable. Those living in the country cannot disgrace the national icons and anybody wishing to do so has no place in India. They should be identified and tackled sternly as per law, he added.

Describing General Rawat as an able soldier, world renowned Military strategist and India's pride, Rana said the entire nation is in pall of gloom over the martyrdom of 13 brave hearts. And, nobody has to belittle their martyrdom. He said freedom of speech does not mean indulging in anti-national activities. Nation comes first and it is supreme. Nobody should dare to disrespect the national heroes or celebrate the adversaries.

On a question about the legacy of Pandit Prem Nath Dogra, the BJP leader said the people will tread the path chartered by him. He said Jammu has great contributions in expansion of the Jammu and Kashmir state and referred to the heroic contribution of General Zorawar Singh, Brigadier Khuda Baksh and the other warriors. He said Jammu and Kashmir was, and remains a beautiful vase of different flowers. Hindu, Muslim, Sikhs and Buddhists reflect the great ethos of this part of the country, he maintained.

Earlier, while inaugurating Lifestyle Trade Fair at Gole Market Gandhi Nagar here, Devender Rana said that trade fairs open up new avenues and vistas of opportunities to entrepreneurs to show-case their produce and to build a bonding with prospective customers, BJP leader and former legislator Devender Singh Rana today observed that such a proposition attains added significance in the present era of start-ups.

"With the online business gaining momentum, the holding of trade fairs ensures better understanding and connect between the producers and the customers, which eventually helps in fine tuning the production as per market trends", he added.

Rana described the holding of such events better for business



HC sets aside order of trial court; directs framing charges of dowry death, cruelty

JAMMU: Justice Rajnesh Oswal of Jammu & Kashmir and Ladakh High Court set-aside the order of Trial Court and directed Trial Court to frame charges against Husband and Others. The present petition has been filed by petitioner, who is mother of deceased for quashing order dated 03.10.2019 passed by 2nd Additional Sessions Judge Jammu is set aside and the trial court is directed to frame charges for commission of offences under section 304-B of RPC against the respondents 2 to 4.

HC rejects bail plea in POCSO case

JAMMU: Justice Rajnesh Oswal of Jammu & Kashmir and Ladakh High Court rejected bail application of one Sandeep Singh involved in rape case of a minor.

According to police, on February 11, 2021, complainant lodged a written report at Police Post, Talab Tillo, Jammu that on February 10, 2021, her minor daughter, named with-held, a student of 11th standard at Government Higher Secondary School, Nowabad, Talab Tillo, Jammu had gone to school but did not return back. Later, it came to her knowledge that her minor daughter had been kidnapped by petitioner using his Scooty. On basis of the information, FIR bearing No. 26/2021 was registered under Section 363 IPC. The girl was recovered from possession of petitioner from Pathankot and who was also arrested. During further investigation, the medical test of victim was conducted from Government Hospital Sarwal and her statement was recorded under Section 164 of CrPC and after conclusion of the investigation, the charge-sheets for commission of offences under Sections 363, 376 of IPC, 84 of Juvenile Justice Act and 3/4 of POCSO Act was filed against petitioner.

Justice Rajnesh Oswal after hearing Adv Raghbir Singh for applicant whereas AAG Aseem Sawhney for UT and Adv Sanjeev Padha for victim observed that it is evident that there are very serious charges against petitioner regarding kidnapping/abduction of a minor girl besides raping her and the matter is pending before trial Court and the statements of the witnesses are yet to be recorded. With these observations, the Court dismissed the bail plea.

Fraudsters booked for duping complainant on pretext of arranging job in Kenya

JAMMU: Crime Branch Jammu has registered a criminal case under relevant sections of law against one Amrit Pal Singh, son of Sher Singh, resident of Nehianwala District Bathinda (Punjab) & others for hatching a criminal conspiracy and duping complainant of his hard earned money on pretext of providing him a job abroad.

Amit also mentioned that the basic premise of all Smart City projects being implemented across the length and breadth of the nation including Jammu and Srinagar Smart City Projects have inherent tools of e-Governance and even Ministry of Electronics and Information Technology has been running various courses and trainings to develop specialists in e-Governance domain through various IIMs, NISG, etc like the one which CEO JaKeGA had undergone at IIM Indore almost a decade ago.

As per an official spokesperson, the complainant namely - Darshan Kumar, son of Mool Raj resident of Tehsil Thathri, District Doda (J&K) was lured through a fake overseas job consultancy namely 'Expert World Overseas'. After realizing the reality, a written complaint was lodged by complainant with Crime Branch Jammu, alleging therein that he has been duped of his money by accused Amrit Pal Singh of Expert World Overseas, Consultancy Street No. 2, Near Katra Sweets, Shah Satnam Ji Chowk, Begu Road, Sirsa-125055 (Haryana). He further told that he came into contact with the company through mobile numbers and believed them to be genuine and trustworthy for helping youth to seek employment

abroad. The aforesaid company itself arranged air tickets and fulfilled other formalities of complainant for his job in Kenya without charging any amount initially but when they gave him employment letter, he was made to transfer money in Axis Bank account of suspects towards air tickets and other formalities required for visit. Later, the complainant was surprised to note that the aforesaid company cancelled the air tickets and duped him."

The official further said that on receipt of this complaint, a preliminary verification was conducted and it has been prima facie estab-

lished that the accused one Amrit Pal Singh, in connivance with some other persons, have hatched a criminal conspiracy by opening a fake company under name and style 'Expert World Overseas' and cheated the complainant of his hard earned money on the pretext of providing him job in Kenya. "The omissions and commissions on the part of the accused and others prima facie constitute offences punishable under sections 420, 465, 467, 468, 471, 120-B of RPC," he said, adding that a formal case has been registered for in depth investigation by Crime Branch, Jammu.

HC upholds PSA of criminal

JAMMU: Justice Tashi Rabstan of Jammu & Kashmir and Ladakh High Court upheld the Public Safety Act (PSA) imposed on Babar Khan, a criminal. While dismissing petition, Justice Tashi Rabstan after hearing Adv Jagpal Singh for the detenu whereas AAG Aseem Sawhney appearing for respondents observed that although right of personal liberty is the most precious right, guaranteed under the Constitution, yet the personal liberty may be curtailed, where a person faces a criminal charge or is convicted of an offence and sentenced to imprisonment. A person is not to be deprived of his personal liberty, except in accordance with procedures established under law and the procedure as laid down in Maneka Gandhi vs Union of India, is to be just and fair. Where a person is facing trial on a criminal charge and is temporarily deprived of his personal liberty owing to criminal charge framed against him, he has an opportunity to defend himself and acquitted of the charge in case prosecution fails to bring home his guilt. Where such person is convicted of offence, he still has

satisfaction of having been given adequate opportunity to contest the charge and also adduce evidence in his defence. However, framers of the Constitution have, by incorporating Article 22(5) in the Constitution, left room for detention of a person without a formal charge and trial and without such person held guilty of an offence and sentenced to imprisonment by a competent court. Its aim and object is to save the society from activities that are likely to deprive a large number of people of their right to life and personal liberty. In such a case it would be dangerous for the people at large, to wait and watch as by the time ordinary law is set into motion, the person having dangerous designs, would execute his plans, exposing general public to risk and causing colossal damage to life and property. It is, for that reason, necessary to take preventive measures and prevent the person bent upon to perpetrate mischief from translating his ideas into action.

The court further observed that in present case, petitioner is involved in many criminal activities and against him nine FIRs have been lodged under various sec-

tions of IPC in different police stations, including the one under sections 307/34 of IPC, 3/25 of Arms Act registered at Police Station Gandhi Nagar, Jammu regarding firing at residential premises of one Nagar Singh. Therefore, it seems the petitioner is a hardcore criminal and has become a terror figure among the people of the area and actions taken against him under the ordinary law from time to time have not been proved to be deterrent. "As per the objections, earlier also in year 2018 the petitioner-detenu was booked under the Public Safety Act. It seems the petitioner-detenu, instead of mending his ways, has continuously been indulging in criminal activities and has not shown any respect for the law of the land, as such the petitioner-detenu has created a sense of alarm, scare and a feeling of insecurity in the minds of the public of the area, has become a chronic fear amongst the people of the area. Thus, activities of the petitioner are of hardcore criminal and habitual of indulging in acts of violence," the Court observed and dismissed the petition thereby upholding detention order under PSA.

Security bunkers manned by the central armed paramilitary forces (CAPF) have been set up in many areas of Srinagar where these were removed between 2011 and 2014 following improvement in the security situation across Kashmir.

Two days prior, on December 10, two policemen were martyred when terrorists fired on a Police party in Bandipora.

To curb terrorism and ease the tensions, authorities have erected several barricades in downtown area of Srinagar city, especially in Khanya near Gousia Hospital, near
