

Army organises workshop on road safety

POONCH: In continuation of the efforts to reach out to the local population, Indian Army conducted workshop on 'Road Safety Awareness' in Kalsa and Salani village of District Poonch (J&K). Over the years on account of economic prosperity in J&K, the vehicular traffic density has increased several folds which make these roads prone to road accidents. Road and transport has become an integral part of society. Road safety education is as essential as any other basic skill of survival. Road safety knowledge and awareness is created amongst the population through education training and publicity campaigns.

The border areas of Poonch region is interspersed with number of roads. However, being a hilly terrain, the roads are narrow and winding with sharp bends, The participants were made aware on importance of wearing helmets and seat belts while driving. If correctly used, seat belts can reduce the risk of death in a road crash. The trainers stressed upon measures to be taken by the participants, to obey traffic rules, avoid drinking and not to talk on mobile phone while driving. The participants applauded the efforts of Indian Army for imparting road safety, knowledge and awareness.

Bidders may modify their bids by uploading their request for modification before the deadline for submission of bids. For this, the bidder need not make any additional payment towards the cost of tender document. For bid modification and consequential re- submission, the bidder is not required to withdraw his bid submitted earlier. The last modified bid submitted by the bidder within the bid submission time shall be considered as the bid. For this purpose, modification/withdrawal by other means will not be accepted. In online system of bid submission, the modification and consequential- submission of bids is allowed any number of times. The bidders may withdraw his bid by uploading their request before the deadline for submission of bids; however, if the bid is withdrawn, the re-submission of the bid is not allowed. No bid shall be modified or withdrawn after the deadline of submission of bids.

3. The date and time of opening of Financial-Bids shall be notified on Web Site www.jktenders.gov.in and conveyed to the bidders automatically through an e-mail message on their e-mail address.
