Pursuant to Notification No. 142-BOPEE of 2021 dated 08-12-2021, the Board conducted 3rd round of up-gradation/ allotment (Mop-up) physical counselling of eligible candidates who had applied for GNM (Lateral Entry) courses 2021 on 11-12-2021 at BOPEE Office, Srinagar/Jammu simultaneously. The candidates who participated in the said counselling and have been allotted seats as per their merit-cum preferences are hereby provisionally selected for admission to GNM (Lateral Entry) Courses-2021 in various Colleges of Union Territory of J&K as per the Annexure "A" to this notification which is available on website of the Board www.jkbopee.gov.in only. The candidates are advised to report to their respective allotted Colleges/ Institutions w.e.l. 13-12-2021 to 20-12-2021 (03:00) PM) along with following documents/ certificates:-

1. Mark cards of FMPHW/MMPHW/ANM.
2. Date of birth certificate of 10th Class.
3. Domicile Certificate
4. Category Certificate, if any
5. Medical fitness certificate.
6. Any other certificates/ document as required by the college Authorities.

The candidates are advised to report to the allotted Colleges/Institutions up to zone of December-2021 positively.

It shall be sole responsibility of the colleges / Institutions concerned to ensure proper check and verification of documents/ eligibility as per Indian Nursing Council (INC) guidelines before the candidate is allowed for admission and in case of any discrepancy in the requisite documents the same shall be reported to the Board for further course of action under rules.

In order to complete admission process within the prescribed cut-off date (20-12-2021) the Colleges/ Institutions shall keep their admission counters open even on holidays/ off days and designate Nodal Officers to facilitate the candidates to complete their admission process well in time. However, the candidates should in their own interest avoid waiting for the last day to complete admission formalities since delay has the potential of causing hardships to the candidates only.

Further, due to non-availability of eligible reserved category candidates in the Govt. Institutions against below mentioned categories, the Board, as provided under Proviso to Section 9(2) of J&K Reservation Act, 2004, converted 13 (thirteen) seats into Open Merit and filled up the same amongst the available eligible OM category candidates. The details of 13 category seats converted into OM are:- ALC:-04 seats, CDP:- 03 seats, SP:-02 seats, JKPM:- 01 seat & PSP :- 03 seats.

The Heads of the Colleges/ Institutions are advised to furnish the shortfall, if any, to the Board through e-mail at helpdeskjakbopee@gmail.com /jakbopee@gmail.com/coejakbopee@gmail.com on 21st of December-2021 (upto 4:00 PM).

Note:

1. The admission of the candidates is purely provisional and shall be cancelled in case any information furnished by any candidate proves to be false/ fabricated, and action as warranted under Law shall be initiated against such candidate(s).
2. The Concerned Colleges/Institutions shall ensure that, any person with disability, if selected in open merit or some reserved category constitute a special Medical Board to assess such candidates and make recommendations based on which colleges shall take further necessary action. In case any such candidate does not fulfill the bench marks of eligibility, he/she shall not be admitted to the course/ college and the matter shall be reported to the BOPEE.
3. For fee / documents required for admission in the College/ Institute, the provisionally selected candidates are advised to contact concerned College, Institute before the last date of admission as fixed by Board.
4. The Heads of Institutions are advised to release the documents and fee deposited by the candidates who have upgraded from one stream to other stream as per circular issued by J&K Paramedical Council or upgraded and shifted from one Institute to other, without any loss of time.
